HEADSTONE APPLICATION - GUIDELINES FOR APPLICANTS

1. Only Stonemasons / monument providers who are listed on Laois County Council's Register of Independent Cemetery Contractors are authorised to undertake work in cemeteries under the control of Laois County Council.

Contractors who are not on the register are prohibited from undertaking work in Laois County Council cemeteries.

2. The Monument Contractor shall confirm with the cemetery registrar, the correct grave space number and section of the cemetery and shall enter these details at Item 5 on page 1 of this application form.
3. The Monument Contractor shall confirm with the cemetery registrar if the grave space which is the subject of this application, is located in a cemetery (or section of a cemetery) which operates as a lawn cemetery. Kerbstones are not permitted in lawn cemeteries.

5. Monument installation may not commence without the written authorisation of Laois County Council in the form of a Certificate of Permission for a Monument.

6. Where the applicant is not the legal owner of the plot, the declaration at item 6 must be completed.
7. Following the issuing of a Certificate of Permission for a Monument, at least two weeks notice must be given to Laois County Council and the cemetery registrar prior to the erection of the monument/headstone.
8. Applicants should provide a contact telephone number in case of queries and in order to minimise delays with this application.
