On the proposition of Councillor John Joe Fennelly seconded by Councillor John King, the Members unanimously agreed the minutes of the December monthly meeting held on the 13<sup>th</sup> of December 2021 as circulated.

#### 3. MINUTES OF THE SPECIAL MEETING HELD ON THE 6<sup>TH</sup> OF JANUARY 2022

On the proposition of Councillor Ollie Clooney seconded by Councillor Paddy Bracken, the Members unanimously agreed the minutes of the special meeting held on the 6<sup>th</sup> of January 2022 as circulated.

### 4. MINUTES OF THE ADJOURNED SPECIAL MEETING HELD ON THE 25<sup>TH</sup> OF JANUARY 2022

On the proposition of Councillor James Kelly seconded by Councillor John King, the Members unanimously agreed the minutes of the adjourned special meeting held on the 25<sup>th</sup> of January 2022 as circulated.

#### 5. REPORT ON CPG MEETING HELD ON THE 6<sup>TH</sup> OF DECEMBER 2021

On the proposition of Councillor Padraig Fleming seconded by Councillor Paddy Bracken, the Members unanimously agreed the report on CPG meeting held on the 6<sup>th</sup> of December 2021 as circulated.

#### 6. REPORT ON MUNICIPAL DISTRICT MEETINGS HELD IN DECEMBER 2021

On the proposition of Councillor Catherine Fitzgerald seconded by Councillor John King, the Members unanimously agreed the report on Municipal District meetings held in December 2021 as circulated.

#### 7. REPORT ON STRATEGIC POLICY COMMITTEE MEETINGS HELD IN SEPTEMBER 2021

On the proposition of Councillor John King and seconded by Councillor Ollie Clooney, the Minutes of the Strategic Policy Committee meetings held in September were agreed.

During a discussion on the Minutes of the Transportation, Environment & Emergency Services Strategic Policy Committee, Councillor Willie Aird raised a query in relation to a prohibition on the burning of bushes. Members expressed their concern about the lack of notification and communication with the farming community in relation to this issue. Mr. Simon Walton, Director of Services, advised Members that legislation (Waste Management (Prohibition of Waste Disposal by Burning) (Amendments) Regulations 2020) provided an exemption to all farmers, as a last resort, to dispose of certain wastes, generated by agricultural practices, by burning. The Regulations provided this exemption up until 1<sup>st</sup> January, 2022. In this way he noted that, post 1<sup>st</sup> January, 2022, it is now unlawful for farmers to burn those wastes generated by agricultural practices. Councillor Noel Tuhoy proposed that the Council invite the Minister with responsibility for this matter to address a meeting of Laois County Council as a matter of urgency.

Councillor Willie Aird proposed that an amnesty be requested from the Minister on this cessation of the burning of bushes until the end of February 2022. This proposal was seconded by Councillor Ben Brennan.

A discussion ensued regarding the cost of having the bushes disposed of at Kyletelisha Landfill and the costs were outlined by Mr. Simon Walton, Director of Services. Further extensions to the end of 2022 and for the next 10 years were also proposed.

Councillor Catherine Fitzgerald proposed that a deputation be made to the three Oireacthas Members seeking their support and asking them to request a meeting with the Minister for Climate Action, Communications, Networks & Transport. It was agreed that the deputation would include the Cathaoirleach, Councillor Conor Bergin together with Councillors Padraig Fleming, Ben Brennan & Ollie Clooney. Separately it was unanimously agreed that a letter be drafted to the Minister reflecting the dissatisfaction of the Elected Members as to the lack of notification and communication in this matter and requesting an extension of the existing exemption.

8. PART VIII OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 (AS AMENDED) IN RELATION TO THE PROPOSED DEVELOPMENT OF A FIRE STATION FACILITY AND ANCILLARY WORKS AT THE JUNCTION OF CORK ROAD AND MAIN STREET, STRADBALLY, CO. LAOIS.

The Members were circulated with the Part VIII report on the above development consisting of the construction of a fire station building of 310 square meters floor area. The building incorporates a watch room, training, welfare and canteen space and internal parking for fire tenders. The building is of standard design and finish. In addition, the erection of drill tower, Crofton FT96C or equivalent drill tower combined with a pitched roof training rig at the southern corner of the site.

On the proposition of Councillor Paschal McEvoy seconded by Councillor John King, the Members unanimously agreed to the above development as presented.

#### 9. DISPSOAL OF LAND UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT, 2001

### DISPOSAL OF LEASEHOLD OF APARTMENT AT 149 CRANN NUA, EDENDERRY ROAD, PORTARLINGTON, CO. LAOIS.

On the proposition of Councillor Aidan Mullins seconded by Councillor Paschal McEvoy, the Members unanimously agreed to the disposal of leasehold of apartment at 149 Crann Nua, Edenderry Road, Portarlington, Co. Laois in the townland of Droughill for a consideration of €1.00.

### DISPOSAL OF FREEHOLD COMPRISING 0.0248 HECTARES AT 31 SLIEVE BLOOM HEIGHTS, RATHDOWNEY, CO. LAOIS.

On the proposition of Councillor John King seconded by Councillor James Kelly, the members unanimously agreed to the disposal of freehold comprising 0.0248 hectares at Slieve Bloom Heights, Rathdowney Co. Laois in the townland of Rathdowney for a consideration of €1.00.

### DISPOSAL OF FREEHOLD COMPRISING 0.0248 HECTARES AT 60 CLONROOSKE ABBEY, PORTLAOISE. CO. LAOIS.

On the proposition of Councillor Caroline Dwane Stanley seconded by Councillor Noel Tuohy, the Members unanimously agreed to the disposal of freehold comprising 0.0248 hectares at 60 Clonrooske Abbey, Portlaoise, Co. Laois in the townland of Clonroosk for a consideration of €1.00

## DISPOSAL OF HOUSE AND LANDS AT MILLBROOK HOUSE, ABBEYLEIX DEMENSE, ABBEYLEIX, CO. LAOIS.

On the proposition of Councillor John Joe Fennelly seconded by Councillor James Kelly, the Members unanimously agreed to the disposal of house and lands at Millbrook House, Abbeyleix Demense, Abbeyleix in the townland of Abbeyleix Demense comprising 1.7 hectares for a consideration of €400,000.

### 10. DELCARATION OF A PUBLIC ROAD IN ACCORDANCE WITH SECTION 11 OF THE ROADS ACT, 1993

#### ROAD ADJACENT TO THE L-6114-0 PALLAS LITTLE, PORTLAOISE

On the proposition of Councillor Willie Aird seconded by Councillor Thomasina Connell, the Members unanimously agreed that the road adjacent to the L-6114-0 Pallas Little, Portlaoise be declared as a public road in accordance with Section 11 of the Roads Act, 1993 (as amended)

#### LANEWAY ADJACENT TO R430, BALLINAKILL ROAD, ABBEYLEIX, CO. LAOIS.

On the proposition of Councillor Caroline Dwane Stanley seconded by Councillor John Joe Fennelly, the Members unanimously agreed that the laneway adjacent to the R430, Ballinakill Road, Abbeyleix, Co. Laois be declared as a public road in accordance with Section 11 of the Roads Act, 1993 (as amended)

# 11. ADOPTION OF DRAT POLICY FOR NAMING OF HOUSING DEVELOPMENTS, COMMEMORATIVE NAMING OF INFRASTRUCUTRE AND THE PROVISIN OF MONUMENTS, MEMORIALS AND PLAQUES

The Members were circulated with a copy of the policy for the naming of Housing Developments, Commemorative Naming of Infrastructure and the provision of Monuments and Plaques.

The Director of Services, Mr. Simon Walton responded to the various queries raised on the policy which included items such as the committee composition/representation of the technical group, the quorum and the twenty- year lapse in relation to the deceased person to be commemorated.

On the proposition of Councillor Paddy Bracken seconded by Councillor John Joe Fennelly, the Members agreed to the adoption of the draft policy subject to the following amendments being made:-

- The Committee to include three Elected Members (one from each Municipal District)
- The Quorum to be discussed and agreed at the first Committee meeting
- The requirement for a Five-Year Lapse (as opposed to the Twenty Year Lapse) for events and deceased persons to be commemorated.

It was agreed that the matter would be tabled for consideration on each Municipal District Agenda in February with a view to the three Elected Members being nominated to the committee following which the first meeting can be arranged.

### 12. OFFICIAL INVITATION TO THE ST. PATRICK'S DAY PARADE 2022 NEW YORK FROM THE LAOIS ASSOCIATION NEW YORK

Mr. Donal Brennan, Director of Services advised the Members that an invitation had been received from the County Laois Association in New York inviting the Cathaoirleach and other officials of Laois County Council to the St. Patrick's Day Parade in New York. On the proposition of Councillor John King seconded by Councillor John Joe Fennelly, approval was given to same. Councillor Willie Aird proposed that the previous Cathaoirlighs that were unable to travel due to the Covid-19 pandemic should also be given the opportunity to attend – this proposal was seconded by Councillor Padraig Fleming.
