Laois County Council are waiting on ESB to confirm location for ESB Supply connection which they have now provided. Remaining works which includes resurfacing of Road, installation of traffic Lights and road marking would take 10 to 12 weeks to complete.

"That this Council investigate the unstable embankment on the Cullahill mountain and do whatever work that has to be done to make it safe for all users of this road"
