1. CONFIRMATION OF MINUTES OF THE APRIL MONTHLY MEETING OF BORRIS-IN-OSSORY/MOUNTMELLICK MUNICIPAL DISTRICT HELD ON THE 19TH OF APRIL 2018

On the proposition of Councillor Brendan Phelan seconded by Councillor David Goodwin, the Minutes of the April meeting held on the 19th of April 2018 were confirmed as circulated.

2. MATTERS ARSISING

Councillor Kelly raised Notice of Motion No: 55/2018 which was discussed at the April meeting in relation to the provision of toilet facilities at the public playground in Coolrain Village. Mr. Donal Brennan, Director of Services indicated that the Town & Village Renewal Scheme has been advertised and the Community Facility Fund also is expected to be announced.

Councillor Paddy Bracken raised Notice of Motion No: 67/2018 which was discussed at the April meeting in relation to the funding for the replacement of gates and railings in the old section of St. Fintan's Cemetery, Ballyfin and the provision of plinths and footpaths in the new section of the cemetery. Mr. Donal Brennan, Director of Services confirmed that Laois County Council are undertaking a review of cemeteries at present. The replacement of railings and gates is not included in this year's programme of works.

Councillor David Goodwin raised Notice of Motion No: 63/2018 passed at the April meeting in relation to the re-erection of the fence at Meadownbrook, Rosenallis. Councillor Goodwin indicated that this is a matter of great urgency that this fence be replaced. Councillor Goodwin requested an update for the next Municipal District Meeting.

4. Notice of Motions

Notice of Motion No: 73/2018

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council address the severe flooding issues at Tom Cashins garage Ballacolla"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that Laois County Council will investigate the issue at this location and proceed as appropriate.

Notice of Motion No: 74/2018

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council provide disabled car park spaces at both St Fergals Church and ICA hall Castletown"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that Laois County Council will assess the request onsite and provide disabled car parking spaces within the public area under its control as necessary.

Notice of Motion No: 75/2018

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council which has allocated funding for works at Canon Delaney Bridge, Rushin Road, Mountrath and Trumera Cross commence the works as a matter of urgency"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that Laois County Council have commenced preparatory works on both of these schemes with a view to completing the work as part of the 2018 works programme.

Notice of Motion No: 76/2018

Councillor John King proposed the following Notice of Motion:-

"That this Council redo all road markings around Dunes Stores and Super Valu, Rathdowney and erect new stop sign as you leave car park to enter square, in the interest of public safety for all road users"

This Notice of Motion was seconded by Councillor Paddy Bracken. The Members were advised that Laois County Council will assess the road marking and signage conditions at the identified locations and renew as required within the area under its control.

Notice of Motion No: 77/2018

Councillor John King proposed the following Notice of Motion:-

"That this Council devise plans for social housing needs on their own lands to the rear of St Kieran's park Errill as their is a big demand for new houses with young family's returning to the area"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that the Housing Section has prepared a preliminary design for social housing on this land. This will be submitted to the Dept. as a Stage 1 application for their consideration.

Notice of Motion No: 78/2018

Councillor John King proposed the following Notice of Motion:-

"That this Council erect No Dumping signs and some mobile cameras at the slip road at Eglish Grogan Rathdowney where old couches and filthy bags of Rubbish are being dumped on a regular basis"

This Notice of Motion was seconded by Councillor Brendan Phelan. The Members were advised that signage will be erected within the week and the location will be included on the mobile cctv Rota.

Notice of Motion No: 79/2018

Councillor Paddy Bracken proposed the following Notice of Motion:-

"That this Council address the traffic and safety issues at Glenbarrow, Rosenallis"

This Notice of Motion was seconded by Councillor Seamus McDonald. The Members were advised that Laois County Council have carried out considerable improvement works at this location in recent years consisting of the provision of a car park, upgrade and overlay of the public road which included passing bays for vehicles. Notwithstanding these improvements the popularity of this scenic recreational facility has lead to severe congestion and difficulty for visitors and residents of the area particularly on weekends with fine weather. To this end Laois County Council have applied for and secured funding for the construction of an additional carpark to improve the visitor experience and to ease the difficulty being experienced by residents in the area. Consultation with Coillte is ongoing with a view to delivering this project in the later stages of 2018. In the interim signage will be installed requesting motorists to park in an appropriate manner and not to block the public road.

Councillor Paddy Bracken proposed the following Notice of Motion:-

"That this Council address the water issue on the footpath at Bay View, Mountmellick"

This Notice of Motion was seconded by Councillor Seamus McDonald. The Members were advised that Laois County Council will investigate the issue and seek to address the mater as appropriate within the resources available.

"That this Council provide lay bys at Rearymore, Rosenallis to facilitate traffic movement"

"That Laois County Council erect sign for County Laois at the Laois Offaly Border at Moneyquid, Killeigh"
