# "That Laois County Council make safe the junction at Lacken Lane, Clonaslee Road, Rosenallis"

### Notice of Motion No: 128/2019

Councillor John King proposed the following Notice of Motion:~

# "That this Council in its budget for cemetery works provide funding to repair and replace badly damaged foothpaths inside the local cemetery Rathdowney"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that funding for cemetery works at Rathdowney was not provided in the 2019 budget. These footpath works were identified in an extensive survey of the 27 Local Authority cemeteries. This survey was completed in 2018. These works had previously been scheduled in the Cemetery Programme of Works for 2021. A revised schedule will be prepared in early 2020 and this request will be borne in mind.

## "That Laois County Council address the road safety issues in Ballyfin at the National School, Catholic Church and GAA Club with a commitment to carry out a road safety audit as soon as possible"

This Notice of Motion was seconded by Councillor Paddy Bracken. The Members were advised that A Non Return Valve was installed on property combined sewer connection. If the sewer on the public road floods or surcharges the non-return valve will close and this will prevent flooding from the sewer back up into the house. This non-return valve is located within private property and it is the responsibility of the property owner to maintain this non-return valve and keep it free of grease and debris to ensure it functions correctly.

# "That this Council install "Warning Beware of Horses Hazard Signs" on the 2 kilometre stretch of road between Cooper's of Shanderry Coolrain to the cross at the Pike of Rushall in line with the RSA aim to improve road safety in Ireland"

# "That this Council extend the 30 minute free parking to one hour in all areas covered by the parking bye-laws in Mountmellick"
