1. CONFIRMATION OF MINUTES OF THE SEPTEMBER MONTHLY MEETING OF BORRIS-IN-OSSORY/MOUNTMELLICK MUNICIPAL DISTRICT HELD ON THE 17TH OF SEPTEMBER 2020

On the proposition of Councillor Paddy Bracken seconded by Councillor James Kelly, the Minutes of the September meeting held on the 17th of September 2020 were confirmed as circulated.

2. MATTERS ARISING

Councillor Paddy Bracken referred to Notices of Motion No: 60/2020 and 61/2020 in relation to parking issues at Glenbarrow. Mr. Edmond Kenny, A/S.E.E. confirmed that Atkins have visited the site and are currently in the process of developing a plan for the area. As soon as this is completed an update will be available for the Members.

Councillor James Kelly referred to Notice of Motion No: 70/2020 in relation to funding for Smart Cycle Sops in towns and villages in the MD. It was noted that €36,000 has been applied for in respect of signage.

3. AMENDMENT TO STANDING ORDERS

On the proposition of Councillor Paddy Bracken seconded by Councillor John King Fennelly, the Members unanimously agreed to the amendment to Standing Orders in light of the Standard Operating Guidance – Attendance at Council Meetings by Elected Members & Council Officials/Others (Media & Public) and attendance at other meetings or Council Buildings issued on the 25th of September 2020 as follows:-

The maximum duration of a meeting of Laois County Council shall be 115 minutes (as measured) from the notified start of the meeting. It shall not be in order for the Cathaoirleach to accept any motion (whether in relation to urgent business or otherwise) which seeks to extend the duration of the meeting.

4. FIX DATE FOR NEXT MEETING

It was agreed that the next meeting be scheduled for the 19th of November 2020 at 9.30 a.m. in the Council Chamber, Áras an Chontae.

5. PARKING PROPOSALS FOR MOUNTRATH

Ms. Georgina Ireland, A.O., Roads Department briefed Members on the parking proposals for Mountrath which was one of three pilot sites chosen by the Transportation, Environment & Emergency Services SPC.

Consideration was given to parking in the town centre and representations made in this regard for a more formalized arrangement to assist with regular turnover of parking and provision of a safe parking environment in the town centre. There is currently no regulated parking for the 43 spaces in the town centre including 2 disabled places except for An Garda Síochana enforcement. Between 50 and 60% of these spaces are occupied all day following a study that was carried out. There are two large car parks which are not utilized.

It is proposed to publish a notice in the coming weeks of Laois County Council's intention to erect signage for time limited parking at certain locations around the town centre, with a two week period for comments/observations.

The proposal was welcomed by all members. Cllr James Kelly stated the importance of consultation with the local and business community in terms of parking alternatives and any works that may be needed to assist with this. Cllr. Ollie Clooney asked that Durrow be considered as another site for parking measures as they are badly needed at this location also. Cllr. Conor Bergin enquired as to arrangements regarding enforcement of parking measures when they are in place and whether current traffic warden resources would be increased in this regard. Ms. Georgina Ireland, A.O., advised that there were no plans to increase Traffic Warden staff compliment, current resources would be deployed to include Mountrath and the assistance of An Garda Siochána would also be sought in terms of enforcement of parking and traffic legislation.

6. MOUNTMELLICK ROAD FEASIBILITY STUDY – PRESENTATION BY MR. ADRIAN BARRETT, SENIOR ENGINEER

Mr. Adrian Barrett, Senior Engineer delivered a presentation to the Members on the recent Mountmellick Road Feasibility Study carried out by Barry Transportation. The Members welcomed the presentation which detailed the scheme, the project brief and findings, Road Infrastructure Study & Impact Assessment, Local Area Reports & Recommendations.

Members were advised that the documentation would now be submitted to the TII for approval to progress schemes to Phase 2. The Members welcomed the presentation.
