#### 3. Correspondence

Ms. Pamela Tynan, A/Chief Officer informed members of correspondences received.

• Email Received 20<sup>th</sup> February from DRCD titled "Call for organisations and groups to be Sustainable Development Goals Champions"

Mr. Pamela Tynan, A/Chief offier advised members that as part of the 2024-2025 programme, a number of organisations and groups from across the country will be appointed 'SDG Champions' to help raise awareness of the importance of the SDGs as the cornerstone of a fair, prosperous and sustainable future for all. As Champions, they will show through their own actions that everyone in society can make a contribution to the 2030 Agenda for Sustainable Development.

Applications are sought from all organisations and groups who would like to act as an advocate for the SDGs and a good practice example of how to promote and achieve the goals. Applications will be accepted in written or video format up to 5:00pm on Monday, 1<sup>st</sup> April 2024 and information for how to apply are set out in the circular.

• Email received 22<sup>nd</sup> February from DRCD titled "Communication re Referendum"

Ms. Tynan noted that this email set out to underline the requirements that where a body or agency receiving public money is disseminaating any information about the Referendum it must ensure such information is equal, fair and impartial and neuteral.

• SICAP Annual Report 2022

Ms Tynan informed members that the 2023 SICAP Annual Report is a national report which provides and overview of the progress and achievement of the SICAP programme between 01.01.2022 and 31.12.2022

• Email received 23<sup>rd</sup> February from DRCD titled "Laois LEADER Local Development Strategy"

It was noted that this correspondance referred to the appeal submitted by Laois LCDC on the 19<sup>th</sup> January 2024 in respect of the Laois LEADER Programme 2023-2027. The appeal and supporting documentation was provided to an independent reviewer for her consideration with it being further noted that the appeal was not allowed. It is now considered that the selection process in the Laois sub-regional area is now finished.

• Letter dated 12<sup>th</sup> March 2024 from Donal Brennan, Director of Services Laois Co Co, titled "Local Economic and Community Plan Framework Document"

Mr. Tynan, A/ Chief Officer noted that the Framework document will be discussed under Agenda Item 4 – Local Economic & Community Plan 2023-2028

# 4. Local Economic & Community Plan (LECP)

Ms. Pamela Tynan, A/Chief Officer noted that the purpose of the LECP, as provided for in the Local Government Act 2001 (as amended by the Local Government Reform Act 2014), is to set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of the relevant Local Authority area.

- Laois LECP 2023-2028 contains 10 High Level Goals and 33 Sustainable Objectives
- The LECP is consistent with the objectives of local and regional policy.
- Appropriate Assessment and Strategic Environmental Assessment screening determined that full screen was not required. A screening determination has been signed in order to complete the AA & SEA process.

Ms. Suzanne O'Connor, Senior Staff Officer presented members with the framework LECP guiding them through the development of the document and information of importance contained within.

Members of the LCDC commended the LECP team on the work undertaken in developing the document and associated appendices. The framework document was welcomed by members with its adoption being proposed by **Ms. Joan Bolger** been seconded by **Ms. Caroline Lydon.** 

## 5. Social Inclusion Community Activation Programme – SICAP

#### (a) 2024 Annual Plan

Ms. Pamela Tynan, A/Chief Officer informed members that on the 5<sup>th</sup>March the Local Development Company, Laois Partnership Company confirmed that all details relating to the 2024 Annual Plan were uploaded to IRIS. An in-depth review of the 2024 Annual Plan is now being undertaken by LCDC staff, comparing information uploaded to IRIS versus that on the original tender and the best and final offer.

The SICAP subcommittee will convene in the coming days to review same in order to recommend the plans approval at the April meeting.

#### (b) Implementation Plan

Ms. Pamela Tynan, A/Chief Officer noted that as part of the 2022 SICAP Internal Audit a number of highlevel findings were identified. When awarding the SICAP 2024-2028 a clause was inserted into the letter of award stating:

"The plan will upon contract signing, form part of the tenderers' contractual obligations under the SICAP Call-Off Contract and, in line with section 2.1 of the SICAP Call-Off Contract, evidence of its implementation will be a pre-condition for continued programme funding beyond 2024.

It should be noted that failure, refusal or neglect 'to comply within a reasonable time with any recommendation or report arising from any audit' constitutes an 'event of default' under the SICAP Call-Off Contract (see clause 3.8.2.8) and, as such, grounds for contract termination, without liability for compensation or damages, and/or imposition of any sanction/ remedy by the contracting authority (see clause 3.8.1)"

With this in mind an Implementation Plan delivery timeline has been put in place where quarterly meetings will be conducted to ensure that audit findings are addressed to the satisfaction to the LCDC.

Approval is sought to pay the IP, Laois Partnership the sum of €35,780.75 representing the full Q2 2024 payment. Payment will only be processed once funds are received from the Dept.

# 6. Local Enhancement Programme

Ms. Pamela Tynan, A/Chief Officer informed the committee that Laois received an allocation of €153,591.05 under the Local Enhancement programme, which comprise of:

- Capital Allocation: €127,992.54
- Women's Allocation: €25,598.51
- Max Admin Allocation: €7,679.55 (i.e., €153,591.05 x 5%)

In addition, underspend from previous years to be allocated to LEP. An underspend of €5,000 was identified, to be used for Admin costs only as instructed by the Dept.

- Capital Allocation: €127,992.54 €2,679.55 = €125,312.99
- Women's Allocation: €25,598.51
- Admin Allocation: €7,679.55 (€5,000 from pervious fund meaning the balance of €2,679.55 is to be deducted from the capital allocation)
- Therefore, spend on projects €150,991.50.
