1. (a) CONFIRMATION OF MINUTES OF THE SPECIAL MEETING OF LAOIS COUNTY COUNCIL HELD ON THE 19th OF DECEMBER 2013

On the proposition of Councillor Rotimi Adebari seconded by Councillor Kathleen O' Brien, the Minutes of the special meeting of Laois County Council held on the 19th of December 2013 were confirmed as circulated.

1. (b) CONFIRMATION OF MINUTES OF THE BUDGET MEETING OF LAOIS COUNTY COUNCIL HELD ON THE 20TH OF DECEMBER 2013

On the proposition of Councillor Rotimi Adebari seconded by Councillor Kathleen O' Brien, the Minutes of the budget meeting of Laois County Council held on the 20th of December 2013 were confirmed as circulated.

2. REPORTS ON AREA & STRATEGIC POLICY COMMITTEE MEETINGS HELD IN DECEMBER 2013

On the proposition of Councillor John King seconded by Councillor Kathleen O' Brien, the reports on Area & Strategic Policy Committee Meetings held in December 2013 were noted.

3. DISPOSAL OF LAND UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT, 2001

(I) DISPOSAL OF PROPERTY AT 57 ST. BRIGID'S PLACE, PORTLAOISE

On the proposition of Councillor Jerry Lodge seconded by Councillor Mary Sweeney, the Members unanimously agreed to the disposal of property at 57 St. Brigid's Place, Portlaoise in the townland of Moneyballytyrell for a consideration of €40,000.00

(ii) DISPOSAL OF PROPERTY AT 57 & 59 O' MOORE PLACE, PORTLAOISE

Councillor Caroline Dwane Stanley indicated her objection to the above disposal in light of the current housing waiting list.

Mr. Gerry Murphy, Head of Finance indicated that both properties are derelict and would cost €50,000 to repair them for which there is no budget. There has been an offer of €18,000 for both properties which will deal with two derelict houses.

On the proposition of Councillor James Deegan seconded by Councillor John King, the Members agreed to the disposal of property at 57 & 59 O' Moore Place, Portlaoise in the townland of Maryborough

(iii) DISPOSAL OF PLOT OF LAND TO THE REAR OF NO. 8 ERKINA COURT RATHDOWNEY

On the proposition of Councillor John King seconded by Councillor Martin Phelan, the Members agreed to the disposal of plot of land to the rear of No. 8 Erkina Court, Rathdowney in the townland of Rathdowney for a consideration of €200.00

On the proposition of Councillor Caroline Dwane Stanley seconded by Councillor Mary Sweeney, the Members agreed to the disposal of property at 368 Market Mews, Maryborough Village, Portlaoise in the townland of Clonroosk Little for a consideration of €65,000

(vii) DISPOSAL OF PROPERTY AT 369 MARKET MEWS, MARYBOROUGH VILLAGE, PORTLAOISE

On the proposition of Councillor Jerry Lodge seconded by Councillor Kathleen O' Brien, the Members agreed to the disposal of property at 369 Market Mews, Maryborough Village, Portlaoise in the townland of Clonroosk Little for a consideration of €65,000

4. UPDATE ON THE IMPLEMENTATION OF THE CORPORATE PLAN 2009-2014

The Members were circulated with an update on the Corporate Plan 2009 – 2014 and a general discussion took place in relation to same. Ms. Anna Marie Delaney indicated that the strategies and objectives outlined in the plan will enable Laois County Council's Elected Members and Employees to continue to provide leadership in the promotion and development of the social, economic and cultural life of the County.

The County Manager, Mr. Peter Carey advised the Members that the Council can be justifiably satisfied with the progress achieved in the implementation of the Corporate Plan 2009-2014. Laois County Council is constantly striving to achieve excellence in all areas. Given the commitment and dedication of it's employees and the Elected Members and the co-operation of the Sectoral Partners, the Council will continue to be viewed as a model of excellence in Local Government, notwithstanding the difficult economic climate and the unprecedented challenges facing the Council.

Ms. Catherine Casey, Heritage Officer gave a very comprehensive presentation on the Heritage Plan 2013 – 2018. Ms. Casey outlined the preparation of the plan process, the objectives of the Heritage Plan and the various activities currently being carried out.

The County Manager also thanked the Heritage Council & the Heritage Forum for their support and also the community groups involved. It was also agreed that a visit to Donaghmore Workhouse and Museum would be arranged for the Elected Members.

6. LOCAL GOVERNMENT BILL 2013 - PRESENTATION BY MS. ANNA MARIE DELANEY, DIRECTOR OF SERVICES

Ms. Anna Marie Delaney gave a brief presentation on the Local Government Bill 2013 which included the background to the Bill, the new structures including

Municipal Districts, community development within Local Authority Areas, the governance and management and also the financial implications. Ms. Delaney responded to the Members queries.
