21. NOTICE OF MOTIONS

Notice of Motion No: 01/2020

Councillor John Kelly proposed the following Notice of Motion:-

"That Laois County Council commits to the carrying out of an audit of bus stopping points in the County with a view to securing funding to provide for bus shelters based on the need of the user"

This Notice of Motion was seconded by Councillor John King. The Members were advised that Laois County Council is the statutory body for the designation of bus stops across the public road network in County Laois.

In parallel the National Transport Authority licence bus operators to provide bus services and, in so doing, the NTA consult with individual local authorities with a view to ensuring that bus service providers utilize designated bus stopping stops only.

An audit of existing bus services throughout County Laois is underway and will be presented to the Transportation SPC. This audit will identify those bus stopping points that are used most frequently and will provide the basis for prioritizing funds to be allocated to the upgrading of individual bus stops. Once finalized at SPC the matter will be referred back to Laois County Council for approval.

On the issue of funding it is noted that, in the recently adopted Capital Budget 2020 – 2022, Elected Members approved a sum of €50,000 for Bus Shelters, to be funded by development contributions. Laois County Council will also continue to liaise with the National Transport Authority with a view to securing funding for the upgrading of public transport facilities throughout County Laois. Accessibility to public transport services will be a key priority of any programme of works.

Notice of Motion No: 02/2020

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council request the Minister for Employment Affairs and Social Protection, Ms. Regina Doherty, T.D., to re-instate the state pension to the age of 65"

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised that a letter would issue to the Minister for Employment Affairs and Social Protection in relation to this matter.

Notice of Motion No: 03/2020

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council make arrangements for extra collections at bottle banks at Christmas time"

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised that Laois County Council operates bottle banks at 43 locations around the County. The bottle bank collection service is a joint service contract operated by the four midland counties, Offaly, Longford, Westmeath & Laois. The bottle banks are monitored daily by LCC staff and some of them also have CCTV in place.

There is a rota in place for the emptying of the banks by the Contractor, Glassco. If this collection service is required sooner than the agreed rota, arrangements are made with the contractor. Following the Christmas period, Glassco were very busy trying to service all of the additional callouts in each of the four counties. Offaly County Council is the lead authority for tendering the works. The current contract expires later this year.

Laois County Council is currently in contact with Offaly County Council to include in the next tender a process whereby the contractor will prioritise the collection rota and collection schedule of the busiest and higher volume bottle banks during and after the busy holiday periods. Laois County Council is always seeking additional locations for bottle banks and relies on members of the public to respect these areas and to keep them clean and litter free. Where receptacles are full an alternative location should be sought or recyclables brought home.

Notice of Motion No: 04/2020

Councillor Catherine Fitzgerald proposed the following Notice of Motion:-

"That this Council exclude the Carers Allowance in their calculation when assessing rent"

This Notice of Motion was seconded by Councillor Paschal McEvoy. The Members were advised that Carers allowance is one of many social welfare incomes that is included for rent calculation purposes. Laois County Council has commenced a review of rents , the first since 2013. There are no plans under the current differential rent scheme to exclude Carers Allowance.

"That this Council calls on the Minister for Housing, Planning & Local Government, Mr. Eoghan Murphy, T.D. to offer a tax exemption to all landlords renting accommodation to students"

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. The Members were advised that Laois County Council are currently examining the possibility of lighting some historical /cultural buildings within the County for the St Patrick's Weekend and will pursue the matter further.

"That Laois County Council provide an update on the Age Friendly Strategy and consider co-ordinating and hosting multi agency community meetings around the County that will provide important information to people"

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. The Members were advised that The Laois Age Friendly Strategy 2016-2021 outlines 66 actions under pinned by the 8 Age Friendly Themes as identified by the World Health Organisation. The programme coordinator based in Laois County Council works closely with the Older Peoples Executive Forum. The Age Friendly Alliance is a high level cross sector multi agency group and meets on a quarterly basis to oversee the implementation of the Age Friendly Strategy. We are currently organizing the Annual General Meeting for the Older Peoples Forum in May or June. This will be the popular Tea Dance. The event will have information stands and speakers. Date, venue and speaker to be confirmed. Together with the Older Peoples Executive Forum Laois County Council intend to update the list of Older Peoples Forum members and their contact details at the Tea Dance. This wider Older Peoples Forum will provide support to the Older Peoples Executive Forum.
