The Members were advised that the budget for the construction phase of the new County Library at Portlaoise is based on an estimated construction cost of $\epsilon_{3.4}$ million exclusive of VAT. The Department of Rural and Community Affairs has committed a minimum of $\epsilon_{1.65}$ million and there is every reason to expect that further financial support will be made available in the period ahead. Notwithstanding this, the Council is satisfied that it has the capacity to proceed to tender for construction of the core building elements in the short term and that best value for money can be procured through a fixed price form of contract having concluded detailed site investigation and design risk assessments.
