125. DISPOSAL OF LAND UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT, 2001 – DISPOSAL OF 0.327 HECTARES OF LAND AT SPRINGFIELD, BALLACOLLA, CO. LAOIS

On the proposition of Councillor John King seconded by Councillor John Joe Fennelly, the Members unanimously agreed to the disposal of 0.327 hectares of land at Springfield, Ballacolla, Co. Laois in the townland of Springfield or Knockkyle, Ballacolla for a consideration of €60,000.

126. UPDATE BY MR. PAUL VEALE, MIDLANDS REGIONAL BUSINESS DEVELOPMENT MANAGER, I.D.A. IRELAND

Mr. Paul Veale, I.D.A. Ireland delivered a presentation to the Members. He briefed Members on the I.D.A. targets and performance from 2015 – 2019. He also advised the Members of what Laois has to offer and included details on the Midland Region Action Plan for Jobs 2015-2017 and also the number of visits to the other Counties in the region. He responded to the various queries raised by the Members.

A lengthy discussion ensued during which all Members expressed their concern in relation to the proposals. Councillor Jerry Lodge proposed a vote of 'No Confidence' in Dr. Susan O' Reilly's report and this was seconded by Councillor Paddy Bracken. It was noted that the 69 Doctors in the County would support Laois County Council with a request to the Minister to meet the people of Laois to discuss what has been the most important issue in the County.

On the proposition of Councillor Willie Aird seconded by Councillor John Joe Fennelly, the Members unanimously agreed that all 19 Members go to the Dáil on Wednesday, November 9th 2016. It was agreed that a letter issue to Minister Charles Flanagan also in this regard.
