## REGENERATION / VACANT HOMES

# Regeneration Team

Laois County Council has established a multi-disciplinary Regeneration Team, comprising staff from Housing, Planning and the Town Regeneration Officer, aimed at addressing vacancy and dereliction in the county.



This team aims to achieve targets set, by gathering data via:

- Geodirectory exercise (set out below)
- Continued engagement with property owners
- Engagement via derelict sites legislation where appropriate
- Action objectives of the Town Centre First Plan for Rathdowney and other town/village plans.

# Vacancy Surveys

The Vacant Homes Team is currently continuing to survey properties identified as being vacant in data supplied by GeoDirectory (via a Dept of Housing 2022 initiative).

The app has shown the following data so far - of the 698 properties surveyed to date, 400 properties were found to be vacant, with 23 of those found to be derelict.

Next step in this process will be to endeavour to contact the owners of the vacant residential properties and outline the schemes available to return these properties to use for housing. Where ownership cannot be established, local enquiries will continue in relation to ownership, vacancy history, etc. Where all other means of returning the properties to use have been exhausted, use of the CPO process to acquire properties deemed to be suitable for social housing will be considered.

# Vacancy / Regeneration Funding Schemes

• Vacant Property Refurbishment Grant - Croí Conaithe (Towns) Fund Grant available up to a maximum of €50,000, including VAT, for refurbishment of vacant properties for <u>use as a principle private residence or to be made available for rent</u>, including the conversion of a property which has not been used as residential heretofore. A top-up grant of up to €20,000 is also available for properties which are derelict.

# **CPO Activation Programme**

Circular 14/2023 provides details on the launch of the CPO Activation Programme. Laois target has been set for properties to enter the Compulsory Acquisition process, where engagement with the owner has not resulted in the vacant or derelict property being brought back into use, to be subsequently used for social housing or made available for sale on the open market.

A target of 60 vacant and derelict properties to enter the Programme and 16 CPOs / Compulsory Acquisitions to commence in 2023 has been set for Laois County Council.

# SERVICED SITES FOR SELF BUILDERS

Laois County Council is actively considering the development of serviced sites over the coming years at a number of locations in the county.

In the first instance, eligibility will be determined by criteria as set out under the Croí Conaithe (Towns) Fund – Ready to Build Scheme (Serviced Sites for New Homes) Scheme. Under the scheme, local authorities are supported to make serviced sites in towns and villages available to potential individual purchasers. These sites will be available at a discount on the market value of the site for the building of a property for occupation as the principal private residence of the purchaser. The level of discount to the individual will depend

on the level of servicing cost incurred by the local authority before the sale of the site with discounts up to a maximum of €30,000. The amount of such discount will be reflected in the sale price of the site to the purchaser. The following locations are currently under consideration for serviced sites and/or have advertised sites for sale. Sites to be a minimum of 0.25 acres in size.

#### HUMANITARIAN RESPONSE TO REFUGEES FLEEING CONFLICT

Laois County Council continues to lead and coordinate the Laois Ukrainian Community Response Forum. The Forum, consisting of 23 statutory and voluntary groups/agencies, meets regularly, with 17 meetings held to date, ensuring consistency and efficiency in service delivery and supports to new arrivals to our county from Ukraine. The most recent data indicates there are approximately 1033 displaced Ukrainian citizens in the County. Approximately 314 of these are in accommodation centres such as hotels, guesthouses, hostels, and refurbished properties, with the remainder in privately sourced or pledged accommodation.

With the pending establishment of a Laois County Council Integration Support Service, the remit of the Forum is being broadened to ensure efficient delivery of services to all refugees fleeing conflict. The Council continues to assist the International Protection Accommodation Service (IPAS - under the auspices of Department of Children, Equality, Disability, Integration and Youth, DCEDIY) with the temporary accommodation of Ukrainian arrivals to our county, as well as providing liaison locally in relation to vacant buildings and sites suitable for medium to long term accommodation solutions. The Council continues to allocate privately pledged/offered accommodation to Ukrainian families, with 48 households having been provided with accommodation through these mechanisms to date.

Site works are continuing at the 42 Modular Homes project in Rathdowney. DCEDIY have indicated a revised date of October 2023 for handover of the site to them from OPW.

# URDF Call 3 - Derelict sites

Call 3 is a key initiative in operationalising the Government's Town Centre First policy and the wider National Planning Framework (NPF) compact growth objectives to support the growth of our towns and urban areas with an increased number of new homes and to activate underutilised building stock in these areas.

This fund specifically applies to the Town of Portlaoise which has a population greater than 10,000.

It will also integrate with existing coordinated Government measures that are tackling building vacancy and dereliction including the Croi Conaithe Refurbishment Grant, the Planning Exemption for commercial to residential use and the CPO Activation Programme amongst others.

In reviewing each submission and the variety of properties submitted, it has been decided that the initial focus of the programme should be on those properties;

- (i) located within town centre areas zoned as Mixed Use or City/Town/village Centre
- (ii) that will provide, as part of their ultimate end use, some element of residential use.

Local authorities can only use the fund to target the acquisition of long term vacant (>2 years) and derelict properties which are either not on the market for sale or to which the market has not responded and which are on their approved acquisition programme. This is necessary to prevent local authorities competing with other potential buyers of vacant or derelict properties and mitigate against the risk of property price inflation arising from the programme.

Laois County Council identified 11 properties within Portlaoise Town Centre which met the criteria eligible for this scheme.

A total of €2 million has been approved to pursue the acquisition of these and /or

other properties to remedy dereliction and vacancy within Portlaoise Town Centre.

#### Restoration Improvements Works Programme

The delivery of the annual restoration improvement works programme is ongoing. The Department of Transport recently provided additional funding in the sum of €522,535 (or 8.8%), under circular RW10/2023. The additional allocation is in recognition of the increased costs being experienced in delivering the works programme for Regional & Local roads. The additional allocation will in the first instance ensure the completion of the approved programme of works with

additional roads considered should funds become available. The increase brings the total allocation to Laois County Council under the Restoration Improvement category for 2023 to €7.44m as per the table below.

5. <u>Waste Management (Storage, Presentation & Segregation of Household and Commercial Waste) Bye-Laws</u>

Since the beginning of 2023 Waste Enforcement Officers have carried out 180 household waste inspections in various housing schemes in Portlaoise, Mountrath & Portarlington.

Some of these inspections were multi agency inspections assisted by Housing, An Garda Siochana & the ISPCA/Dog Warden.

6. Anti-Dumping Initiatives:

The Free Bulky Waste Amnesty will be held on Saturday  $29^{th}$  July 2023 at Portlaoise Rugby Club from 9.30-15.30, with a maximum of 2 items per vehicle for domestic customers only. The items accepted are bed bases, mattresses, couches, chairs & tables which must be clean and dry.

Adds were placed in local papers, on social media and on local signage around the County.

#### WATER SERVICES AND RURAL WATER

#### Uisce Éireann

Members are advised that the Service Level Agreement between Laois County Council and Irish Water (now Uisce Éireann) terminates on 27th of July 2023.

In effect this means that Uisce Éireann has taken over full control and accountability for water and waste water services in Laois. While a certain number of eligible staff will fall under the direction and management of Uisce Éireann it is the case that from the effective date (27/07/2023) Laois County Council will have no statutory function or authority in water services.

## Water Services Laboratory

Laois County Council Water Laboratory is accredited to the international standard ISO 17025:2017 'Requirements for the competency of testing and calibration Laboratories' since 26th October 2016. The Laboratory is inspected at least annually by the national regulatory body INAB (Irish National Accreditation Board) to ensure all sampling and testing undertaken by the Laboratory is being conducted competently in compliance with specifications in ISO 17025:2017. The most recent INAB inspection occurred on 18th and 19th April 2023 and the Laboratory has retained its existing accreditation and also gained an additional accreditation for Enterococci, which is an important microbiological test for drinking water safety. Accreditation provides confidence to our customers that the Laboratory operates to the highest possible standard. The Laboratory is currently on target to test 4,500 samples in 2023 and as part of our strategy this will be increased to 10,000 samples within the next 3 years to cater for increased demand from neighbouring local authorities. To accommodate this increased throughput there has been substantial investment in Laboratory equipment and the provision of additional resources.

An automated run to waste system recently installed at the Knocks WTP to address periodic raw water turbidity issue.

#### Multi Annual Rural Water Programme

It is expected that the Department will issue details of the next Rural Water Programme later this year. Construction is continuing in Rosenallis on the Goodwin Estate Group Sewerage Scheme.

#### Well Grants

There has been 32 well grant applications received to date in 2023 for grant aid assistance to improve private water supplies to domestic households.

#### The Domestic Lead Remediation Grant Scheme

The grant for the Domestic Lead Remediation Grant Scheme is no longer means tested and is available for both public and private water supplies. This grant provides 100% financial assistance (max of €5,000) to eligible applicants to replace lead piping and fittings in a house, that is occupied as the applicant's normal place of residence.

# **Emergency Planning, Fire Services & Flood Relief**

Fire and Emergency Services

To date (30<sup>th</sup> June 2023), Laois County Fire & Rescue Service attended 363 emergency incidents, consisting of 137 fires, 161 special service incidents and 65 false alarms.

#### Civil Defence

#### Volunteers

Civil Defence continues to provide ongoing training and upskilling for volunteers. As of 18th July, all volunteers meet the minimum training standard requirements, as required by the Department of Defence.

Laois Civil Defence has run two intake programs in 2023 and currently has 45 Active Volunteers, plus a further 7 currently completing the induction program. This will bring the total number of active volunteers to 52 by August 2023. This is an increase of 19 active volunteers.

Facilities / Health & Safety

Minor upgrade projects continue to take place in the Stradbally unit and across the fleet to create safe systems of work and provide for safety in the unit. Additional systems such as electronic vehicle defect forms and equipment inspection forms continue to be rolled out across the unit. In July, the Road Safety Authority carried out an inspection of the unit's vehicles and fleet operations. The RSA scored the assessment at 100%, with no infringements or defects noted. This has embellished the Laois Civil Defence RSA risk rating to the 96th Percentile. There was 1 reported minor accident by a volunteer in June 2023.

**Funding** 

The annual Civil Defence grant claim has been completed for 2023 and the operational grant received for 2023 is €100,567.79 The required 70% spend for 2023 will be €115,000.

In addition, the following grant funding has been secured:

- Funding towards Personal Protective Equipment €2,900
- Funding to support the fit out of a new headquarters €150,000 (30,000 over 5 years)
- Funding towards the fit out of an operational support vehicle €20,000
- Funding toward volunteers competing in the World Rescue Competition €2,400

#### **VEMS**

Civil Defence will roll out a new Volunteer Equipment Management System in July 2023. A lot of work has been carried out locally creating equipment registers, updating volunteer details, and verifying data before the go live date.

## Walking Biodiversity Tour of Portlaoise

Laois PPN in collaboration with Portlaoise Tidy Towns held a Walking Biodiversity Tour of Portlaoise on the evening of Tuesday the 27th of June. The walk was led by Ecologist Dr. Fiona McGowan, who co-authored the recently launched new Biodiversity Action Plan 2023 - 2028. Attendees learned about the many positive steps taken to enhance biodiversity in Portlaoise including changed grass mowing regimes, natural wildflower meadows, pollinator friendly planting and thousands of native trees planted across the town. Portlaoise Tidy Towns with the support of Laois County Council have enhanced biodiversity in Portlaoise making it a great place to live work and visit. This event is part of Laois PPNs over all Climate Action Project 2023.

The Pride of Place tour continued on Thursday 20th July where they visited the "Stradbally-Vicarstown-Timahoe Activity & Wellness Hub".

The judges commenced their visit in Stradbally Library & Courthouse where the SVT Activity & Wellness Hub Committee gave a presentation charting their journey and programmes offered.

The locations visited by the judges included Stradbally Playground, the local Cricket Club, Cosby House, Carrigmeal Woodland, old schoolhouse Vicarstown and the Barrow Blueway.

#### Laois Federation of Tidy Towns Seminar in Camross

The Laois Federation of Tidy Towns held a seminar on 19th June 2023 which brought together community groups, environmental enthusiasts, and local organizations to explore opportunities for community engagement, sustainable practices, and biodiversity conservation. The seminar took place at the Camross Community Hub. The event featured distinguished speakers who provided valuable insights into various initiatives and funding opportunities available to Tidy Towns Groups including Karen Moore, Community Climate Action Officer, Regina Dunne, Tourism Development Executive with Laois Chamber Alliance and Caitriona Ryan, Manager of the Laois Volunteer Centre. The seminar's agenda included a tour of Camross led by Johanna McDonald Steenkist, offering participants an up-close look at the village's beauty and environmental projects



#### Community Climate Action Officer

The Community Climate Action Office has been actively meeting groups and conducting site visits for potential projects under the Community Climate Action Fund around County Laois. To date 13 groups have been met in person along with 25 online consultations.

#### Gum Litter Taskforce Launch

The national Gum Litter Taskforce Roadshow visited Portarlington on the 14th July and was attended by Cathaoirleach Paschal McEvoy, Portarlington Tidy Towns Committee Members and Emily Doyle, Litter Warden. Initiated in 2007, the Gum Litter Taskforce is a collaboration between Food Drink Ireland, the Department of Environment, Climate and Communications, the chewing gum industry, and local authorities to achieve a long-term sustainable solution to the irresponsible disposal of chewing gum litter, through education and awareness campaigns that encourage behavioural change. Research published recently to coincide with the National Launch of the 2023 GLT Campaign revealed that 87% of people now report proper gum disposal, versus 49% when the campaign began in 2007– an increase of 77.5%,

demonstrating the positive impact the campaign has had on attitudes towards gum litter

#### Website Update

Climate Action pages of website have been updated and now include Climate Action Video Series and information on Community Climate Action Fund and Portlaoise Low Carbon Town Project.

#### **Energy Performance**

The *Annual Report 2022 on Public Sector Energy Performance* has recently been published. The document contains reports on energy efficiency improvements across the public sector for the year 2021.

While 2021 was a Covid year where consumption was reduced especially in the Leisure Centres, the figures for Laois County Council were:

- Energy Efficiency: 59% improvement from baseline
- Greenhouse gas improvement (from non-electricity sources): 52% under baseline
- Greenhouse gas improvement overall: 40% under baseline.

These figures put Laois County Council at the top of the list for local authorities for energy efficiency in 2021. While the expected figures for 2022 will naturally show increased consumption due to increased activity, we would expect the efficiency measure for 2022 to be around 47% as against a 2030 target of 51%.

The Council has recently entered into a "Pathfinder" Memorandum of Understanding (MOU) with the SEAI for projects out to 2030. This MOU will mean that the Council will be eligible for up to 50% grant funding for certain energy projects (rather than the normal 30%) from the SEAI. The Pathfinder process will concentrate locations of high energy use within the Council's operations and buildings.

#### Town & Village Renewal Scheme (TVRS)

The Town & Village Renewal Scheme (TVRS) for 2023 has been recently announced. The scheme provides funding for projects that make our towns and villages more attractive and sustainable.

The scheme is administered through the Local Authority, who are required to work closely with local communities and local businesses to develop and implement proposals that can make a lasting impact in revitalising rural towns and villages across the country.

# **Applications**

The final closing date for the submission of applications by the Council to the Department under the TVRS this year is 10th November 2023.

The Council will in the coming weeks be issuing a "call for proposals" to Communities for this year's TVRS. These proposals will then undergo a shortlisting process and the Council will work with the selected community groups to finalise the submissions to the Department.

Each Local Authority has been invited to submit applications of varying scale under the 2023 Scheme as follows:

i. 4 applications funding €20,000 to €250,000

ii. 1 application funding €20,000 to €500,000

Types of activities that may be supported under the 2023 Town and Village Renewal Scheme include:

- Regeneration projects that assist in revitalising our rural towns and villages, in line with the Town Centre First Policy, through planned and sustainable regeneration and development projects that will drive greater economic activity and footfall, address vacancy and dereliction and ensure the re-use of heritage and other existing buildings
- There is a new option introduced under the 2023 Scheme for the acquisition of land in town centres which supports local authorities for the development of town regeneration / community focused projects
- Renovation or refurbishment to existing community centres
- Projects to support vibrant and sustainable island communities on Ireland's inhabited offshore islands.
- Projects to support the establishment of town or village centre markets
- Projects to develop town / village centre plazas, public outdoor dining spaces, parks, green spaces (including allotments and community gardens) and recreational spaces/amenities in town centres to make them vibrant hubs for community enjoyment, and to increase footfall for local businesses.
- Projects to support the upgrade and enhancement of shopfronts and street facades (including murals) in towns and villages.
- Projects that bring vacant and derelict buildings and sites back into use as multi-purpose spaces.
- Projects that bring vacant properties in town centres back into use as Remote Working Hubs, where there is a demonstrable local need.
- Enhancement of heritage assets (e.g. local museums/tourism attractions focused on historical aspects of the area, heritage sites/buildings, etc.) located in towns and villages, including energy efficiency measures.

# Playground - Borris in Ossory Playground & Doonane

Borris in Ossory Playground & MUGA was officially opened by An Cathoirleach Thomasina Connell on 19<sup>th</sup> June. The development with an estimated overall cost of €280,000 is being used extensively by locals and visitors to the area

Doonane's refurbished playground was re-opened on June  $30^{\rm th}$  , following the establishment of local playground committee. An official re-opening will take place in early September when schools return.



# **New County Library**

The new County Library was officially opened on Monday the 17th of June 2023 by Minister Heather Humphreys, Minister of Rural and Community Development.

It offers an enhanced and expanded library service for everyone in County Laois .The new library is not only a place to borrow books, study or perform a task,

Portlaoise Library will also be a place to relax and recharge in the heart of the town. It will be a welcoming free space for the community and visitors. It will facilitate the provision of educational and cultural information, provide free digital access to WIFI, PCs and a range of free events . Occupying a central location on the Main Street the library will form a significant element of The Cultural Quarter development in the historic core of Portlaoise showcasing and promoting the Fort Protector and Fitzmaurice Place.

The newly constructed building provides public space in excess of 1,600 square metres. The ground floor area has general lending services with books, media and other library stock with separately definable areas for adults, and children. The first floor provides study spaces, teen section, a dedicated local history reading room, and a community room which will cater for community events and group activities. Book storage and staff offices will be housed on the second floor.

Since opening to the public on Tuesday the 18<sup>th</sup> July the library has welcomed a large number of visitors and locals. Very high numbers of books have been issued as well as members of the public browsing and using the computers and the newly installed "magic table".

Over the first three days of public opening (18th July to 20th July) over **4,000 people** visited the library and more than **300 people** signed up as new library members.

The all in cost of the library including construction, fit out, shelving, furniture, pc's and mechanical and electrical components is €7.1m including VAT. Were the original site purchase cost to be included the figure is €7.56 million. The Council received €3.035m from the Department of Rural and Community Development for the project and €125k towards additional book stock. The Department of Housing, Local Government and Heritage has provided a funding line up to €2.7m under the Urban Regeneration and Development fund for this project. The out turn cost Laois County Council for the construction of the building stands at under €2million.

For insurance purposes the Council has been required to revalue the building at current market prices; this process has yielded a valuation of over €11m for the building – which is €4m more than was spent on its construction.







Summer Stars – our Summer Reading Programme is continuing in all of our libraries. To date we have had over 1000 children signing up to do the summer reading. All of our Libraries have organised a full range of free activities, storytimes and fun reading events to encourage children to join the library and read over the summer.
