# **PRIVACY STATEMENT**

## **for the use of Sensorpro to deliver Laois Heritage Office Communications**

### **Who we are and why do we require your information?**

Laois County Council seeks to promote the economic, social and cultural development of the Council and in doing so contribute significantly to improving the quality of life of the people of County Laois.

The delivery of high-quality services, tailored to meet the needs of all our customers, remains one of Laois County Council's core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment.

In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of the county we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being sought or provided the information sought may include 'personal data' as defined by the Data Protection Acts and by the general data protection Regulation (GDPR) and may relate to current, past and future service users; past, current and prospective employees; suppliers; and members of the public who may engage in communications with

our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

### **What is the basis for making the processing of this personal data in this activity lawful?**

(a) the data subject has given consent to the processing of his or her personal data for one or more specific purposes;

(e) processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller; it is Section 64 2 (b) Local Government Act,2001. Heritage Ireland 2030 (Ireland's Heritage Plan) highlights the importance of collaboration between government and communities, heritage organisations, individuals, and local authorities in caring and planning for our shared heritage.

You also have the right to data portability. In certain circumstances blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you.
