The Members raised the matter of the speed limit review. Mr. Paul McLoughlin, A/Director of Services advised that guidelines, advising the review, had been received. The process to review speed limits will commence as provided for in the guidelines and in parallel with all other Local Authorities.

## 81. PART VIII OF THE PLANNING & DEVELOPMENT REGULATIONS, 2001 (AS AMENDED) – PROPOSED DEVELOPMENT BY LAOIS COUNTY COUNCIL – FIRE STATION UPGRADE IN MOUNTMELLICK, CO. LAOIS.

The Members were circulated with details on the proposed development consisting of the following work:

• Provision of an 875m2 drill yard to the rear of the station

- Provision of a new fire service tower with 4 levels with access to each level on at least 2 sides with an approximate footprint of 3m x 4m with an overall height of approximately 15m
- All associated ancillary site works including drainage, rainwater harvesting tanks and water supply in relation to the construction of a new drill yard and erection of the fire tower at Portlaoise Road, Mountmellick, Co. Laois.

On the proposition of Councillor Paddy Bracken seconded by Councillor Seamus McDonald, the Members agreed to proceed with the development as outlined.

### 82. DISPOSAL OF LAND UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT, 2001 IN RESPECT OF LEASE OF 1070.4 M2 OF LAND AT THE UNDERCROFT BASEMENT CAR PARK, PORTLAOISE PLAZA

On the proposition of Councillor Padraig Fleming seconded by Councillor John Joe Fennelly, the Members unanimously agreed to the lease of 1070.4 m2 of land at the Undercroft Basement Car Park, Portlaoise Plaza (53 no. car parking spaces) in the townland of Kylekiproe for a period of three years (commencing 01/06/2024) by way of a Licence Agreement with the Office of Public Works, 100 Georges Quay, Dublin 2, DO2 Y098 for a consideration of €30,000.

The Members were advised that the question of funding for a Communications Officer will be discussed as part of the budget considerations for 2025. In addition to any budgetary approval, a separate approval would be needed from the Department of Housing, Local Government & Heritage.

### Notice of Motion No: 25/2024

Councillor Marie Tuohy proposed the following Notice of Motion:-

## "That this Council undertake a feasibility study on the availability of a suitable site for use for a sports complex in the environs of Portlaoise"

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. The Members were advised that ahead of looking for sites, it is considered that the first matter to be decided is the question of the type of facility to be provided. Given the needs of the County and of Portlaoise as the County town it is considered that initial efforts be focussed on the provision of an additional Sports Hall within Portlaoise as a community level facility.

Following a lengthy discussion on the issue Mr. Simon Walton, Deputy Chief Executive advised that the Council will require state investment in order to provide a regional Sports Centre in Portlaoise, at a likely overall cost of  $\leq 30 - \leq 35$  million. Where such state support is not available, the Council will consider available grant schemes and what is possible, in terms of funding, from the Council's resources.

#### Notice of Motion No: 26/2024

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council call on the Minister for Children, Equality, Disability and Youth, Mr. Roderic O Gorman, T.D., & the Minister for Social Protection, Ms. Heather Humphries, T.D., to put measures in place to provide a full Contributory Pension to Foster parents as they provide an invaluable place in their homes for the most vulnerable in our Society. The state should recognise their contribution"
