Mar Chathaoirleach Chomhairle Chontae Laoise, is cúis mhórtais dom baint a bheith agam le foilsiú an dara Plean Oidhreachta seo do Chontae Laoise. Cuireann ár n-oidhreacht ár muintearas in iúl dúinn agus is í eochair ár bhféiniúlachta í. Tá sé de sprioc ag Plean Oidhreachta Chontae Laoise cuidiú linn ár stair a iniúchadh, ár saol i láthair a thuiscint agus ár dtodhchaí a mhúnlú. Tá a lán foghlamtha faoi oidhreacht Chontae Laoise ó fhoilsiú ar gcéad phlean. Bailíodh eolas eolaíoch ar ábhair chomh hilghnéitheach le heascracha, fálta sceacha, canálacha agus muilte. De thoradh réimse imeachtaí a raibh freastal maith orthu agus foilseacháin d'ardchaighdeán, tá méadú tagtha ar eolas an phobail ar an oidhreacht ilghnéitheach atá ar leac an dorais againn.

I dteannta chaomhnú ár n-oidhreachta ar a son féin, ba mhaith liom aird a dhíriú ar an méid a chuireann an Plean Oidhreachta le cuid de bhunpholasaithe Chomhairle Chontae Laoise – cruthú agus cothú comhphobal inmharthana agus chuimsitheach. Ár gcomhshaol, ár bhfóntais, ar suímh oidhreachta, ár bpáirceanna agus gairdíní poiblí, ár dtírdhreacha agus ár sráid-dreacha, cuireann siad go léir go mór le forbairt agus le cothabháil ardcháilíocht bheatha dár saoránaigh go léir. Cuirim fáilte ar leith roimh an tiomantas atá déanta sa phlean seo do phrionsabail agus cleachtas an chuimsithe shóisialta, agus tá mé cinnte de go gcuirfídh cur i gcrích an phlean seo i rith na cúig bliana seo amach romhainn le forbairt mhuinín Laoise mar phobal ilghnéitheach go sóisialta agus go cultúrtha.

Is mian liom tréaslú le cách a bhí bainteach le forbairt Plean Oidhreachta Laoise, go háirithe Baill Thofa Chomhairle Chontae Laoise agus Chomhairlí Bhaile Phort Laoise agus Mhóinteach Mílic, baill Bhord Forbartha an Chontae agus Fóram Pobail an Chontae agus an iomad eagras agus duine, ar bhonn áitiúil, réigiúnach agus náisiúnta, a chuir leis an bpróiseas comhairliúcháin. Ní mór aitheantas ar leith a thabhairt do thiomantas bhalleagrais uile Fóram Oidhreachta Laoise, agus do rannpháirtíocht reatha na Comhairle Oidhreachta, as tacú agus forbairt Plean Oidhreachta Laoise. INTRODUCTION

This is the second Heritage Plan for County Laois, covering the period 2007 to 2011. It aims to identify, conserve, raise awareness and promote enjoyment of all aspects of the built, natural and cultural heritage of the county. The plan has been written by the Laois Heritage Forum (see Appendix 1), in consultation with the people of the county and local, regional and national organisations with an interest in the heritage of Laois. For the purposes of the Laois Heritage Plan, heritage is considered to include monuments, archaeology, heritage objects, architecture, flora, fauna, wildlife habitats, landscapes, seascapes, wrecks, geology, heritage gardens and parks and inland waterways.

The new Heritage Plan aims to build upon the achievements of the first plan, while taking account of changes in the national and local environment since the publication of the first plan. Two key pieces of Government policy have been published since 2002: the National Heritage Plan and the National Biodiversity Plan.

The Laois Heritage Plan reflects many of the policies and objectives of the National Heritage Plan. The major themes of the National Heritage Plan (placing heritage at the heart of public life, protecting heritage, acquiring knowledge and promoting awareness) are broadly parallel to those of the Laois Heritage Plan. The central role of the County Heritage Forum and Local Heritage Plans is acknowledged in the National Heritage Plan. The Laois Heritage Plan aims to deliver one of the key objectives of the National Biodiversity Plan, which states that it is essential that action is taken at local level for biodiversity. The Laois Heritage Plan aims to deliver this objective in several ways – through a commitment to write a Local Biodiversity Action Plan for Laois, and also by collecting data on biodiversity through research and surveys, and promoting awareness of its importance through events, seminars and training.

The Laois Heritage Plan 2002 - 2006

The first Heritage Plan for County Laois covered the period 2002 to 2006, and was among the first Heritage Plans published nationally. The key achievements of the first Laois Heritage Plan are summarised below. Detailed reports on projects delivered through the first plan, as well as an independent evaluation of the plan, are available from the Laois Heritage Office.

How this plan was written

The plan was drawn up according to methodology agreed by the Heritage Council. A discussion document was circulated to all households in the county in early 2006, inviting comment and promoting a consultation response form, which aimed to make it as easy as possible for people to submit their comments. Letters were sent to a range of public bodies and organisations with an interest in or impact on the Heritage of the county, inviting submissions. Public meetings were held in each of the five electoral areas, in association with the County Community Forum. Formal presentations were given at these meetings and notes made of all issues raised in question and answer sessions. Presentations were also given to Elected Members of Laois County Council, Mountmellick Town Council and Portlaoise Town Council, and a range of other groups. A timetable for the writing of the plan is shown in Appendix 3. Details of submissions and attendance at meetings are given in Appendix 6 and Appendix 7.

A report on all issues raised in the first phase of public consultation was prepared by the Heritage Officer and circulated to Heritage Forum Members, and to those who had sent submissions. A one-day facilitated workshop of the Laois Heritage Forum was held, objectives for the new plan agreed and preliminary actions discussed. The Heritage Forum then broke into working groups (representing built, natural and

cultural heritage) and each of the working groups worked to draft and agree actions for the draft plan. Thus the input of the member organisations of the Heritage Forum was through these working groups, rather than through formal submissions.

The draft plan was presented to the Housing, Social and Cultural Strategic Policy Committee (SPC) of Laois County Council and recommended to the full Council. Following adoption of the draft plan on 25th September, a further phase of public consultation was undertaken (to 3rd November) and the views of the public incorporated. The amended plan was again discussed at an SPC meeting and the final plan was adopted by Laois County Council on 12th December 2006.

This is a specific action plan for heritage in County Laois. It is informed by, but does not restate, relevant aspirations, policies and principles contained elsewhere (e.g. the County Development Plan, County Development Board Strategy and the National Heritage and Biodiversity Plans). Most of the actions state not a general aspiration, but how the relevant objective will be achieved. However, some flexibility remains, to allow the Heritage Forum to respond to changing priorities during the lifetime of the plan.

The inclusion of performance indicators (Appendix 2), and the setting up of systems to ensure that relevant performance data is collected from the start of

implementation, will ensure that the impacts of the Laois Heritage Plan can be measured on an ongoing basis.

This plan includes only actions which are within the direct power of the Heritage Forum to deliver. However, the Plan does not exist in a vacuum and the Heritage Forum will aim to work with and influence outside bodies in delivering policies and programmes to benefit Laois heritage throughout the Plan period. In particular, the very great contribution that local community and heritage groups around the county make to the conservation and presentation of the heritage of Laois is acknowledged. The Forum will work with these groups wherever possible and partners will be identified in annual work programmes.

Experience of the first Heritage Plan for Laois has shown that an average of about eight actions per year can be delivered by the Heritage Forum. This is a five-year plan, and it is important to be realistic about what can be achieved in this time frame. Therefore, on the recommendation of the independent evaluators of the first plan, the Heritage Forum decided to limit the number of actions included in this plan to 50. Actions included have been prioritised using the issues raised during the lifetime of the last plan, the evaluation of that plan and the public consultation process undertaken in preparation of this plan as a guide. It is therefore realistic to aim for complete delivery of this plan over its five-year time scale.



How the plan will be implemented

Implementation of the Heritage Plan will be through a detailed annual work programme, agreed with the Heritage Council, overseen by the Laois Heritage Forum and co-ordinated on a day to day basis by the Heritage Officer of Laois County Council. Opportunities to work in co-operation with partners within the county, or with neighbouring counties will be taken wherever possible. Budgets, detailed timetables and partners for individual projects will be agreed by the Laois Heritage Forum and detailed in the annual work programme, which will be made available to the public. A detailed report on progress each year will also be made available.

How progress will be measured

It is essential to the success of any plan that its impact be monitored and evaluated. Ongoing monitoring will allow changes to be made to implementation of the plan as necessary, and evaluation mid-way through and at the end of the plan delivery period will allow the results of the plan to be quantified. To this end, a set of performance indicators has been developed (Appendix 2), to measure the impacts of the plan objectives. These are quantitative indicators and will be used with qualitative results to form a detailed picture of the full impacts of the plan on the heritage and communities of the county.

Guiding principles

Certain principles underpin all the objectives of the Heritage Plan and will be borne in mind at all stages of implementation. These are summarised below:

- The principles of Sustainable Development will be applied to all actions undertaken by the Laois Heritage Forum. An accepted definition of sustainable development is "Development which meets the need of the present generation without compromising the ability of future generations to meet their needs". Comhar, the National Sustainable Development Partnership, has outlined seven themes for sustainable development in Ireland: Satisfaction of human needs by the efficient use of resources; Equity between generations; Respect for ecological integrity and biodiversity; Equity between countries and regions; Social equity; Respect for cultural heritage/diversity; Good decision-making.
- In dealing with residents, visitors and communities of Laois, the principles of *Social Inclusion* will be applied at all times. In particular, every effort will be made to ensure that all events undertaken as part of the delivery of this plan reflect the interests of the socially and culturally diverse community of the county, and are accessible to people of all abilities. In dealing with customers of Laois County Council, the commitments of the *Charter for Socially Inclusive Services* will be adhered to.

- Dissemination of Information The Laois Heritage Forum will ensure all reports of surveys and studies carried out under the Laois Heritage Plan are made as widely available as possible, including publication on the laois.ie website, and lodgement in the County Library.
- Co-operation The Laois Heritage Forum will work to identify opportunities for co-operation with organisations within Laois and in surrounding counties in relation to implementation of the Heritage Plan. This will be especially relevant in the case of projects involving shared natural features, such as the Slieve Bloom Mountains and the Rivers Barrow and Nore. Co-operation will also be important in the area of tourism and in relation to monuments in State ownership, particularly the Rock of Dunamase.
- Laois Heritage Forum believes that in order for the principles of heritage conservation to be fully integrated to the day to day operation of Laois County Council, the appointment of full-time, suitably qualified staff will be necessary in the areas of archives, conservation and biodiversity. However, the Forum recognises that the provision of such staff is an operational matter for Laois County Council, dependant on resources, and that considerable progress has been made to date.

OBJECTIVES AND ACTIONS

OBJECTIVE 1: Collect Information relating to all aspects of the heritage of County Laois

Carry out surveys of aspects of the built, natural and cultural heritage of Laois

- 1. Continue the Laois Habitats survey, on a broad level, townland by townland
- 2. Continue the Laois Habitats survey, focusing on specific habitats, including peatlands, waterways and wetlands and trees & woodlands, building on the national Native Woodland Survey
- 3. Assess the current conservation status of legally protected and endangered plant species in County Laois
- 4. Work with professional geologists and representative bodies to prioritise collection and dissemination of data on important geological sites in the county
- 5. Survey of thatched and farm buildings
- Resurvey of buildings listed as locally important in NIAH survey of Portlaoise, making recommendations for buildings to be included on the Record of Protected Structures for the town
- 7. Survey of traditional shop fronts throughout County Laois
- 8. Survey of street furniture such as iron gates, milestones, pumps, letter boxes
- 9. Carry out survey of built, natural and cultural heritage of graveyards and churches in County Laois
- 10. Carry out survey of built and natural heritage of Laois bridges
- 11. Audit and provide information on artefacts from Laois in the National Museum of Ireland
- 12. Initiate survey of local and traditional place- and fieldnames throughout the county, working with, among others, schools and the Community Forum, to inform the work of the Placenames Committee

OBJECTIVE 2: Raise awareness and promote enjoyment of the heritage of Laois

General Awareness Raising & Promotion

- 13. Promote wider awareness of all aspects of heritage in Laois through participation in national programmes and events such as Heritage Week, Water Day, Biodiversity Day and Tree Week
- 14. Promote participation in the "Heritage in Schools" programme, through active support and recruitment of Laois-based heritage experts and promotion of the programme to Laois schools
- 15. Prepare and publish regular series of heritage-related articles in local print and broadcast media
- 16. Monitor developments at Clara Bog Interpretive Centre, with a view to investigating the possibility of developing interpretive material relating to peatlands and bogs in Laois
- 17. Promote heritage awareness through regular competitions, starting with a photographic competition on the theme of vernacular architecture in Laois
- 18. Promote importance of traditional building skills and crafts through data collection, seminars and exhibitions
- 19. Promote the commemoration of important historical figures from Laois, including Helen M. Roe, first County Librarian for Laois, through naming of places, development of scholarships etc

Dissemination of Information

- 20. Disseminate key survey/research information on Laois Heritage, in an accessible format
- 21. Hold an annual seminar to report on progress in implementing the Heritage Plan, to present the upcoming work plan, and to discuss current issues in relation to heritage in the county

- 22. Work with Planning Section to ensure that copies of all Environmental Impact Assessments conducted in the county are lodged in the County Library
- 23. Raise awareness of the existence and importance of designated nature conservation sites in Laois, in association with the National Parks and Wildlife Service
- 24. Raise awareness of the particular importance of Laois for Nore Pearl Mussel, in co-operation with the National Parks and Wildlife Survey (NPWS), through production of leaflet on Nore Pearl Mussel friendly farm and forest management and a targeted information pack for schools
- 25. Raise awareness of inland waterways, water quality and aquatic heritage in association with Environment Section of Laois County Council, NPWS, Southern Regional Fisheries Board and South Eastern River Basin District
- 26. Promote awareness of the culture and heritage of the Slieve Blooms through co-operative projects
- 27. Investigate possibility of "travelling" or temporary exhibitions in co-operation with the National Museum of Ireland
- 28. Erect bilingual nameplates at a selection of townland boundaries, to raise awareness of both traditional names and the biodiversity value of townland-boundary hedgerows

Provision of Training & Education

- 29. Develop and deliver an education and training programme for Laois County Council Elected Members and staff on all aspects of built, natural and cultural heritage, to include:
 - Biodiversity, including farmland and waterways, and designated sites
 - Heritage aspects of the planning process
 - · Legislation relating to and affecting built and natural heritage
 - Management of hedgerows and other boundary types

- 30. Provide training for community groups, in particular continuing to work with Tidy Towns to ensure best practice in heritage management, through provision of targeted training
- 31. Provide practical support, information and training for owners, potential purchasers and auctioneers dealing with important built and natural heritage sites, including information on practical management and maintenance, and potential sources of funding

- 32. Initiate and publicise a process to develop and resource a Local Biodiversity Action Plan for Laois, to build on and complement the actions outlined in the County Heritage Plan. The first step in this process will be the establishment of a Laois Biodiversity Working Group, to meet the requirements of the National Biodiversity Plan
- 33. Develop and implement Hedgerow Policy for Laois County Council, in association with all sections of the organisation, based on the recommendations of the hedgerow survey carried out in 2005
- 34. Agree and implement a policy to ensure integration of heritage with all aspects of operation of Laois County Council
- 35. Publish guidance information to support the operation of the Laois Placenames Committee, which aims to ensure that names for new developments are appropriate (following on from Placenames Survey, Action 12)

36. Carry out a heritage audit of Laois County Council property and use the information collected to develop and implement a best practice guide to heritage management within Laois County Council

OBJECTIVE 4: Promote active conservation of Heritage in Laois

Undertake initiatives to protect, conserve and enhance the heritage of Laois

- 38. Work with Forward Planning Section to carry out Landscape Character Assessment for County Laois to identify sensitive areas, and ensure controls on development in these areas
- 39. Work with Forward Planning Section to enhance protection of buildings identified in built heritage surveys
- 40. Undertake initiatives to promote community involvement and best practice in maintaining and enhancing rural roadside heritage
- 41. Select one pilot site for participation in the NeighbourWood Scheme, to develop appropriate woodland amenities for public use

Enhance the role of existing initiatives (legislation, schemes, funding mechanisms) in the conservation of Laois Heritage

- Forest Service Schemes such as the Native Woodland and Neighbour Wood Schemes
- "Leave no Trace" initiative

Promote Networking and Communication between all those with an interest in conservation of heritage in Laois

- 45. Work closely with the County Development Board and County Community Forum to ensure communities throughout the County are involved in the delivery of the Heritage Plan and that the principles of social inclusion are fully integrated to all aspects of delivery of the Plan
- 46. Promote enhanced communication on heritage issues both within Laois County Council and with outside bodies
- 47. Assist establishment of local conservation groups (aimed at all aspects of natural, built and cultural heritage conservation) and provide appropriate support to such groups once established
- 48. Involve all relevant national, regional and local bodies in implementation of actions in the Heritage Plan
- 49. Develop Laois Museums Network and work to ensure support for small local museums
- 50. Work with organisations carrying out research & surveys in Laois, to ensure dissemination of information locally


