(1) Confirmation of the Minutes of the July meeting of Borris-in-Ossory/Mountmellick Municipal District held on 19th of July 2024

On the proposition of Councillor Paddy Bracken seconded by Councillor John King, the minutes of the July meeting held on the 19th of July 2024 were confirmed as circulated.

Councillor John King sought a commencement date for the repair works to Conorboro Bridge in Rathdowney (Notice of Motion No: 91/2024) – Mr. James Dowling, Senior Executive Engineer advised that the works will commence on the 23rd of September 2024.

Councillor James Kelly extended compliments on behalf of the residents for the recent works carried out at the bridge at Drim Water Treatment Plant (Notice of Motion No: 83/2024)

Councillor Paddy Bracken raised Notice of Motion No: 94/2024 in relation to the refurbishment of O' Connell Square, Mountmellick and sought an update on funding sources for the works. It was agreed to follow up on the matter.

Councillor Conor Bergin proposed the following Notice of Motion:-

"That Laois County Council address the severe road surface issues on the L-10778 at Cappagh South, Mountrath"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that Laois County Council Road Maintenance Crews will attend to the surface repairs in the coming weeks.

Councillor Conor Bergin proposed the following Notice of Motion:-

"That Laois County Council install additional signage to reduce speeding on the R-435 at Ballybrophy Railway Station"

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council give an update on the provision of the car park on their lands adjacent to Mountrath Cemetery and the Community School"

This Notice of Motion was seconded by Councillor John King. The Members were advised that funding for future development of this car park will be considered as part of the overall budgetary process - both the Revenue budget and the 3-year indicative forward capital

programme. In addition, the Council will examine potential external funding opportunities as they may arise.

"That this Council carry out safety measures at Castlefleming Bridge, Errill regarding putting up new signage and markings on road to indicate who has proper right of way in order to prevent accidents occurring at this junction"

Councillor John King proposed that a letter issue to the Department regarding additional funding being provided for the scheme. This proposal was seconded by Councillor James Kelly and supported by all the Members.
