Notice of Motion No: 91/2024

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council install road markings at the Rain Cross Roads in Ballylinan to make the junction safe and also to put a ghost island and larger barrier board there"

This Notice of Motion was seconded by Councillor Ben Brennan. The Members were advised that Laois County Council will arrange to have these roadmarkings refreshed in the coming weeks.

"That Laois County Council carry out road safety improvement works at the Rahin Road T Junction, Ballylinan on the approach road from Fallaghmore towards Killyganard as the visibility at this junction to turn right up the Rahin Road is minimal in the interest of road safety"

The Members were advised that forward visibility for turning right towards Ballylinan is restricted by the boundary hedge located around the bend at this junction. The landowner could be approached regarding the removal of this boundary hedge and replacement with a fence to improve the visibility at the junction.

Councillor Padraig Fleming proposed the following Notice of Motion:-

"That Laois County Council in consultation with T.I.I. (Transport Infrastructure Ireland) to review the current speeds and road safety measures on the N78 in Crettyard at the Filling Station and the Creamery. This location has a considerable number of vehicles entering and exiting these commercial premises within the 100 kms speed limit with a number of near misses reported in recent times"

This Notice of Motion was seconded by Councillor Aisling Moran. The Members were advised that Laois County Council's Road Design Section will conduct speed and traffic movement surveys at this location along with reviewing both the available accident data and the current measurers for road safety provision for this location. The findings from the surveys and reviews will be brought to the attention of TII as required.

"That this Council complete appropriate road safety measures at the junction of N80 and L78356 outside Stradbally"

This Notice of Motion was seconded by Councillor Paschal McEvoy. The Members were advised that A geophysical survey has been undertaken to inform the archaeological constraints at the location. A feasibility & options report is now required to be prepared for submission to TII.

"That this Council address persistent road flooding on a small section of the approach road into Vicarstown from the N7 motorway"

Tailte Eireann provide an independent valuation which is to be accepted by both parties without dispute should LCC wish to purchase the property. Once we are in receipt of same, the valuation will be considered.
