Given the frequency of requests which results from the number of mature estates in the county, provision will have to be made for an appropriate budget for such works as part of the budgetary process for 2025 and beyond. The Irish Public Bodies risk reduction programme is no longer available to Councils. An alternative funding source has been sought in the past from the Department of Transport for a restoration improvement programme for footpaths akin to that introduced for local and regional roads in circa 1997. No such specific funding for footpaths has been provided to date.

The matter was discussed, and the Members outlined the wide range of issues arising in relation to footpath repairs. It was noted that the funding which the Council currently has available is not sufficient to meet the demands. It was agreed to raise the issue with the Department of Transport again.
