REGENERATION TEAM

Laois County Council Regeneration Team, comprising of staff from Housing, Planning, Derelict Sites, and the Town Regeneration Officer are addressing vacancy and dereliction in the county, prioritizing towns in the TCF programme – Rathdowney, Mountrath and Mountmellick and under the URDF 3 programme – Portlaoise.

Vacant Homes Office Update

A Vacant Homes Team survey of properties identified as being vacant in data supplied by GeoDirectory (via a Dept of Housing 2022 initiative) has shown so far - of the 1,080 properties surveyed (residential and commercial), 695 properties were found to be vacant, with 47 of those also found to have some elements of dereliction.

The Housing Section Continues to make contact with the owners of the vacant residential properties and outline the schemes available to return these properties to use for social housing. Where ownership cannot be established, local enquiries will continue in relation to ownership, vacancy history, etc. Where all other means of returning the properties to use have been exhausted, use of the CPO process to acquire properties deemed to be suitable

for social housing may be considered. Suitability for social housing will depend on the need and housing typology of need in particular locations.

Following the vacancy survey, 30 properties in Portlaoise were identified as potentially suitable for social housing. These properties have been investigated further and correspondence was issued to the registered owners of 19 of the properties. The Vacant Homes team will endeavour to return these properties to use, as appropriate.

Vacancy/Dereliction Activation Programme

Properties are counted as entering the Vacancy/Dereliction Activation Programme where they have been identified as being vacant or derelict as part of the vacancy survey and where efforts are being made to contact property owners. Properties approved/approved in principle for a Vacant Property Refurbishment Grant are also counted as entering the Programme.

Properties are counted as exiting the Vacancy/Dereliction Activation Programme in the following circumstances:

- Sale of Property by Owner the property exits the programme once the sale is closed
- Action taken by owner bringing property back into use following engagement – the property exits the programme when the local authority is satisfied the property has been brought back into use
- Repair and Leasing Scheme the property exits the programme when the lease commences between the owner and local authority
- Vacant Property Refurbishment Grant (Grant paid) the property exits the programme when the grant is paid to the applicant
- Buy and Renew voluntary acquisition the property exits the programme once the sale is closed
- Property is acquired by the local authority by agreement or by CPO
- Ready to Build Scheme the property exits the programme once the local authority advertises the serviced site for sale

Derelict Sites

There are currently 102 derelict sites files open relating to sites across the County. To date in 2024, 11 files have been closed and removed from the Register as improvement works have been carried out.

Vesting Orders have been lodged in the Land Registry for 5 sites following completion of the CPO process:-

- 1. Bracklone Street Portarlington
- 2. 2 sites at Old Knockmay Portlaoise
- 3. Triogue Manor, Portlaoise
- 4. Main Street, Stradbally

The Derelict Sites Team also works alongside the Business Support Unit in advising in relation to the incentives available through the BSU and Local Enterprise Office in relation to the reuse of derelict and vacant commercial properties.

It should be noted that GeoDirectory's latest reports shows the county saw a reduction of 0.5% in its commercial vacancy rate. The commercial vacancy rate currently stands at 14% in Laois, which puts the county just below the national average of 14.4%. Laois has seen the largest drop in the number of empty shops in the country.

Vacant Sites

In August the Planning Authority received payment of a vacant site levy, for the years 2020 – 2022, of €33,500 in relation to a vacant site at Crossneen, Graiguecullen.

Vacancy / Regeneration Funding Schemes

A Vacant Property Refurbishment Grant is available for up to a maximum of €50,000, including VAT, for refurbishment of vacant properties for <u>use as a principle private residence or to be made available for rent</u>, including the conversion of a property which has not been used as residential heretofore. A top-up grant of up to €20,000 is also available for properties which are derelict. To qualify for the Vacant Property Refurbishment Grant, properties must be:

- Vacant for over 2 years
- Built before 2008

Amendment to Vacant Property Refurbishment Grant from 1st December 2024

Circular 34/2024 issued by the Department of Housing 11th November 2024 advises as follows:

The Vacant Property Refurbishment Grant currently provides funding for works under a number of different categories, as outlined in the application form and scheme outline. The work category 'Services' includes plumbing; heating; ventilation; power; lighting; telecommunications; and smoke/CO2 detection.

While no specific reference is made to fossil fuel boilers, grant funding for such boilers could currently be provided under the 'Services' category of works.

From 1st January, 2025, EU Member States shall not provide any financial incentives for the installation of stand-alone boilers powered by fossil fuels. Accordingly, (per EU/2024/1275), the Vacant Property Refurbishment Grant will no longer provide funding for the installation of a standalone fossil fuel boiler for new applications from 1st December, 2024.

Local Authority Purchase and Renovation Loan

People who wish to purchase and/or renovate a Vacant Property Refurbishment Grant eligible home, but cannot get sufficient funding from commercial lenders, will now be able to apply to their local authority for a LAPR.

INTEGRATION SUPPORTS AND SERVICES

Laois County Council leads and coordinates the Laois Community Integration Forum (CIF). The Forum, consisting of 23 statutory and voluntary groups/agencies, meets regularly, with 28 meetings held to date, ensuring consistency and efficiency in service delivery and integration supports to new arrivals to our county.

The Council hosted, on behalf of the Laois Community Integration Forum, a successful and well attended information event for employers on 24^{th} October 2024, at Aras an Chontae. This event informed employers and potential employers on the full suite of support services available when employing new arrivals to our county, and provided a valuable networking opportunity.

The Department of Children, Equality, Disability, Integration and Youth (DCEDIY) continues with the national consolidation of its Ukrainian Accommodation portfolio. As a result a small number of Ukrainian citizens were relocated in October from emergency accommodation arrangements at Portlaoise and Abbeyleix to other centres, including centres outside of Laois. This consolidation during 2024 has led to a reduction in the number of Ukrainian accommodation Centres around Laois, which now stands at 5. DCEDIY also confirmed in recent weeks that an IPAS centre in Portarlington, is now no longer under contract.

With the cessation of the refurbishment programme for vacant buildings, effective from 31st October 2024, DCEDIY no longer require Council support in the sourcing of such temporary accommodation for Ukrainian displaced persons.

The Council continues however, to allocate privately offered accommodation under the Offer A Home Scheme to Ukrainian families, with 75 Ukrainian households having been supported by Council in securing privately arranged accommodation to date.

The Council's Integration Support Office continues to coordinate service delivery and integration supports to all those in need of such services. This includes for onsite one to one clinics, engagement with CIF members, local agencies and service providers to deliver supports such as English classes, Safe Pass and Manual Handling training and information sessions.

Weekly clinics take place in Áras an Chontae for international protection applicants and programme refugees from Syria, who arrived to Laois under the 2015 and 2019 resettlement programmes.

Accommodation Centre residents are encouraged and supported to participate in and volunteer at local events, including Culture Night activities in Rathdowney and Portarlington and the Global Solidarity Run on 19th October last, in conjunction with Vicarstown Parkrun.

PLANNING

Local Area Plans

Graiguecullen/Carlow

- The Graiguecullen/Carlow Joint Urban Area Plan (JULAP) 2024 2030 has been completed and was adopted by Laois County Council on the 29th July 2024 and by Carlow County Council on the 30th July 2024 respectively.
- It came into effect on 9th and 10th September 2024 respectively.

<u>Portlaoise</u>

- The Draft Portlaoise Local Area Plan 2024 2030 has been prepared. The Chief Executives Report, on the submissions received following public consultation, was considered at a Special Meeting on the 10th September 2024.
- Preparation of the Chief Executives report on the submissions received [9 no.] at Material Alterations of the draft LAP is underway. This will be issued to the Members for their considerations and for statutory decision at the December 2024 Monthly Meeting.

MIDLAND ICT CLUSTER AND STEM OFFICER

The Launch of the Just Transition Fund was held at The Cube on Friday 4th October. The Fund was launched by Minister Eamonn Ryan – Transport, Environment, Climate and Communications and Minister Peter Burke – Enterprise, Trade and Employment.

Funded by the Just Transition Fund, Midlands Local Authorities (Laois, Longford, Offaly and Westmeath) are allocating dedicated resources, for 18 months, to realise sectoral ambitions, in line with the objectives for the Regional Enterprise Plan, including the Midland Pathway to a Net-Zero Economy, Midlands Ireland Placemaking Programme and the Midlands Ireland Regional Food and Drink Strategy.

In parallel, in addition to supporting economic development and having regard to the Just Transition Fund's heavy emphasis towards education and future skills, a Science Technology Engineering and Maths (STEM) Officer position has also been filled in each of the Midlands Local Authorities. This will enable expansion of award-winning regional STEM education programmes, such as Dream Space and VEX Robotics, to over 280 Primary and Secondary Schools across the region. The programme will also support investment in digitalisation and equipment for schools.







LOCAL ENTERPRISE OFFICE

Local Enterprise Office Update - November 2024

Demand continues to be high for LEO supports across all areas. We are currently on target to meet key metrics set by Enterprise Ireland at the start of the year. Since our last update the following supports have been delivered to new and existing entrepreneurs:

- €60,000 was approved in grant aid to 4 businesses with potential to create 5 new jobs. Financial
 grant support is available for clients in the manufacturing or internationally traded services
 sector through the Feasibility, Priming and Business Expansion Funds.
- Businesswomen from across Laois, Longford, Offaly, and Westmeath recently came together at the Crypt in St Mel's Cathedral, Longford to celebrate National Women's Enterprise Day (NWED). Organised by the Local Enterprise Offices in Laois, Longford, Westmeath and Offaly, over 150 Midlands-based businesswomen attended the midlands event held on Thursday, 17th October.
- 26 businesses were set up to avail of 1-1 mentoring. The LEO Mentor programme has been designed to give clients the benefit of an expert business practitioner's experience. Under this programme, clients are matched with a mentor who can provide both practical and strategic advice to help with decision making.
- 9 training courses were delivered to 127 participants. To assist the small business community
 in meeting the challenges of the business world, LEOs provide a wide range of high-quality
 training supports which are tailored to meet specific business requirements. These include start
 your own business programmes, marketing focused programmes, HR and financial management
 programmes etc.
- 7 Trading Online Vouchers (TOV's) were approved to bring a total of 26 to date this year. The Trading Online Voucher is a financial incentive to small businesses to develop or enhance their ability to trade online.
- 1 business was approved for Technical Assistance for Micro Exporters (TAME) Export Grants.
 The 'Technical Assistance for Micro Exporters' grant is available through Local Enterprise Office
 Laois to help more small businesses develop products and services that will unlock export
 markets.
- 1 business was approved for the Green for Business programme. Green for Business is a fully funded programme that helps small businesses take the first step towards becoming more sustainable. It provides access to a green consultant who develops a tailored sustainability roadmap for each participating business.
- 1 business received approval for an Energy Efficiency grant. The Energy Efficiency Grant helps small businesses to invest in technologies and equipment with 75% of eligible costs from a minimum grant of €750 to a maximum of €10,000.

STRADBALLY FAÇADE ENHANCHMENT SCHEME

In 2024, the Business Support Unit launched a new initiative in Stradbally, a façade enhancement painting scheme, open to occupiers of commercial and residential properties. This scheme has been very successful with 25 applications approved including 4 local authority houses. Grant payments are being progressed and the project is now complete.

GRANTS AND SUPPORTS

The BSU continue to process Grant Schemes such as the Shop Front, Façade Enhancement, Shop Fit-out and Business Incentive Schemes. We have received 28 shop front grant applications so far this year - 24 approved, 3 refused and 1 in progress. We have received 5 applications under the Façade Enhancement Scheme – 4 approved and 1 not proceeding. We have received and approved 3 shop fit out grant applications. We have received 7 applications under the Business Incentive Scheme – 4 approved, 2 in progress and 1 not proceeding. This Scheme gives businesses a 3-year reduction on their rates if they open up in a premises that has been vacant for 6 months or more.

1. Kyletalesha Landfill, Transfer Station & Civic Amenity Sites:

The facility is being operated in compliance with the facility's EPA waste license. The Portarlington Civic Amenity Site continues to be managed and operated by Bord na Mona. Laois County Council carries out regular inspections of the facility.

7. Rural Water - Multi Annual Programme 2024 to 2026

Approval for a number of projects under the MARWP 2024-26 has been received from the Department of Housing, Local Government & Heritage. These projects were approved under the following funding measures;

- Measure A1: Source Protection for Existing Private Group Water Schemes;
- Measure A2: Water Treatment Provision, Improvements and Capital Replacement (existing private group water schemes);
- Measure A3: Amalgamation and/or Rationalisation (existing private group water schemes);
- Measure A6: Taking-in-charge of Group Water Schemes and Group Sewerage Schemes; and
- Measure A7: Community Water Connections and Community Wastewater Connections.

Funding was announced for projects proposed by Errill GWS, The Heath GWS and Cullohill GWS under Measures A1, A2, A3, A6 and A7 of the Rural Water Programme 2024-2026. Correspondence has issued to the Group Schemes informing them of the announcement and €271,296.00 is the total value of the current funding announcement.

A further funding announcement in relation to remaining Measures is awaited.

8. Department of Rural and Community Development funding for the Dog Control Support Initiative 2024

Laois County Council were allocated €58,692 by the Department of Rural and Community Development in November 2024, under the **Dog Control Support Initiative 2024**.

The Council will work with the ISPCA who provide the Dog Warden Service and Dog Pound Services to consider eligible expenditure.

9. Laois County Council Laboratory

Laois Co Co Laboratory is an internationally accredited facility under ISO 17025:2017 'General requirements for the competency of testing and calibration laboratories'. There is a statutory inspection of the Laboratory annually by our regulator the Irish National Accreditation Board

(INAB) comprising technical experts from the disciplines of both analytical chemistry and microbiology, to ensure our testing activities continually satisfy the requirements of ISO 17025:2017 and that we are producing test results that are both credible and legally defendable.

Following our recent inspection INAB informed us on 25th October we continue to retain our accreditation and thus are operating to the highest standards. Since becoming accredited on 25th October 2016 the Laboratory has performed satisfactorily in all its annual statutory inspections which is testament to the skills, commitment, professionalism of Laboratory staff and the unrelenting support provided to the Laboratory by Senior Management.







Fire Service Operations

In 2024, to date, (8th Nov) Laois County Fire & Rescue Service attended 655 emergency incidents, consisting of 171 fires, 354 special service incidents and 130 false alarms.

Retained Fire Services in Ireland - Recruitment and Rostering

For information, as of 8th November 2024, there are 13 permanent vacancies in the Laois retained fire service. This is based on the new compliment of 100 retained firefighters (up from 75) in the 8 fire stations, following the WRC Agreement. Open recruitment is ongoing to recruit more fire-fighters, with 8 applications currently on file.

The WRC Agreement, signed in September 2023, provides for 100 retained Fire Fighters in County Laois. Since the WRC Agreement came into being, 22 retained fire fighters have been recruited, increasing the compliment of retained fire fighters to 87. Rostered operations are now in place in all 8 Fire Stations. There are 13 vacancies still to be filled with 4 applicants in the final stages of recruitment (Garda Vetting, Medical etc.) and a further 8 applicants awaiting interview.

Approximately 12,000 hours of training has been carried out in 2024.

Fire Prevention & Community Fire Safety

- 110 Fire Safety Certificate applications received to date.
- 474 Fire safety consultations with consultants and member of the public.
- 35 "During Performance Inspections" carried out.
- 21 Fire inspections carried out under the Fire Services Acts 1981 & 2003
- 48 Intoxicating Liquor licences applications processed.
- 82 Fire Safety Certificate search requests processed.

Civil Defence

Volunteers

Civil Defence continues to provide ongoing training and upskilling for volunteers. As of 5th November 2024, the unit has 52 active volunteers who all meet the Minium Training Standards of the Department of Defence.

- 123 Deployments & Events
- 101 Training Events

These included 18 missing person operations, 4 supports to the Ukrainian response, 101 community events.

Winter Training Programme

The units' winter weekly training programme has started with several courses ongoing at present such as First Aid Response, People Handling, Lifejacket Competence and training of additional instructors in Search Management and Missing Person Search Response. The unit's new headquarters has allowed for the expansion of weekly training sessions with a number of different disciplines running back-to-back each week.

Volunteers

Recruitment of new volunteers is underway with an induction course planned for November. This recruitment process will aim to increase volunteer numbers to 60 by the end of $Q4\ 2024$.

Grant aid has been secured from the Department of Defence for the purchase of new water rescue PPE for several volunteers. This grant has upgraded PPE which has reached End of Life.

Fleet

The trail use of Hydrotreated Vegetable Oil as a fuel source for our vehicles has been going well. Currently there are 4 Civil Defence vehicles using this fuel with no performance issues to date.

Finance

The 2024 grant payment has been received from the Department of Defence. The grant allocation for 2024 is €115,000 less deductions of €3,547.24 for Insurance. The total payment received was €111,452.76

The unit is currently receiving an accommodation grant towards the fit out of the new Headquarters building in Portlaoise from the Department of defence which was $\le 30,000$ per year over 5 years. The first two years payments have been already drawn down and the Department have now confirmed that the remaining 3 years payments will be paid in 2024 allowing the works to progress sooner. The remaining balance due in 2024 is $\le 90,000$.

Laois Comhairle na nÓg

Laois Comhairle na nÓg annual youth conference took place on 21 October 2024 in the Midlands Park Hotel. Students from all Secondary Schools in Laois were represented including students from National Learning Network. 119 young people were in attendance. Comhairle members presented work that they have done throughout the year and their experience at the Dail na nÓg. The topics discussed were Mental health, Physical health and Bullying.

Local Enhancement Programme 2024

The Department of Rural and Community Development Local Enhancement Programme (LEP) 2025 was announced with Laois set to receive an allocation of €173,943. The capital funding element of the LEP will support groups, particularly in disadvantaged areas to carry out necessary repairs and improvements to their facilities, purchase equipment such as tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies and training equipment etc. The current funding will support groups/organisations with running costs associated with their facilities and groups — such as electricity bills, insurance, refuse costs, rental costs, etc. Applications are expected to open in early December.

National Age Friendly Awards

On the 7th of November, members of the Executive of the Older Peoples Council along with Cathaoirleach Cllr Padraig Fleming and organisers of the event attended the National Age Friendly awards at a ceremony in Dublin. The Live Well Expo, which was shortlisted for an award in the communications category of the National Age friendly Awards. While not a winner on this occasion, the shortlisting of the event, in only its 2nd year in existence, shows its value as a means to create awareness of a wide range of supports across County Laois.

Laois Connects 2024

This annual health and wellbeing initiative took place from the 7th to 13th October. This year saw events take place throughout the county, run out by our various partners. Laois Sports Partnership delivered a wide range of events including sequence Dance, Chair Pilates/yoga, Jiving, Wheelchair rugby, All-inclusive fun days, Aqua Aerobics, Boccia/Target games and Vicarstown Parkrun

<u>Laois Volunteer Centre</u> in collaboration with <u>Mountmellick Community School</u> joined forces and plan to hold a community and voluntary Expo for young people from 11am - 2.30pm, on Wednesday, November 20th in Mountmellick Community School.

The Dunamaise Arts Centre held a number of events including a live podcast of Bressie's "Where is my mind " which featured Dr Eddie Murphy. They also provided a schools movie screening of " The Sparrow " for Transition year students. Director of the movie Michael Kinirons joined the students after the movie for what was a great Q and A session.

The Sport & Leisure team provided Willow weaving and ceramic workshops in a number of libraries along with a leisure cycle and Tai Chi while Laois Libraries provided sound meditation in Portlaoise Library.

The Climate Action team and Age Friendly Laois collaborated to provide a Wellness walk in Emo Court and the HSE worked with GROW and Laois Partnership to provide a three week community education programme around mental health.

The Sing for Joy choir held an event in Portlaoise also and Portlaoise family Resource Centre hosted a mindfulness workshop.

Town Centre First & Rural Regeneration

Rathdowney

The Rathdowney Town Team went on a site visit to view projects in Kildare Town and Naas on 15th October 2024. The Town Team were accompanied by the Denise Rainey, TRO and Ken Morley, S.E.E. They met with representatives from Kildare County Council and Town Team members in both Naas and Kildare to view town centre projects – Market Square Kildare Town and Poplar Square Naas- to acquire learnings with advancing similar projects in their own town.

The trip was hugely beneficial for Town Team members and Council officials alike.

Mountrath

The Mountrath Town Team accompanied the Rathdowney Town Team on the site visit mentioned above on 15th October 2024. Again, they found the site visit very informative. The Mountrath Town Team have also commenced a programme of capacity building with an experienced trainer to increase their effectiveness as a town team.

Mountmellick

The consultants SLR Consulting Ltd have been appointed to prepare the Town Centre First Plan for Mountmellick. The Consultants had their initial meeting with the Mountmellick Town Team on Tuesday 12th November.

Ballylinan

A new Town Team has been set up in Ballylinan village. 3 meetings have been held to date. The South Eastern Technological University has been appointed to conduct a health check for the Town and work has commenced on same.

CLIMATE ACTION AND ENVIRONMENT AWARENESS

Laois Climate Action Festival 2024

The Laois Climate Action Festival 2024 ran from 6th to 23rd October, featuring 50 free events and effectively showcasing climate action initiatives by Laois County Council alongside contributions from partner organisations, including The Cube, Laois Libraries, PPN, Laois Connects, Laois Chamber Alliance, and Dunamaise Theatre. Themes across the festival ranged from food waste reduction and upcycling to the circular economy, biodiversity, sustainable gardening, and climate awareness, engaging the public through hands-on workshops, interactive sessions, and community events.

Key highlights included Applefest Abbeyleix, praised for its family-focused atmosphere and promotion of local produce, and the Farm Hazardous Waste Collection, which drew

significant engagement with 170 farmers participating. Upcycling workshops such as Brat Bhríde Scarf Upcycling and Denim Upcycling emphasized circular economy principles, with attendees appreciating the practical focus and requesting future seasonal themes. Biodiversity and gardening events offered participants valuable skills to apply at home, with positive feedback on their practical, educational content. One of the highlights of the festival was Colm O'Regan's comedy show Climate Worrier at the Comedy Club at PJ Kavanagh's Pub. A published author of a book of the same



name Colm brought humour to the anxieties surrounding climate change, offering audiences an entertaining yet thoughtful perspective on sustainable living. The festival closed with the Laois premiere of the documentary Mrs Robinson at Dunamaise Theatre. Mary Robinson is one of the foremost advocates internationally for climate justice. This screening was followed by a "Climate Inspirations" panel, featuring Laois climate advocates, including Tom Popple (CEO of BE IMPACTFUL and Climate Cocktail Club founder), Stephen McEvoy, Sarah Bennett (An Taisce Climate Ambassador), and Laura Kirwan (a nutritionist with a PhD in Sustainable Diets who is speaking on this topic at COP29).

Each panellist shared personal motivations for climate action, inspiring attendees to engage more deeply with sustainability.

Feedback from festival participants highlighted the engaging formats, practical learning, and strong sense of community throughout. The festival demonstrated Laois County Council's commitment to climate action through collaboration and education, positioning Laois as a proactive leader in sustainable community engagement.

Over 60s Climate Course



Jacinta Barrins a former UN diplomat is hosting a 6-week climate course starting in November for the Over 60s in Portlaoise. Jacinta created the course with her age group in mind. Jacinta is a passionate advocate for climate conservation. She believes in the urgent need to protect our planet and address the pressing issues of climate change. Her dedication to raising awareness and promoting sustainable practices serves as an inspiration to many. Jacinta's work highlights the importance of taking action now; regardless of age, to preserve our environment for future generations.

National Tidy Towns Awards

The SuperValu Tidy Towns Awards ceremony, held on 1st November 2024 at Croke Park, celebrated the outstanding achievements of Laois Tidy Towns groups, with 24 communities participating and each group either maintaining or improving their previous results.

Abbeyleix Tidy Towns, last year's national winner, was awarded County First Place and a Gold Medal, underscoring their continued commitment to environmental enhancement and community pride. Durrow Tidy Towns achieved County Second Place with a Silver Medal and the Waters and Communities Special Award for their work preserving local waterways. Portlaoise Tidy Towns took County Third Place and a Gold Medal in their population category, also winning the National Tree Project Award for their greening efforts. Killeshin Tidy Towns received the Endeavour Award for the most significant improvement from the previous year.



LOCAL AUTHORITY CLIMATE FORUM CONFERENCE- AGENTS FOR CHANGE



On November 5th Climate Action Teams from the 31 Local Authorities attended the Agents For Change forum to share initiatives and developments that they could bring back to their own counties, and to take part in a skill and resilience development session. The forum was sponsored by IPB

Insurance and hosted in the Midlands Park Hotel, Portlaoise by Laois County Council.

Suzanne Dempsey, Climate Action Co-ordinator presented to Climate Action Staff from across Ireland on her experience of delivering Portlaoise Low Carbon Town Project as it was designated as a demonstration decarbonising zone in previous National Climate Action Plans.

Dr. Quentin Crowley of Trinity College Dublin highlighted the pilot course Systems Innovation for Sustainable Enterprises and Communities (SISEC), developed in partnership with Laois County Council. Run over three months in early 2024 in Portlaoise. This course brought together 40 participants from 32 organisations from public, private, and voluntary sectors, creating a model of community-based learning that other local authorities expressed interest in adopting.

Vanessa Langford, Marketing Manager at Midlands Park Hotel, shared her experiences as a participant on the SISEC course, particularly applying Systems Thinking from the course to her work and personal sustainability efforts through the hotel's "Champions for Change" Green Team.

Megan Best, CEO of Native Events, spoke about greening festivals, referencing Native Events' work with Laois County Council to develop the "Green Your Festival Kit" for sustainable event management.

Portlaoise Travel Cluster Project



On November 7th, 50 students and their teachers from six Portlaoise primary schools gathered at the Council Chamber as part of the Portlaoise Travel Cluster Project to discuss creating safer, healthier, and more sustainable school journeys. Facilitated by Green-Schools Travel Officers Michèle Castiaux and Chiara Hanrahan, the forum enabled students to share achievements from the October "Walk to School" week and to plan for upcoming events such as Clean Air Week and the Winter Walk.

Laois County Council is sponsoring the implementation of the Green-Schools Travel theme across ten mainstream schools in Portlaoise, aiming to increase sustainable travel among students. This initiative integrates proven strategies from the national Green-Schools Travel programme, including travel audits, student surveys, educational workshops, and mapping exercises. By promoting walking, cycling, scooting, and the use of public or shared transportation, the program encourages a shift toward active, eco-friendly commuting options. This approach not only fosters healthier habits among students but also reduces local traffic congestion and emissions, supporting broader climate and sustainability goals for Laois.

This project builds on recommendations from the 2020–2021 School Sustainable Travel Study, in Portlaoise funded by Laois County Council. The Portlaoise Travel Cluster Project represents a strategic effort to implement those recommendations, fostering a shift towards active, sustainable school travel in Portlaoise.

Presentation to Laois TY students for the DREAMBIG programme



Laois County Council are partnering in the DREAMBIG Program in the Midlands and as part of this 26 TY students from Laois secondary schools visited the Council Chamber on 11th November to hear from the Climate Action Section of Laois County Council on what is happening and how to get involved in local climate

action.

Through the DREAMBIG program, students gain knowledge, engage in hands-on experience, and are guided in pursuing careers in the Midlands manufacturing sector. The visit to the Chamber offered the group an opportunity to hear from Sam Mc Leod, Environmental Awareness Officer and Karen Moore, Community Climate Action Officer about the climate action and sustainability work that goes on in their local government. The students took part in a workshop to help them find opportunities to apply their interests and skills to climate action.

Laois Federation Tidy Town Awards

The Laois Federation Tidy Towns Awards 2024 celebrated the remarkable achievements of community groups across the county, recognizing their contributions to environmental sustainability, heritage preservation, and community involvement. Here's a summary of the key winners:

- **Best Streetscape**: **Ballacolla** Known for its vibrant floral displays, new notice board, and eco-friendly grass verges that support pollinators.
- **Best Landscaping: Clonaslee** Impressive approach roads, stone walls along the river, and the beautiful Brittas Woods, with a nod to the town's heritage.
- **Best Floral Display: Durrow** Stunning year-round floral displays, with Durrow continuing to shine since its 1966 Tidy Towns involvement.
- Best Heritage Feature: Mountmellick Rich in history, especially highlighted through the Mountmellick Embroidery Museum and storytelling by local historian Paddy Buggy.
- Best Biodiversity Project: Portlaoise Outstanding biodiversity efforts, including the planting of 30,000 native trees and the creation of pollinator-friendly environments.
- Best Community Involvement Project: Stradbally A strong sense of community with initiatives like "Adopt a Planter" and biodiversity projects at the Ballymore/N80 junction.
