

WELCOME TO COUNTY LAOIS

Information for new members of our community

Laois County Library Service highly values the culture of welcome that we aim to place at the heart of our service and our community in County Laois. This was acknowledged in 2019 by Places of Sanctuary Ireland when Portlaoise Library was recognized as the first Library of Sanctuary in Ireland. Through our work with Laois Integration Network (and its many member groups), Laois Partnership, direct provision centres and the many library members who are new to County Laois we identified a need for information as a key barrier to the new members of our community accessing the services they need, making meaningful connections and feeling welcome in County Laois. Although this guide is not exhaustive we hope that it provides at least access points to the different areas of Laois community and services. The publication of this guide was funded by the Dormant Accounts Fund and Laois County Council.

SHORT HISTORY OF LAOIS

Archaeology tells us that the first people in Laois were hunters and gatherers about 8,500 years ago when the land was covered with forests. By the Neolithic period (4000-2500 BC) the first farmers appeared, clearing forests and planting crops. Bronze Age people lived here around 2500 BC producing weapons, tools and golden objects. They were followed by people of the pre-Christian Celtic Iron age.

By the first century AD, Laois was part of the Kingdom of Ossory. The county was divided roughly into seven parts, which were ruled by the Seven Septs of Laois: O'More (O'Moore), O'Lalor, O'Doran, O'Dowling, O'Devoy (O'Deevy), O'Kelly and McEvoy.

When Christianity came to Ireland, holy men and women founded religious communities in Laois. Between 550 and 600, St. Canice founded Aghaboe Abbey and St. Mochua founded a religious community at Timahoe. Later, religious orders with strong ties to the continental Catholic Church replaced the older religious communities.

Around 1150 the Normans seized control of Ireland. In Laois, the fortress on the Rock of Dunamase was part of the dowry of the Irish princess Aoife, who was given in marriage in 1170 to the Norman warrior Strongbow. The Normans controlled the best land in the county, while the native Irish retreated to the bogs, forests and the Slieve Bloom Mountains. The early 14th century saw a Gaelic resurgence with the Irish chieftains forcing the Normans to withdraw.

In 1548. English warriors confiscated the lands of the O'Mores, and built the Fort of Leix. Portlaoise is the town that grew up around the fort. In 1556, the town was named Maryborough and Laois was named Oueen's County in honour of the English queen, Mary Tudor. Queen Mary issued orders for the plantation of Laois with English settlers. Irish chieftains fought the English, but the power of the Gaelic chieftains was broken and by 1610, most of Laois's Irish nobility were transported to the south and west of Ireland, Catholic tenants and landless labourers remained behind and served the Protestant settlers who now owned the land.

The Great Famine of 1845-49 devastated the county and many of the poorest people died or emigrated. Further crop failures in the 1860s and 1870s, along with increasing levels of debt, caused an increase in tensions between the county's landlords and their tenants. Tenants began to assert their rights and oppose the landlord system.

By the end of the century a series of land reforms had transferred much of the land ownership to the tenants. This coincided with an increase in Irish nationalism, with many Irish people feeling that Ireland should control her own destiny. This led to the Irish War of Independence and the establishment of a new Irish State in 1922. The new Ireland gave the county its old name back. Queen's County was once again County Laois.

If you live in Ireland and are a victim of a crime, you should contact the Gardaí – the Irish police force.

Portlaoise Garda Station is open 24 hours a day seven days a week and can be contacted on 0578674100. Other stations in Laois are part-time and contact details can be found below.

Crimestoppers is a partnership between the Gardai and the community. You can give information to the Gardai criminal investigation about anv using the confidential freephone number 1800 25 00 25. The caller can remain anonymous. This confidential freephone number is staffed by members of the Garda National Bureau of Criminal Investigation.

If you are a victim of crime, you are entitled to information from An Garda Síochána. You will be told the name, telephone number and station of the investigating Garda and Garda record number on its PULSE system. You will also be informed about:

- · your role in the criminal justice system
- the support services available
- the compensation schemes available
- how to access legal aid and your entitlement to certain expenses if the matter goes to court

The Gardai will explain the investigation process to you and make sure that you are kept informed about the progress of the investigation, including whether a suspect is charged or cautioned. You will also be told about the support services available to victims of crime.

The Garda Victim Service Offices will acknowledge your report of the crime and keep you informed of significant developments during the investigation. Where it is decided to prosecute or not to prosecute you, following an investigation into an incident, the Gardaí or the Director of Public Prosecutions will write to you to let you know of that decision. Sometimes you may be told in person. The Gardaí will show special sensitivity if you are the victim of a sexual offence. The Gardaí will try to make sure that the Garda and the doctor who are helping you are of the same gender. You will be told about special support agencies dealing with sexual offences.

SOCIAL ENTITLEMENTS

Intreo Centre

The Department of Social Protection runs Ireland's social welfare system. The staff are known as Community Welfare Officers. They assess and advise on the eligibility for allowances and supplements. They can give you advice about income support and social welfare payments and can help you with finding a job. Examples of social welfare payments include Jobseeker's Allowance, One Parent Family Allowance, Disability Allowance and Child Benefit. All allowances are subject to means testing and vary according to circumstances and the nature of the need.

Intreo is a new service from the Department of Social Protection. Intreo is a single point of contact for all employment and income supports. Designed to provide a more streamlined approach, Intreo offers practical, tailored employment services and supports for jobseekers and employers alike. Their offices are called Intreo Centres. 

Personal Public Service Number (PPSN):

A Personal Public Service (PPS) Number is a unique reference number that helps you access social welfare benefits and public services in Ireland. It is required when applying for any benefits, entitlements, social housing support and health care e.g. medical card in Ireland. It is also used for employment and taxation purposes. A PPS Number is always 7 numbers followed by either one or two letters. To get a PPS Number, you will need to provide evidence of why you need a PPS Number and provide a copy of your photo identity document (Passport, Driving Licence, ID card) and proof of your address. If you do not have valid documents, you should provide whatever ID documents that you do have. You can apply online, in writing by filling out a REG1 form or by email. Public Services Card:

The Public Services card allows people to access a range of government services and payments. Contact Portlaoise Social Welfare office at 057 8678010 for an appointment to get the card. You must attend in person in order to have your photograph taken. You will need to bring your passport/driving licence as proof of identity and current utility bill as proof of address.

Accommodation:

Private rented Accommodation:

Most rooms, flats, apartments and houses to rent are advertised on accommodation websites such as https://www.daft.ie/ or www.myhome2let.ie. You can search for accommodation and set up alerts for your specific requirements. In Laois keep an eye out in the accommodations section of the local newspapers such as the Laois Nationalist and Leinster Express. Local noticeboards and local newsletters are also sources for information. You may also find available accommodation through word of mouth or 'To Let' signs on properties. Be aware of your rights and your obligations as a tenant and your landlord's rights and obligations. For example, your landlord must provide you with a rent book and ensure that the accommodation meets certain minimum physical standards. They must also register the tenancy with the Residential Tenancies Board (RTB). For more information visit www. citizensinformation.ie.

Housing Assistance Payment

The HAP (Housing Assistance Payment) scheme is a form of social housing support which authorities can provide housing assistance to households with a long-term housing need, including many long-term Rent Supplement recipients. It is provided by the local authority i.e. Laois County Council (not by the Department of Social Protection). You must be an approved housing applicant in order to be eligible for HAP. HEALTH

In Ireland, the public health service is run by the Health Service Executive, the HSE. It oversees hospitals, local health centre and offices. These provide a range of services including:

- · Child health services
- · Community Welfare
- · Public health nursing
- · Family Doctor Services
- Speech therapy
- · Social Work
- Physiotherapy
- · Addiction Counselling and Treatment
- · Psychiatric Services
- Occupational therapy
- Audiology Services (Care of hearing)
- Chiropody Services (Care of the feet)
- Ophthalmic Services (Care of the eye)

Registering with a family doctor/General Practitioner/GP:

To access health services, you will need to register with a family doctor/GP in your area. A GP is often the first doctor people see about a health problem. GPs provide referrals to more specialised doctors called consultants and other services such as addiction or counselling. You cannot see a consultant for the first time without a referral from a GP. You will find a list of General Practitioners on https://www.icgp.ie/go/find_a_gp. Some GPs only offer services to private patients, while others may deal with both private and medical/GP card patients. Your local health office can provide you with a list of the GPs in your area who accept medical card patients.

On registering you will have to give your name, address, contact number and date of birth. If changing your GP, you should tell your current doctor of your plans to change and ask that your medical history be sent on to your new doctor.

Medical Card Scheme:

The medical card scheme entitles certain people to free public health services. With a medical card you can get public health services free of charge, including doctor visits and public hospital services. To be eligible, your income must be below a certain level. If you do not qualify for a medical card on income grounds you may be eligible for a GP visit cards. You can apply online at www.medicalcard.ie or phone 1890 252919. You will need you will need to provide PPSN (Personal Public Service Number), dates of birth, income and expense details. Your local citizen's information office can provide you with more information on eligibility.

GP Visit Card:

This card entitles you to free visits to your family doctor/GP. To be eligible your income must be below a certain level. However, children under the age of 6 years and people over the age of 70 years are automatically entitled to a GP visit card without an income test. The GP card does not cover you for medication costs and hospital visits. You will need a PPS number to register online or you can fill out an application form manually. Local Pharmacy

Your local pharmacist can advise on some minor ailments and recommend medicines that do not require a prescription.

Dental Treatment Services Scheme:

This scheme provides access to limited dental treatment for adult medical card holders only. This includes a free oral examination every calendar year and free emergency treatment to relieve pain.

Public Health Nurse:

Public Health Nurses are employed by the Health Services Executive to provide a range of health services in the community. You can contact your local Public Health Nurse at your local health centre. Services include post hospital care, dressings and injections and referrals to other services. Your PHN can also advise you on Dietary, Occupational Health and Counselling Services.

Mental Health:

Mental health problems are common and can have a very wide range. If you feel persistently sad, depressed, have trouble sleeping or have other concerns you should contact your GP for advice. In an emergency situation you may contact the Department of Psychiatry in Portlaoise Hospital or if it is late in the evening or night-time MIDOC is available at 1850 302 702.

EDUCATION

Early Childhood Education:

This is not part of the formal education system. It is run by private, community and voluntary groups. The Early Childhood Care and Education Programme (ECCE) gives children less than 4 years of age access to two full academic years of free pre-school before they start primary school. Children are eligible to start the ECCE scheme in the September of the year that they turn 3 years old. For more information on this scheme visit https://www.earlychildhoodireland.ie/. Primary education:

Children attend primary schools, also known as national school, between the ages of 4 and 12. Primary education consists of an eight-year cycle: junior infants, senior infants, and first to sixth classes. Education in state primary schools is free. The school year is from September to June. A list of primary schools in Laois can be found on the www.education.ie or www.schooldays.ie websites.

The Citizens Information website-www.citizensinformation.ie- provides a step-bystep guide to how to enrol your child in a primary school.

Secondary education:

The secondary level of education is five years with two State examinations during that time, the Junior Certificate after three years and the Leaving Certificate after five years. Some schools offer a transition year after the Junior Certificate making the school cycle six years in total. Children begin their second-level education around the age of 12 and finish around the age of 17 or 18. The Citizens Information websitewww.citizensinformation.ie - provides a step-by-step guide to how to enrol your child in a secondary school.

Third level Education:

This includes colleges, universities of technology, colleges of education and private third level colleges. Access to these is usually based on the Leaving Certificate results. The Central Applications Office (CAO) manages admission applications to higher education institutions. You can apply for a place by sending a completed application form to the CAO. For further information go to www.cao.ie.

Financial support for third level students is means tested (it is based on family income). Grants are available to help meet living expenses, transport costs and or college fees. The grants are managed by Student Universal Support Ireland (SUSI). For more information visit their website at https://susi.ie/.

Training and Education Supports:

Laois and Offaly ETB:

The Education and Training Board offers a range of adult and further education and training programmes. These programmes include Post-leaving certificate (PLC) courses, Vocational Training Opportunities Scheme (VTOS), Youthreach programmes for early school leavers and evening classes for adults. The Information Hub (LOETB Adult Guidance Service) is a place to seek advice on Adult Education pathways, options and funding and provides one to one guidance and information.

Laois County Library Service

The library provides access to informal lifelong learning by providing access to a national collection of over 12 million books and other media. There are also online learning courses and other online resources. These are all for free.

Qualifax:

This provides comprehensive information on further education and training courses. They include different types of courses some of which lead to qualification while others do not. The site has a listing of all courses in Ireland. It is annually updated with information about further and higher education and training options in Ireland and further afield.

Skills to Work:

Skills to Work is an Irish Government jobs campaign, aimed at making it easier for jobseekers and employers to know what Government skills initiatives are available to them and to encourage businesses to employ people currently unemployed. Using online information, you can find out which of the Government skills initiatives -Springboard, JobBridge, JobsPlus and Skillnets - could best suit you.

The Springboard+ provides free higher education courses for people who are unemployed and those looking to return to the workforce. You can also apply for a Springboard+ course if you are working, but you must pay a 10% contribution towards the course fee. There is a range of part-time courses from certificate to master's degree levels. Visit the back to education section of www.citizensinformation.ie for further information.

The Back to Education programme can support people getting a social welfare payment to access second- and third-level education.

The Part-Time Education Option allows you to keep your Job Seeker's Allowance or Jobseeker's benefit and attend a part-time day or evening course that will improve your chances of getting a job.

The Education, Training and Development Option allows you to keep your jobseeker's payment and attend a course not covered by the standard Back to Education allowance such as a personal development course.

Vocational Training and Opportunities/VTOS:

If you are over 21 years of age, are unemployed and have been getting certain social welfare payments for at least 6 months you can apply for the Vocational Training and Opportunities Scheme (VTOS). This scheme provides a range of courses to meet the education and training needs of unemployed people. It gives participants opportunities to improve their general level of education, gain certification, develop their skills and prepare for employment, self-employment and further education and training. VTOS is operated through Laois Education and Training Boards and is aimed at unemployed people who are early school-leavers.

Portlaoise Education and Training Board:

Portlaosie ETB have a range of English language classes to suit most levels. They offer:

- · An initial assessment of your current English language level, so you can understand where your language skills are on the National Qualifications Framework (NOF).
- Structured English language tuition to improve your use of English grammar, vocabulary, and spelling and to increase your confidence and fluency in using English for speaking, listening, reading and writing.
- The chance to get ready to start working towards a qualification to progress your English language skills.

If you are not sure of your level, don't worry, each student is assessed before being placed in a class. They will find a class that suits you. Most of their courses are free of charge or low cost. There is no fee for courses at Beginner to Elementary level. For higher level courses, learners may have to buy books or pay a small fee. BUSINESS AND EMPLOYMENT

Who can work in Ireland?

If you are from a European Union/EU member state, one of the countries of the European Economic Area/EEA, Switzerland or the UK, you are entitled to come to work in Ireland. You do not need an employment permit. You are entitled to have your dependents come to live with you.

If your non-European Economic Area/EEA spouse or civil partner is coming to live in Ireland with you, they must apply for permission to remain under EU Treaty Rights to have similar rights to live and work in Ireland.

If you are an EEA, Swiss or British national, you are entitled to be treated in the same way as Irish citizens when you apply for work in Ireland. You are free to apply for any job vacancy, including jobs in the public sector.

If you are from any another country, then generally you need an employment permit. There are 9 different employment permits. For more information on these go to www.citizensinformation.ie.

People who have been granted refugee status in Ireland and people who have been refused refugee status but have been given permission to remain on humanitarian grounds do not need an employment permit.

Quality and qualifications Ireland (QQI) is the state agency responsible for the recognition of foreign qualifications in Ireland and the recognition of Irish qualifications abroad.

It provides advice, information and support to you in starting up or growing your business. You can set up a business as a sole trader, as a partnership or as a limited company. The type you choose depends on the kind of business you are running and with whom you are doing business. Local Enterprise Offices (LEOs) provide






Dignity Partnership

Free Travel Scheme:

The Free Travel Scheme allows you to travel free of charge on all public transport owned by the State. This includes bus, rail and Dublin's LUAS with some exceptions.

Everyone aged 66 and over, legally living permanently in the State, is entitled to the Free Travel Scheme. Some people under 66 also qualify. In some cases, a Free Travel Companion Card is available. This card allows a companion to travel with you for free. No one else can use your Free Travel Card; it is for you only.

Free travel is also available on a limited number of services operated by private bus transport companies. Private bus transport operators that have opted in to the Free Travel Scheme accept free travel cards.

Driving in Ireland:

To drive in Ireland, you must have a valid driver's licence. If you have never driven before you will first need to:

- · Pass the driver theory test
- Apply for a learner permit
- Complete a driving test course/Essential Driving Training/EDT
- Pass a driving test.

Driver Theory Test:

You will need to have passed a driver theory test before applying for a learner permit. There are different tests depending on which category of drivers licence you are applying for. Go to https://theorytest.ie/ to book your theory test. When going to the driver theory test centre you will need the following: valid proof of identity, evidence of your Irish PPS number and two identical colour passport sized photographs.

Driving Licence/Learner Permit

When applying for a driving licence or learner permit, you must visit a National Driver Licence Service (NDLS) Centre. The only NDLS Centre in Laois is in the basement of the Laois Shopping Centre in Portlaoise. As part of the face-to-face application process, your photograph and signature are captured digitally. You must also provide proof of your PPS number (see Section on how to apply for this), proof of address, and photographic identification to confirm your identity. Other documentation is also required please visit www.ndls.ie for more information. You can make an appointment at www.ndls.ie. You are required to carry your driving licence with you at all time when driving.

It is possible to exchange a driving licence issued by certain recognised states, a list of which is available on www.citizensinformation.ie under the travel and recreation section. If you have a European Union/European Economic Area driver's licence you may continue to drive in Ireland on your current licence. You can exchange it for an Irish drivers' licence when it expires.

If you are the holder of a driving licence issued by a country not recognised for driving licence exchange, you cannot exchange your driving licence for an Irish driving licence and will have to go through the full driver licensing procedure starting with the driver theory test. If you have a licence from a country outside of the EU/EEA, then you may drive on your driver's licence in Ireland for 12 months. However, after the 12-month period you need to apply to have your driver's licence changed to an Irish one. For more information on this go to https://www.ndls.ie/

Driving Test:


Once you have completed your Essential Driver Training sessions and held your learner driving permit for at least six months, you may book your driving test on the https://rsa.ie/. The Essential Driver Training course is made up of 12 one-hour Sessions with a Road Safety Authority approved instructor, which you must complete before taking your Driving test. Alternatively, you can download a driving test application form or obtain a copy from any motor tax office. It is recommended that the driving test be applied for well in advance as waiting times can be long.




Motor tax:

Under Irish Law, if you have a car you must pay motor tax before you can drive it. Motor tax is collected in Laois by Laois County Council. You can pay online at https://laois.ie/online-payments/. You can get more information about the cost and how to pay motor tax at www.motortax.ie. Online payment will require:

- Vehicle registration number
- PIN number- Your PIN number may be received from Shannon via email, text or reminder motor tax form. If not, try last 6 digits of Vehicle
 - Registration Certificate VRC/logbook i.e. C17____123456.If new/imported vehicle, it is the last 6 digits of your chassis number (also known as Vehicle Identification Number/VIN number on VRC/logbook)









Motor Insurance:

Under Irish law, you must also have motor insurance before you can drive your car in Ireland. Driving without insurance in Ireland is a serious offence. If caught you will have to pay a fine, may be disqualified from driving and get penalty points on your driving licence. Most insurance companies sell motor insurance. The price can vary a lot from company to company and depends on the age of the car, the type of car and the age and experience of the driver.

National Car Test:

Under Irish law, your car must have regular tests to make sure it is road worthy and safe to drive. This test is called the National Car Test or NCT and is carried out in local testing centres. If your car has not got a up to date NCT certificate you could face a fine and penalty points on your driving licence. BANKING

There are three main types of financial institutes in Ireland: banks, building societies and credit unions. You can open an account in any bank or building society for your everyday banking needs. This type of account is called a current account you can lodge/put money in such as your salary or social welfare payment or take money out in branch or via an ATM. This account will also allow you to pay bills or transfer money.

A Savings account is one where you gain interest on your money. It is also called a deposit account. If you do earn interest on your savings, you will have to pay a tax on the interest called Deposit Interest Retention Tax (DIRT).

A credit union is a financial co-operative where members can save money and can lend money to each other at reasonable rates of interest. Unlike banks, credit unions are non-for-profit organisations with a community focus. To find out more and to become a member, visit www.creditunion.ie

VOTING

In order to vote in an election or referendum in Ireland, you must be eligible to vote and registered to vote.

Eligibility:

Each local authority must put together and publish a list of voters in its area. This is called the Register of Electors. You can check the Register at local authority offices, Garda stations and public libraries, or online at https://www.checktheregister.ie

To be eligible for inclusion in the Register of Electors, you must:

- Be at least 18 years old on the day the Register comes into force (15 February). You can add your name to the draft Register before you turn 18.
- Have been ordinarily resident in the State on 1 September in the year before the Register comes into force.
- To be eligible to vote, you must be resident in Ireland. Also, your eligibility to vote
 in different types of elections depends on your citizenship.
- Irish citizens can vote in every election and referendum
- British citizens can vote in Dáil, European and local elections
- EU citizens can vote in European and local elections
- Non-EU citizens including refugees and asylum seekers can vote in local elections.

Registration:

To add your details to the Register of Electors, you complete form RFA available online at www.checktheregister.ie and return it to Laois County Council. Forms are also available from all local authorities, post offices and public libraries. You do not need to pay for postage. The Register of Electors is published on 1 February each year and comes into force on 15 February. If your name is not on the Register of Electors on 15 February, you can apply to be included in a supplement to it, using form RFA2. This will allow you to vote in any election or referendum held during the year. You can apply at any time. However, you can only be included in the supplement used at an election or referendum if your local authority gets your application at least 15 days before polling day. Sundays, public holidays and Good Friday are not counted as days for this purpose. For more information go to www.citizensinformation.ie

CITIZENSHIP

How can I become an Irish citizen?

Irish citizenship is obtained in different ways. Most Irish citizens get their citizenship through birth or descent. Foreign nationals can apply to become Irish citizens through naturalisation. Naturalisation is the process through which a foreign national living in Ireland may apply to become an Irish citizen. To apply for naturalisation in Ireland, you must have been physically resident in Ireland for a certain length of time. If you are a foreign national who is either married to an Irish citizen or a civil partner of an Irish citizen, you can apply for Irish citizenship through naturalisation. The residence requirements are more favourable for the spouse or civil partner of an Irish citizen but there is no longer an absolute entitlement to Irish citizenship through marriage. Dual citizenship

If you are an Irish citizen, you may also hold dual citizenship, that is, citizenship of another country. You should be aware that certain countries do not recognise dual citizenship. If you wish to apply for dual citizenship, you should check with the authorities of the other country to ensure that your rights are protected. For example, the law in some countries provides for the automatic termination of its citizenship or nationality if you acquire another citizenship or nationality. You should also be aware that acquiring Irish citizenship does not automatically void the obligations of another citizenship or nationality (for example, the requirement to complete military service). 



