68. Part VIII of the Local Government Planning & Development Regulations 2001 in respect of proposed Playground & MUGA development by Laois County Council and Borris-in-Ossory Community Development Association

Notice of Motion No: 20/2021

Councillor Aisling Moran proposed the following Notice of Motion:

"That this Council support the change to the Bye-laws to give additional powers to the Gardaí to allow for them to confiscate horses if there are not chipped or registered or if they are involved in illegal activity and to put in place measures to fine and arrest those involved"

This Notice of Motion was seconded by Councillor Thomasina Connell. The Members were advised that a meeting is being arranged between the Environment and Housing Departments of Laois County Council and the Gardai on this matter. This meeting will examine the effectiveness of the current Control of Horses byelaws. An update will be given at the next Council meeting on the progress made. Any changes that are considered necessary will subsequently be brought forward to Council for their consideration.

Councillor Moran requested that the sub-committee be set up. Mr. Joe Delaney, Director of Services advised that the Council already has SPC committees for dealing with policy matters but confirmed that a sub-committee could be set up for a short period if Council so wish to consider the detail and any proposals would be brought to both the Transport, Environment & Emergency Services and the Housing, Regeneration & Planning SPCs for their consideration.

The Cathaoirleach, Councillor Fitzgerald proposed that the Chair of each Municipal District submit two nominations from each district for the sub-committee.

Notice of Motion No: 21/2021

Councillor Willie Aird proposed the following Notice of Motion:-

"That Laois County Council supports the development of market and production outlets for dairy output from this County"

Notice of Motion No: 22/2021

Councillor Willie Aird proposed the following Notice of Motion:-

"That Laois County Council request a reply from the Minister for Education as to the commencement date for work on Kolbe Special School for Laois children"

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. It was agreed that a letter issue to the Minister for Education in this regard. Councillor Aird indicated that there has been no commencement date for the refurbishment of the Kolbe Special School.

The Cathaoirleach, Councillor Catherine Fitzgerald referred to a press release which she had received last week from Minister Sean Fleming which issued from the Minister for Education, Ms. Norma Foley, T.D. confirming that the Kolbe Special School has recently been authorised to progress to Stage 2B – detailed design which includes applications for all statutory consents, including planning permission, disability certificate and fire safety certificate and also the preparation of tender documentation. The brief is to provide a new replacement school building designed for special needs pupils on a greenfield site and the project will deliver a single storey building, providing an 8 classroom special school and appropriate ancillary accommodation including a general purpose room, a Home Economics Room, a Daily Living Skills room, library and resource area.
