#### 203. NOTICE OF MOTIONS

#### Notice of Motion No: 70/2019

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council put in place procedures so that public service companies carry out maintenance works when it is it minimally disruptive to the majority, for example at night, weekends and not during business hours as is done all across Europe, America, Australia. They force businesses to close their doors at another cost to the businesses"

This Notice of Motion was seconded by Councillor Mary Sweeney. The Members were advised that there are a multiplicity of organisations and agencies that use the public road network for the purposes of maintaining and upgrading their services.

For its part Laois County Council assesses its own jobs on a case by case basis so as to decide the appropriateness of carrying out works during daytime hours or at night. Night time works can reduce impacts on businesses and commuters but are more expensive and can increase inconvenience for residents depending on the location of the works.

Aside from local authorities there are numerous other statutory bodies (ESB Networks, Irish Water, Eir etc.) all of whom have legal entitlements to maintain and upgrade their services. These agencies also undertake daytime and nighttime works, as assessed on a case by case basis. It would appear inevitable that, in circumstances where such work are restricted solely to nighttime hours, there would inevitably be a consequent increase in service consumption costs. Local Authorities cannot compel such agencies to complete all of their works at night.

Thereafter, there are also health and safety issues that dictate that certain works are more appropriately addressed during daytime hours than at night.
