# Notice of Motion No: 14/2019

"That Laois County Council provide an update for their plans for a local digital strategy including supporting the rollout of Broadband throughout the County"

This Notice of Motion was seconded by Councillor John King. The Members were advised that Indecon have been engaged by the Department of Rural and Climate Action (DRCA) to develop a template for all Local Authorities in relation to the Local Digital Strategies (LDS). In 2018, Laois County Council filled out an extensive questionnaire for Indecon in line with the Digital Readiness Assessments and Guidelines documents.

The Broadband officers with approval from the DRCA have asked Indecon for one to one support sessions to develop their own LDS.

The Broadband Officer is currently completing a survey issued by Indecon and consulting with the relevant sections of the Council such as IT, the Business Support Unit and LEO office for their imput.

As soon as Indecon has replies from all Local Authorities they will be in touch to finalise dates for the one to one sessions.

In relation to the Rollout of Broadband across the County, EIR are continuing to roll out their service in the county, Cignal are currently developing their infrastructure including 10 sites in Laois. This infrastructure is currently being looked with the view to being shared amongst the service providers.
