# 64. MINUTES OF THE MAY MONTHLY MEETING HELD ON THE 30<sup>TH</sup> OF MAY 2022

On the proposition of Councillor John Joe Fennelly seconded by Councillor Paddy Bracken, the minutes of the May monthly meeting of Laois County Council held on the 30<sup>th</sup> of May 2022 were confirmed as circulated. Councillor Aidan Mullins, under

matters arising, read out a statement from the RTS Group in relation to previously agreed Notice of Motion and associated correspondence, recently received from ESB Networks/Eirgrid.

In summary, the group are requesting Laois County Council to facilitate the procurement of a suitable, independent, expert company to carry out a risk assessment of the site at Coolnabacky, prior to the commencement of works on the main footprint and structure of the substation. The Elected Members and the RTS Group are requesting a meeting with officials of Laois County Council to discuss same.

Mr. Simon Walton, Director of Services advised that Laois County Council is and has been available for such a meeting. Mr. Walton also confirmed that ongoing environmental inspections were being carried out at the Site and, in the specific matter of drinking water, highlighted that ongoing monitoring of the local water supply was being undertaken in accordance with Drinking Water Regulations and monitoring results are in accordance with drinking water standards.

Councillor P.J. Kelly under matters arising sought an update on Notice of Motion No: 25/2022 which was proposed and seconded at the May Meeting of Laois County Council in relation to the reinstatement of lights that are non-operational on the M7/M8 Motorway. It was agreed that Laois County Council would engage further with the T.I.I. on the matter.

# 67. PART VIII OF THE PLANNING & DEVELOPMENT REGULATIONS 2001 IN RELATION TO THE PROPOSED DEVELOPMENT OF THE CONSTRUCTION OF A RESIDENTIAL DEVELOPMENT OF 54 HOUSES ON A SITE OF 2.4 HECTARES OF HEPBURN COURT, PORTLAOISE, CO. LAOIS

On the proposition of Councillor Caroline Dwane Stanley seconded by Councillor Thomasina Connell, the Members unanimously agreed to the proposed development of the construction of a residential development of 54 houses on a site of 2.4 hectares of Hepburn Court, Portlaoise, Co. Laois in accordance with Part VIII of the Planning & Development Regulations 2001.

The Members were circulated with the planning report on the proposed development which will consist of the construction of 54 dwellings, foul and surface water drainage works and surface water attenuation, footpaths and landscaped public open space with passive and active areas that includes a secure playground for young children,

associated siteworks that includes boundary treatment and a total of 111 no. car parking spaces.

The Members were advised that the issue of boundary treatment would be addressed.

# 68. DISPOSAL OF LAND UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT 2001

## (i) LEASE OF 0.94 HECTARES OF LAND AT MONURE, GRAIGUECULLEN

On the proposition of Councillor Padraig Fleming seconded by Councillor Ben Brennan, the Members unanimously agreed to the lease of 0.94 hectares of land at Monure, Graiguecullen in the townland of Monure for a period of 3 years—consideration for the licence agreement shall be €1.00 per annum and the consideration for the lease agreement of the property shall be €100.00 per annum.

## (ii) LEASE OF 2.1 HECTARES OF LAND AT MONURE, GRAIGUECULLEN

On the proposition of Councillor Ben Brennan seconded by Councillor Padraig Fleming, the Members unanimously agreed to the lease of 2.1 hectares of land at Monure, Graiguecullen in the townland of Monure for a period of 3 years – consideration for the lease of the property shall be €1.00 per annum and the consideration for the lease agreement of the property shall be €1.00.00 per annum.

# (iii) DISPOSAL OF 3.75 HECTARES OF LAND AT J17 NATIONAL ENTERPRISE PARK, TOGHER, PORTLAOISE

On the proposition of Councillor James Kelly seconded by Councillor Thomasina Connell, the Members unanimously agreed to the disposal of 3.75 hectares of land at J17 National Enterprise Park, Togher, Portlaoise in the townland of Togher for a consideration of €966,000 plus V.A.T.

# (iv) DISPOSAL OF 1.49 HECTARES OF LAND AT CLONMINAM, PORTLAOISE

On the proposition of Councillor John Joe Fennelly seconded by Councillor Barry Walsh, the Members unanimously agreed to the disposal of 1.49 hectares of land at Clonminam, Portlaoise in the townland of Knockmay for a consideration of €396,476.00 plus V.A.T.
