38. STATEMENT BY CATHAOIRLEACH

The Cathaoirleach advised the Members that it had been brought to his attention that Laois County Council did not formally comment as a body following publication of *Report* of the Mother and Baby Homes Commission of Investigation and proceeded to make the following statement on behalf of Laois County Council with the agreement of the Members:-

"That Laois County Council conveys its regrets as to the wrongs visited on mothers from County Laois and their children who ended up in a Mother and Baby Home or who were discriminated against based on the marital status of the mothers in relation to their pregnancy. The lack of respect for the rights and dignity of mothers and children who spent time in these institutions or who were discriminated against on account marital status of the mothers is also acknowledged and regretted. In passing this motion, the Council also bears in mind the totally unacceptable treatment of the woman referred to at section 19.29 of the Final Report of the Mother and Baby Homes Commission of Investigation, when she presented in 1934 to the hospitals in Abbeyleix and Portlaoise"

60. NOTICE OF MOTIONS

Notice of Motion No: 12/2024

Councillors Thomasina Connell, Willie Aird, Barry Walsh, P.J. Kelly, Conor Bergin & John King proposed the following Notice of Motion:-

"That Laois County Council notes, that the Help to Buy Scheme has assisted 982 individuals and families in County Laois with up to €30,000 of their taxes back from the previous four years towards their deposit to either build or purchase their first home. Laois County Council further supports the Government's extension of the Help to Buy Scheme to the end of 2025 and calls for the scheme to be extended to the end of 2026 in Budget 2025 to introduce certainty for prospective buyers or those seeking to build their first home"

This Notice of Motion was seconded by Councillor Paschal McEvoy. The Members were advised that correspondence would issue in this regard.

Notice of Motion No: 13/2024

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council clean and repair road signs across County Laois"

This Notice of Motion was seconded by Councillor Paddy Bracken. The Members were advised that Laois County Council maintain and clean Regional and Local road signage on our network on an ongoing basis. Following an extended wet period from last summer through to the current spring conditions have been challenging in this regard. There is currently a concerted effort to clean and replace damaged signage (where required) on the Regional road network given that it carries approximately 50% of the traffic within the County. National road signage cleaning and maintenance is the subject of a contract managed by Transport Infrastructure Ireland.

Notice of Motion No: 14/2024

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council clarify what protocol/s we rely on when valuing land purchased through the CPO process, to include an explanation of the protocol the Council relies on to ensure all persons from who land has been compulsorily purchased are treated equally and fairly whether in terms of financial remuneration and/or by way of benefit in kind, or work completed on boundaries of land purchased through the CPO process"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that in assessing compensation for land that has been compulsorily acquired by means of a CPO, Acquiring Authorities rely on rules, established further to the provision of the Acquisition of land (Assessment of Compensation) Act 1919 (as amended) having due regard to legal precedents where appropriate. These rules apply equally to all compulsory acquisitions.

Notice of Motion No: 15/2024

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council in line with good governance and best practice, call on the Minister for Housing, Local Government & Heritage, Mr. Darragh O Brien, to bring all Local Authorities under the remit of the Comptroller and Auditor General, and by extension under the remit of the Public Accounts Committee"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that at the moment the Council is subject to the Local Government Audit Service rather than directly to the Comptroller and Auditor General. One marked difference between the Local Authorities and the bodies under the remit of the C & AG is that the meetings of the Council are open to the public and reported on by the press and other local media as such the accounts of the local authorities are subject to much greater public scrutiny in general than other public bodies.

Notice of Motion No: 17/2024

Councillor Caroline Dwane Stanley proposed the following Notice of Motion:

"This Council give an update on the progress made with the refurbishment of Laois Civil Defence building in Portlaoise" This Notice of Motion was seconded by Councillor Aisling Moran. The Members were advised that Laois Civil Defence has substantially consolidated its activities to the recently-purchased premises in Kea-Lew. The Civil Defence Officer reports very positive feedback from volunteers and highlights that training, planning and servicing of equipment for Civil Defence activities are more streamlined from the new premises. Additionally, weekly training, for large groups of volunteers, is now regularly undertaken whereas, previously, this was not possible. In the coming weeks revisions to electrical installations, new signage and the development of revised floor layouts will all progress. Separately, it is of note that the lease on part of the building has expired and the tenant has vacated the premises. Furthermore, part of the building will be used as a count centre for the forthcoming local and European Elections.
