88. PRESENTATION BY LAOIS DOMESTIC ABUSE SERVICE – DEVELOPMENT OF A REFUGE FOR WOMEN AND CHILDREN EXPERIENCING DOMESTIC ABUSE

Ms. Marna Carroll, Laois Domestic Abuse Service accompanied by Mr. John Scanlan, Chief Superintendent of An Garda Siochana delivered a presentation on the proposals for the provision of a refuge for women and children in Laois who are experiencing domestic abuse. Laois County Council assured Ms. Carroll of their support for the proposal and will assist in the preparation and submission process for funding for same. Support will also be given in identifying a suitable site. The Members commended the Laois Domestic Abuse Service for their work.

89. PRESENTATION BY MR. CHRISTY BANNON, SOSAD – PROPOSED OFFICE OPENING IN PORTLAOISE

Mr. Christy Bannon, SOSAD, Portlaoise delivered a presentation on the proposals for an office opening in Portlaoise. The Members assured Mr. Bannon of their support for the proposals and complimented him on the presentation.

90. ECONOMIC DEVELOPMENT AND J17 NATIONAL ENTERPRISE PARK

Mr. John Mulholland, Chief Executive delivered a presentation on the J17 National Enterprise park and Economic Development which included the following:-

93. Notice of Motions

Notice of Motion No: 25/2021

Councillor Mary Sweeney proposed the following Notice of Motion:-

"That Laois County Council provide an update on the tourism promotion plans for the County as the Country reopens to domestic tourism"

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised that Laois County Council is providing the following supports and initiatives to assist the tourism trade in the County and promote the County to visitors:

- 1. A two month Midlands and County Promotion Campaign, in association with Offaly and Westmeath County Councils commenced on Midlands 103 on Monday 17th May 2021. This joint staycation campaign will promote the Midlands and each County in the region. In Laois, the various tourist attractions will be advertised including the Rock of Dunamaise, Round Tower at Timahoe, The Slieve Bloom Mountains and Bike Trail, the Laois Garden Trail and Emo Court.
- 2. In collaboration with Fáilte Ireland the Council will be rolling out the "Keep Discovering" domestic marketing campaign aimed at driving domestic holidays for the remainder of the year and helping to reboot and rebuild Ireland's tourism industry. The national advertising campaign went live on Monday 24th May 2021. The campaign is to encourage and remind more Irish people to discover the joy of holidaying in Ireland as they begin to reconnect with each other.
- 3. In association with Fáilte Ireland, an online training programme "Developing Saleable Experiences" specifically tailored for tourism businesses in the Slieve Blooms was held. The aim is for immediate increased sales and revenues into the domestic market and in time the international market. The initiative is to establish more innovative ways to present and lead out on selling the Slieve Blooms as a new destination in Ireland's Ancient East.
- 4. Work with Businesses to avail of the Fáilte Ireland "Weatherproofing & Outdoor Dining Infrastructure Scheme".

- 5 Avail of the "Additional Outdoor Infrastructure Scheme" administered by the National Transport Authority.
- 6. Support independent tourism and hospitality business owners to create outdoor dining experiences in a regulated and accessible manner through the "Outdoor Seating & Accessories for Tourism & Hospitality Business Scheme" in association with Fáilte Ireland.

The Laois Local Enterprise Office also supports the Tourism and Business Sectors with the following initiatives:

- One to one expert advice with hospitality specialist, Ms Alva Pearson of Pearson Consulting, to support them in re-opening and re-booting their business.
- 19 tourism/hospitality businesses are currently taking part in a marketing programme specifically aimed at the tourism sector.
- In consultation with Laois Tourism the Council has identified other relevant training that will be delivered to this sector over the coming months. This includes Digital Marketing, Social Media, Promotion of Businesses and ongoing Marketing for Businesses. Mentoring will also be provided.
- The Council are currently in the process of delivering a Start Your Own Tourism Business to 15 individuals who have identified opportunities as part of the Blueway experience.

Notice of Motion No: 26/2021

Councillor Aisling Moran proposed the following Notice of Motion:-

"That this Council consider the provision of trails throughout Laois for horses. There are very few areas where horses and their riders can safely go. This will also be very important from a tourist perspective"

This Notice of Motion was seconded by Councillor Willie Aird. The Members were advised that Laois County Council does not have any lands available for the provision of horse trails. However, horse trails are provided in some of Coillte's lands and there is a requirement to obtain a permit before permission is allowed. The Members should note that a submission on this topic was made to the Draft Portarlington Strategy 2030 by Ms Johanna Krois, Three Counties Hacking Club, an Equestrian Club in Portarlington. She indicated that there is an incredible demand for designated horse trekking areas and that they are currently hoping to engage with the Local Development Group to recognise this. She further indicated that Portarlington had vast areas of wood and bog land available to develop into a tranquil and diverse trekking route that will encourage social horse trekking for young and old but also endurance riding and orienteering if developed the right way. She added that it could further future establishments of equestrian centres, horse for hire to add to Portarlington's tourism portfolio or therapy riding in the Midlands.

Notice of Motion No: 27/2021

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council carry out a comprehensive audit on all the pits and quarries in the County, to include all those on the register of quarries and all others which Laois

County Council have any knowledge of. This must include all Unauthorised Developments since the 261 process and any other that may have had been brought to the attention of Laois County Council"

This Notice of Motion received no seconder.

Notice of Motion No: 28/2021

Councillor Caroline Dwane Stanley proposed the following Notice of Motion:-

"That this Council contact the Minister for Health, Mr. Stephen Donnelly requesting him to address the absence of any dental care/treatment for medical card patients in County Laois"

This Notice of Motion was seconded by Councillor Aisling Moran. The Members were advised that a letter would issue to the Minister for Health in this regard and also to request negotiation with the dentists that have withdrawn from the scheme to have them re-instated.
