DISPOSAL OF SITE NO. 8 COMPRISING OF 0.10 HECTARES AT CASTLETOWN UNDER SECTION 183 OF THE LOCAL GOVERNMENT ACT, 2001

159. Laois County Council Indicative Capital Programme 2022 to 2024

The Members were circulated with the details of the Indicative Capital Programme for 2022-2024 totalling €145.87 million including the list of projects. Mr. Gerry Murphy briefed the Members on the various areas and responded to the queries raised.

160. Section 85 Agreement with Kildare County Council – Leinster Bridges Rehabilitation Contract 2022

The Members were circulated with details on the above and Mr. Simon Walton advised the Members that one bridge had been identified for rehabilitation works to be carried out which is located at the M7 Ballydavis Interchange. It is recommended that Laois County Council enter into a Section 85 Agreement with Kildare County Council whereby Kildare County Council will administer and oversee the development and implementation of a works contract enabling the completion of necessary repairs to the M7 Ballydavis Interchange Bridge, all part of the Leinster Bridges Rehabilitation Contract 2022.

On the proposition of Councillor Willie Aird seconded by Councillor John Joe Fennelly, the Members unanimously agreed to the Section 85 Agreement with Kildare County Council – Leinster Bridges Rehabilitation Contract 2022.

161. Draft Litter Management Plan 2022~2024
