(4) Notice of Motions

Notice of Motion No: 133/2022

Councillor Conor Bergin proposed the following Notice of Motion:-

"That Laois County Council install a flood prevention wall at residences at Moneymore, Borris-in-Ossory as a matter of urgency and apply to the Department of Transport for funding under the Climate Change adaptation and resilience works for same"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that the location in question is outside the Drainage District for which Laois County Council have statutory responsibility for. The Capital Projects Office will assist Municipal District Staff in assessing, developing and submitting an application (where appropriate) under the OPW Minor Works Scheme for measures to address the flood risk.

Councillor Conor Bergin proposed the following Notice of Motion:-

"That Laois County Council carry out urgent repairs and maintenance at Lackey Bridge, Ballaghmore and bridge at Rossbaun, Ballaghmore as a matter of urgency"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that a bridge inspection will be undertaken to confirm the condition of the structure. The Elected Member will be updated on the condition of the bridge following the inspection.

Councillor Conor Bergin proposed the following Notice of Motion:-

"ThatLaois County Council carry out repairs to the bridge wall at Cahir Cross, Borris-in-Ossory as soon as possible"

This Notice of Motion was seconded by Councillor John King. The Members were advised that a bridge inspection will be undertaken to confirm the condition of the structure. The Elected Member will be updated on the condition of the bridge following the inspection.

Notice of Motion No: 136/2022

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council as a matter of urgency and in light of the flash flooding on Friday, October 28th 2022 at Mountrath, Borris-in-Ossory & Donaghmore carry out immediate remedial works to prevent further flooding of residences, St. Fintan's Boys National School, Mountrath Health Centre, Mooney's Pub, Donaghmore and Laois County Council Municipal Offices"

This Notice of Motion was seconded by Councillor Conor Bergin. The Members were advised by Councillor Conor Bergin. The Members were advised that in relation to Mountrath - The CFRAM preliminary options for Mountrath have

previously been assessed as not meeting the threshold Benefit Cost Ratio (BCR) of 1:1 for schemes to achieve approval to advance to project level development and funding under the OPW Flood Risk Management Plans. Following continued representations by Elected Representatives and Laois County Council with regard to the flooding situation in Mountrath, the OPW committed to undertaking a Scheme Viability Review. Progress is this regard has been hampered based on workload and available staff resources to complete the required works. In the interim Laois County Council have undertaken 2 projects to reduce the frequency and increase resilience to flooding events, the removal of the cross member from the underside of Patricks Street Bridge and the overflow culvert to the rear of properties on Shannon Street. LCC will continue to Liaise and assist OPW where possible to ensure the completion of the SVR for Mountrath at the earliest opportunity. In relation to Donaghmore, Laois County Council Capital Projects Office will work with Municipal District staff to establish the cause of the flooding at this location and where appropriate develop and submit an application under the OPW Minor Works Scheme for funding.

Notice of Motion No: 137/2022

Councillor James Kelly proposed the following Notice of Motion:-

"That Laois County Council repair and make safe the footpaths on the junction of Shannon Street and Shannon Road, Mountrath"

"That this Council give an update on when meetings with consultants / planners and the people of Rathdowney will take place regarding the new town plan so that local people can have their voice on the future of their town"

This Notice of Motion was seconded by Councillor James Kelly. The Members were advised that the Town Centre First Plan initiative aims to create town centres that function as viable, vibrant and attractive locations for people to live, work and visit, while also functioning as the service, social, cultural and recreational hub for the local community. Towns such as Rathdowney are facing significant challenges and opportunities that require a coordinated and comprehensive response. The Town Centre First (TCF) Plan will facilitate that response so that Rathdowney can function as the sustainable and vibrant heart of the communities it serves, in ways that are adaptable and appropriate to 21st Century needs. The plan will be underpinned by a clear diagnosis of local strengths and challenges. It will be driven by the local community and businesses as part of a Town Team which will be supported by the Local Authority. To deliver on its objectives the plan will seek to access funding from the Urban Regeneration and Development Fund and the Rural Regeneration and Development Fund. It is proposed to meet with the Elected Members of Borris-in-Ossory/Mountmellick Municipal District and the Town Team on the 23rd November 2022 to appraise them of the specific nature of the project and the work carried out to date and to garner items of interest to be included in the Plan."

"That Laois County Council put measures in place to relieve flooding at Tinweir, Durrow on the N77 road"
