#### 189. PRESENTATION BY MS. MICHELLE DE FORGE, DIRECTOR, DUNAMAISE ARTS CENTRE ON THE WORK PROGRAMME OF THE DUNAMAISE ARTS CENTRE

Ms. Michelle de Forge, Director, Dunamaise Arts Centre delivered a very comprehensive presentation to the Members on the activities of the Dunamaise Arts Centre. The Members complimented Ms. De Forge on her commitment to the Dunamaise Arts Centre and thanked the Board & Committee also for their contribution.

#### 190. ADOPTION OF THE ELECTED MEMBERS IPAD POLICY

The Members were circulated with the Elected Members IPad Policy which applies to the Ipads that have been allocated to the Elected Members of Laois County Council. The policy outlines the responsibilities in the use of the Ipads by Laois County Council Elected members and also the responsibilities of staff and Elected Members in the management of the iPads. On the proposition of Councillor Paddy Bracken seconded by Councillor Mary Sweeney, the Members adopted the Elected Members iPad policy.

It was noted that the policy will be regularly monitored and reviewed periodically.

#### 191. HEALTHY LAOIS PLAN – FOR NOTING

The Members were circulated with a copy of the Healthy Laois Plan 2018 – 2020 and same was noted by the Members.

#### 192. LAOIS COUNTY COUNCIL MONTHLY MANAGEMENT REPORT FOR OCTOBER 2018

Mr. John Mulholland, Chief Executive briefed the meeting on this matter and the report for October was circulated. The report was unanimously agreed and noted. A number of queries were raised on the report and the Directors of Services responded to the various queries raised.

#### **193.** RATIFICATION OF CONFERENCES/ATTENDANCE AT TRAINING

The Members were circulated with the list of conferences/training for ratification and forthcoming conferences/training which was ratified on the proposal of Councillor James Kelly and seconded by Councillor Noel Tuohy.

The following items of correspondence were circulated to the Members which had been received since the last meeting of Laois County Council:-

The Members raised the issue regarding the Order of Malta and their accommodation requirements – it was agreed that Mr. Donal Brennan, Director of Services would follow up on this matter with a view to finding a resolution to the matter.

#### **195.** NOTICE OF MOTIONS

#### Notice of Motion No: 22/2018

Councillor Willie Aird proposed the following Notice of Motion:-

# "That this Council request an up to date position for the manning of the tourism office going forward, unlike what happened during July and August where the office wasn't staffed"

This Notice of Motion was seconded by Councillor Pauline Madigan. The Members were advised that Fáilte Ireland own the office and decided to withdraw their services some years ago. The office was subsequently leased from Fáilte Ireland by Laois County Council. The Tourist Office is now staffed through the **Tús – Community work placement initiative through the Laois Tourism Board**. Placements are for a maximum duration of 52 weeks, which means staff must be recruited each year. This year there was a delay in finalising that recruitment process which subsequently

caused the office to be closed for a short period. However, the County Council will be consulting with the Tourism Board as to ways to improve the service to Tourists visiting the town.

#### Notice of Motion No: 23/2018

Councillor William Aird proposed the following Notice of Motion:-

# *"Can this Council inform us as to what is the position regarding the provision of broadband in the County"*

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were given an update as follows:-

## <u>Eir – 300k rollout</u>

*Of the 300,000 homes to be connected by EIR nationally, Laois has approximately 5,833 of these to date 3,501 have been connected to high speed broadband* 

## <u> Virgin Media – Portarligton</u>

- The contractors KN and VN are actively constructing networks in a number of locations throughout the town (building the network in the locations Node 1 6).
- There are currently 6 Node (Street cabinets) locations throughout the town with each Node supplying 250 premises. It takes approx. 5 weeks from start of construction to live delivery of services to a premise.
- Node 2, 3 and part of 4 are now live. Remainder of 4 and 6 will be live by the end of October.
- License application due on Node 5 due to change of location on site.
- Node 7 11 will be applied for shortly and constructed under the next phase.

## <u>SIRO – PORTLAOISE</u>

• Siro continue to rollout services in Portlaoise town , working in Lyster sq areas at present.

#### Wi-Fi to Donaghmore Famine Museum.

- Currently liaising with **Dense Air** (Mobile Networks Enhanced and Extended) in relation to provision of Wi Fi in the Donaghmore Famine Museum as part of a pilot scheme they are undertaking.
- Donaghmore is 1 of only 3 pilot locations in the country been rollout by Dense Air. The other two are in Kilkenny and Dublin.
- Works on the ground will hopefully start within the next few weeks , as well as connecting the Museum there will also be connections to houses in the local surrounding area.

# WIFI4EU

- The WiFi4EU initiative promotes free access to Wi-Fi connectivity for citizens in public spaces including parks, squares, public buildings, libraries, health centers and museums in municipalities throughout Europe.
- The WiFi4EU initiative provides municipalities with the opportunity to apply for vouchers to the value EUR 15 000. The vouchers are to be used to install Wi-Fi equipment in public spaces within the municipality that are not already equipped with a free Wi-Fi hotspot.

• Laois County Council have applied for 4 vouchers, however we are unsure how many/if any we will be awarded.

## <u>CIGNAL – Clear signal everywhere</u>.

- Cignal acquired the Coillte telecoms business in 2015 supporting the requirements of all wireless operators in Ireland. They are now developing sites across the country which will improve the service of mobile users (blackspots).
- Currently in Laois there are 3 sites being developed :
- 1. Killenard indoor coverage improvements
- 2. Errill rail coverage
- 3. Garran N7 coverage
- \* There are a further 5 sites under review in Portlaoise , Stradbally, Ballylinan, Durrow and Mountmellick.
  - I am currently undertaking a mobile blackspot survey and results to date show the need for site in all of the areas mentioned above which would benefit from this project.
  - Eir have informed Cignal that Laois will be one of the first counties to be targeted for their rollout plan which is due to commence in the next three months. Eir were bought by new shareholders earlier this year. They have stated that their intention is to invest in the expansion of their mobile network. Cignal has been appointed as their partner to help deliver sites in areas where poor coverage exists today. Eir have been preparing their rollout plan over the past number of weeks and they informed us that Laois will be one of the first areas targeted for this rollout.

The benefits for County Laois are as follows:-

- 1. Eir intend to upgrade their existing mobile technology at all existing sites meaning the latest 4G technology will be deployed
- 2. The sites will be 5G ready which Cignal anticipate will be available next year under pilot projects
- 3. Cignal has 8 new sites which I have mentioned above and 3 existing sites at Portarlington, Shraduff Glebe and Sheffield wood which are progressing and if delivered as part of the eir rollout will provide a significant improvement across the county in relation to the mobile coverage footprint
- 4. Laois will be completed early in the new year

# <u>Free town Wi – Fi</u>.

- Ongoing liaising with several companies in relation to Free town Wi Fi. As Portlaoise and Portarlington are well served to date, this may be a solution for other towns such as Mountmellick Mountrath Stradbally Abbeyleix Durrow or Rathdowney.
- This initiative can fall under the WI FI4EU project as mentioned above.

#### Notice of Motion No: 24/2018

Councillor William Aird proposed the following Notice of Motion:-

"That this Council request the Minister for Housing, Planning & Local Government to increase HAP rent caps in County Laois to ensure Council tenants and HAP tenants are paying the same level of rent and avoid any requirement on HAP tenants to pay top up payments to landlords" This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised that a letter would issue to the Minister in this regard.

## Notice of Motion No: 25/2018

Councillor Mary Sweeney proposed the following Notice of Motion:-

"That Laois County Council give a progress report and possible timeframe for the commencement of works at the new library on Main Street, Portlaoise following the recent allocation of additional funds for same"

This Notice of Motion was seconded by Councillor John Joe Fennelly. The Members were advised that the Department of Community Rural Development published an announcement on the 12<sup>th</sup> of October indicating a further  $\epsilon$ 1.35m grant support to the new library in Portlaoise, raising the total grant funding to  $\epsilon$ 3m. This was welcome and timely news as the design team –led by MCOH Architects of Portlaoise- are currently finalising tender drawings and documents. The architects have confirmed that the final documentation for tender approval will be ready by the end of November; we will then seek approval from the Department to seek tender prices.

# Notice of Motion No: 26/2018

Councillor Mary Sweeney proposed the following Notice of Motion:

"That Laois County Council request the Minister for Education & Skills to provide a new school for the students and staff at Kolbe Special School Centre without further delay, as it is currently not fit for purpose for the Pupils and Staff"

This Notice of Motion was seconded by Councillor John Joe Fennelly

# Notice of Motion No: 28/2018

Councillor Noel Tuohy proposed the following Notice of Motion:-

"That this Council writes to the Minister for Education & Skills, supporting the call of the staff and the parents of the pupils of Kolbe house, to be part of a new building project on the site which has been selected for some years, and further that this council assist in any way it can to expedite this badly needed project for the most vulnerable children in our society"

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. It was agreed that a letter issue to Mr. Joe McHugh, Minister for Education & Skills as a matter of urgency in relation to this issue.

#### Notice of Motion No: 27/2018

Councillor Noel Tuohy proposed the following Notice of Motion:-

#### "That this Council extend the mattress amnesty for another month"

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. The Members were advised that Laois County Council applied for and was successful in obtaining a grant of €20,000 from the DCCAE this year to fund a mattress amnesty. The amnesty was rolled out in June/July at four locations across the county running for a week in both Portlaoise and Portarlington Civic amenity sites and for a day each in Rathdowney and Graiguecullen. The event was a great success and 827 mattresses were collected. We are optimistic that the amnesty will be funded again in 2019. Mattresses are accepted at Portlaoise Civic amenity site all year round but they do incur a charge which covers the cost of removing them from site and recycling.

This concluded the business of the meeting.
