# 157. NOTICE OF MOTIONS

### Notice of Motion No: 52/2019

Councillor Willie Aird proposed the following Notice of Motion:~

"That this Council give details of the percentage of monies that are collected by way of rent for Local Authority houses that is spent on housing maintenance"

This Motion was seconded by Councillor Tom Mulhall. The members were advised that iIt is estimated that 54% of the rental income for 2019 will be spent on the maintenance and improvement of local authority housing. A further 43% will be spent in the following areas:

- Social Worker
- Illegal parking of caravans
- Service Support
- Housing Assessment, Allocation and Transfer
- Rent and Tenant Purchase Administration
- Community Development Support
- Administration of Homeless Service
- Support to Housing Capital
- Housing Loans Administration
- Housing Grants
- HAP Programme

The remaining 3% will be used to partially fund:

- Estate Road Maintenance
- Public Lighting
- Bring Centres and Recycling
- Litter Warden Service
- Fire Brigade Service
- Water Quality
- Library Service
- Parks and Playgrounds
- Recreation and Amenity
- Arts
- Dog Warden Service
- Horse Control

A discussion ensued during which Mr. Michael Rainey, Director of Services responded to the various queries raised by the Members.

# Notice of Motion No: 53/2019

Councillor Mary Sweeney proposed the following Notice of Motion:~

"That this Council call on the Minister for Health, Mr. Simon Harris, T.D. & Minister Jim Daly, Minister of State at the Department of Health with special responsibility for mental health and older people to urgently address the reduced staffing levels in the Young Adult Mental Health services in Laois in particular the shortage of Occupational Therapists for children and young adults who are not being assessed due to the shortage of these key professionals"

This Notice of Motion was seconded by Councillor Aisling Moran. It was agreed that a letter issue to the Minister for Health in this regard.

# Notice of Motion No: 54/2019

Councillor Conor Bergin proposed the following Notice of Motion:

"That Laois County Council call on the Minister for Health, Simon Harris TD to address the serious issues regarding the lack of HSE dental services for children and orthodontic waiting lists in County Laois as a matter of urgency"

This Notice of Motion was seconded by Councillor Padraig Fleming. It was agreed that a letter issue to the Minister for Health & the H.S.E. in this regard.

## Notice of Motion No: 55/2019

Councillor Aisling Moran proposed the following Notice of Motion:

"That this Council prior to the granting a licence for Electric Picnic 2020 consider putting in place Health & Safety measures to ensure the health and wellbeing of those attending Ireland's largest festival bearing in mind the implication made by Melvin Benn that there would be a further increase in numbers for Electric Picnic 2020 ~ Electric Picnic 2020 needs to be a better and safer festival rather than just a bigger festival"

This Notice of Motion was seconded by Councillor Noel Tuohy. The Members were advised that Laois County Council has committed to work with the Festival organisers in the coming months to address Health and Safety concerns raised by Statutory Agencies and the public. This approach has been adopted irrespective of the overall numbers attending the event. The festival organisers are required to submit to Laois County Council an application for an Event Licence at least 13 weeks prior to such an event. It is a statutory requirement that an Event Management Plan, which includes health and safety measures, is submitted with this licence application. The engagement over the coming months with Festival Republic and Laois County Council and the feedback from Statutory Agencies and the public will inform the Event Management Plan for Electric Picnic 2020.

# Notice of Motion No: 56/2019

Councillor Aisling Moran proposed the following Notice of Motion:

"That this Council consider the planting of wild flowers along the motorways and primary routes in an effort to have a positive impact on the environment in Laois whilst improving the appearance for both residents and visitors to our lovely County"

This Notice of Motion was seconded by Councillor Tom Mulhall. The Members were advised that Transport Infrastructure Ireland retains full responsibility for the ongoing maintenance of the Motorway Network. Therefore the implementation of the Notice of Motion is not in the control of

Laois County Council insofar as the motorway network is concerned. It was requested that a letter issue to T.I.I. in this regard.

The ongoing development and imminent completion of the Portlaoise Southern Circular will include numerous elements of pollinator friendly planting, fully in keeping with the Notice of Motion. Suitable pollinator friendly, native planting supports the enhancement of public realm presentation, supports biodiversity and compliments the more formal, mown grass areas on the approaches to and within our towns. Insofar as resources allow and in co-operation with local residents' groups and Tidy Towns' associations there is considerable merit in seeking to realise the principles of the Motion.

## Notice of Motion No: 57/2019

Councillor Aisling Moran proposed the following Notice of Motion:

"That this Council actively review our policy in relation to Anti-Social Behaviour for housing provided by this Council and consider the introduction of penalties for repeated anti-social behaviour - anti-social behaviour should not be tolerated"

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. The Members were advised that the Laois County Council Anti-Social Behaviour Strategy was adopted by the Elected Members in October 2010. Estate Management staff in the Housing Department deal with all incidents in an effective and efficient manner. Laois County Council endeavours to use all necessary measures available under the current legislation to prevent and abate anti-social behaviour. This strategy could be considered for review at the next Housing SPC meeting.

A discussion ensued during which Mr. Michael Rainey, Director of Services responded to the various queries raised by the Members.

# Notice of Motion No: 58/2019

This concluded the business of the meeting.

Councillor Noel Tuohy proposed the following Notice of Motion:

"That Laois County Council call on the Minister for Health to direct the HSE to immediately stop the practice of removing Medical Cards from those with acute life threatening long term illnesses and also the policy of revoking medical cards due to technical errors as they have done to over 200,000 medical card holders"

This Notice of Motion was seconded by Councillor Aisling Moran. The Members were advised that a letter would issue to the Minister for Health in this regard.
