Chairman Cllr. Paschal McEvoy opened the meeting and welcomed new members.

- 1. Confirmation of Minutes of LCDC meeting held on 22nd July 2020.

 The minutes were adopted following a proposal from Mr. Joe Thompson which was seconded by Ms. Mary White.

4. LCDC Membership

(A) Cllr. Paschal McEvoy, Chairperson, welcomed new members of the LCDC as follows:

New members were ratified by Elected Members on 31st August at the LA monthly meeting. Members were also ratified by LCDC members being *proposed by Cllr. John King and seconded by Mr. Robbie Quinn.*

(B) Election of Vice Chairperson

Cllr. Paschal McEvoy invited members to nominate a member to the position of Vice Chairperson. The Vice Chairperson will be appointed for a maximum period of 3 years, in order to allow rotation of members. A member may not serve two consecutive terms as Vice Chairperson. *Ms. Mary White proposed Mr. Joe Thompson, which was seconded by Cllr. John King.* Mr. Joe Thompson acknowledged the nomination and accepted the position of Vice Chairperson.

5. SICAP

(A) Mid Year Check

Mr. Donal Brennan, Chief Officer, noted that members of the SICAP sub-committee met on 9th September with the Local Development Company (Laois Partnership) to review the Mid Year Check in order to approve the Mid Year Check in line with Pobal timelines.

Feedback from Meeting:

It was noted the manner in which the IP responded positively to a change in circumstances due to CODIV-19, coming up with innovative ideas and working in partnership with other agencies. The strength of partnership working/interagency work throughout the county with the LDC adapting to meet needs of those in need.

Concerns were noted in relation to under spend in the areas of training and this would be as a direct result to COVID restrictions. It was noted that the LDC have already flagged this concern with Pobal in the Mid Year Update and we would have a greater insight into budget spend in October and the possibility to carry over any under spend to 2021 as per previous years.

The Sub Committee discussed in general the challenges faced by the LDC, but at present have no concerns that need to be flagged with the LCDC, LDC or Pobal. The LCDC will continue their engagement with the LDC and keep the current under spend under review.

(B) SICAP Mid Year VAT Payment

Mr. Donal Brennan, Chief Officer, sought approval of the SICAP VAT payment to the Implementing Partner, Laois Partnership for period 1st January -30th June 2020 in the amount of €2,265.91. This amount was identified as part of the Mid Year Check. *This was proposed by Cllr. John King and seconded by Cllr. Paschal McEvoy*.

(C) SICAP Sub Committee

Mr. Donal Brennan, Chief Officer, invited members to nominate a member to the SICAP sub-committee. *Cllr. Paschal McEvoy proposed Mr. Clive Davis which was seconded by Mr. Joe Thompson*. Mr. Clive Davis acknowledged the nomination and accepted the position on the SICAP sub-committee.

(D) SICAP Case Study

Mr. Donal Brennan, Chief Officer, informed members that the Implementing Partner, Laois Partnership are required to submit a Case Study, the purpose of which is a research methodology that provides a comprehensive picture or story of individuals, groups, projects, organisations or events. It provides qualitative information and context about a particular project, way of working, or individual client/group story

Ms. Catherine Cowap, A/CEO Laois Partnership Company, advised members the 2020 Case Study will be based on the Hope for Laois Project. This project was operated during COVID with three projects workers assigned giving time and support, with fantastic outcomes.

Deadline for submission - 4th October 2020.

(E) ESF Financial Claim Process

Mr. Donal Brennan, Chief Officer, referred to correspondence received from the Dept. of Rural and Community Development on Friday 18th September titled SICAP ESF Financial Claims Process. Mr. Brennan noted that a request has issued to Laois Partnership to complete relevant data sheets and upload audit trail documents by Friday 2nd October. The LCDC will be required to make a financial declaration in respect to SICAP for 2018 and 2019 by Friday 9th October. It was noted that correspondence was received too late in order to include as an Agenda Item.

6. Healthy Ireland

(A) Healthy Ireland Co-ordinator

Mr. Donal Brennan, Chief Officer, advised members that Ms. Julie Scully has been appointed effective from 27th August as Healthy Ireland Co-ordinator

(B) Community Mental Health Fund

Mr. Donal Brennan, Chief Officer, drew member's attention to the proposed CMHF (Community Mental Health Fund) of €30,000 which has been secured from the Dept of Health (Mental Health Unit) under the Healthy Ireland Fund 2019-2021. The purpose of the fund is to deliver a small grant scheme for local community, voluntary and sporting organisations to support them in the delivery of initiatives which will address "mental health" priority themes contained within Healthy Ireland, a Framework for Improved Health and Wellbeing 2013-2015.

Mr. Joe Thomspon enquired if applicants are required to be a member of Laois Public Participation Network in order to make an application. Mr. Donal Brennan, Chief Officer noted that the proposed application stated "Applicants must be a member of Laois PPN or undertake to join Laois PPN if the application is successful". Therefore, at the time of application applicants are not required to be a member of the PPN.

Mr. Donal Brennan, Chief Officer sought approval from member to proceed with the fund as outlined. This matter was proposed by Ms. Mary White and seconded by Cllr. John King.

(C) Healthy Ireland Sub-Committee

Mr. Donal Brennan, Chief Officer, invited members to nominate a member to the Healthy Ireland sub-committee. Cllr. John King voluntary put himself forward for the position. This was proposed by Joe Thompson and seconded by Cllr. Paschal McEvoy.

(D) Healthy Ireland Fund Addendum

Mr. Donal Brennan, Chief Officer, noted correspondence received from Pobal on the 8th September titled URN 73040C_1 Laois County Council HIF 3 Addendum, which was required to be signed and returned to Pobal by Tuesday 22nd September. The addendum noted small changes in the Healthy Ireland fund which arose mainly due to COVID, copies of which were furnished to members as part of their meeting pack. Both Cllr. Paschal McEvoy, Chairperson and Mr. Donal Brennan, Chief Officer signed the document, and now require same to be proposed and seconded retrospectively. *Proposed Ms. Mary White and seconded Cllr. John King.*
