Notice of Motion No: 51/2023

Councillor Conor Bergin proposed the following Notice of Motion:

"That Laois County Council call on the Minister for Environment, Climate and Communications & Transport, Mr. Eamon Ryan T.D to extend the Local Hackney Pilot scheme to rural areas across County Laois as a matter of priority"

This Notice of Motion was seconded by Councillor Seamus McDonald. The Members were advised that correspondence would issue to Minister Eamon Ryan in this regard.

Notice of Motion No: 52/2023

Councillor Thomasina Connell proposed the following Notice of Motion:-

"That Laois County Council prepare a report on the implications and plans for dealing with trees affected by Ash dieback disease in public areas"

This Notice of Motion was seconded by Councillor Willie Aird. The Members were advised that Ash Dieback in public (urban) areas is not a significant issue in County Laois, arising from the fact that the common Ash Tree has never been grown in urban areas. The Ash Tree is considered a more rural-type tree. If, however, an issue is identified in public parks or a housing estate etc., it

will be dealt with appropriately and the Council's Landscape Architect is available to advise and support any specific, identified, areas of concern regarding Ash Dieback.

Notice of Motion No: 53/2023

Councillor Thomasina Connell proposed the following Notice of Motion:-

"That Laois County Council consider the significant social and economic value of Social Enterprises for communities across County Laois and that Social Enterprises have dedicated support and assistance when required from a designated senior Council Official"

This Notice of Motion was seconded by Councillor Willie Aird. The Members were advised that Social Enterprises are being increasingly recognised as an effective means for delivering community, social and economic development through innovative, integrated, and cooperative methods and operations. They are of great importance to Laois and to local communities as they typically bring about economic benefits such as job creation (often for those who are marginalised); community benefits such as social inclusion or education; and policy benefits such as service delivery or active citizenship. For anyone interested in starting a social enterprise, supports are available from many different organisations such as Local Authorities, Local Enterprise Offices, Local Development Companies / Partnerships etc. The Local Enterprise Office will continue to advise/support anyone looking at setting up a social enterprise in the County. In addition the Community Development Department will continue to offer support through its various grant schemes and through its administrative support to the LCDC which has overseen the LEADER programme in Laois. A number of Social Enterprises have been supported through the Town and Village Renewal programmes ranging, for example, from Ballinakill Swimming Pool to Bloom HQ and Killeshin Community Centre.

accomodation. Laois County Council have a suitable site acquired however to advance this project we are currently in discussion with both LDAS and the Dept of Housing in relation to the funding and methodology for project management of the build and operation. We will brief the elected members once we have finality on this issue.

"That Laois County Council call on the Minister for Environment, Climate and Communications & Transport, Mr. Eamon Ryan T.D to urgently enact long overdue legislation to regulate and improve the safer use of electric scooters"

"That Laois County Council please clarify the announcement that Mr. Darragh O' Brien, T.D. Minister for Housing, Local Government and Heritage recently made in relation to the grants that are now available for septic tanks and when will the application process commence"

The Members were advised that the recent Ministerial announcement provided that, effective from the 1st January 2024, the maximum grant will increase to $\epsilon_{12,000}$ (from ϵ_{5000}) and the requirement that the grant only apply to pre-January 2013-registered septic tanks is

removed. There are other, current, eligibility criteria that limit the number of septic tanks to which the grant applies. The Minister's announcement is silent in respect of these eligibility criteria. A Circular is to be provided by the Department, prior to 1st January 2024, to advise all eligibility criteria for the grant from that date forward.

Notice of Motion No: 60/2023

Councillor Aisling Moran proposed the following Notice of Motion:-

"That this Council call on the Minister for Environment, Climate and Communications & Transport, Mr. Eamon Ryan T.D to put into law a new set back distance from residential dwellings. This is to ensure that quarries will not get planning permission within a certain distance of homes as is the case in other European Countries"
