37. NOTICE OF MOTIONS

Notice of Motion No: 08/2023

Councillor Aisling Moran proposed the following Notice of Motion:-

"That Laois County Council write to both the Assistant Secretary General with responsibility for Disability and the Secretary General in Department of Children Equality Disability Integration and Youth to enact/expedite the implementation of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD). This International Convention was ratified by the Houses of the Oireachtas in March 2018 and has only been partially implemented to date"

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. The Members were advised that correspondence would issue to the Department of Children, Equality, Disability, Integration and Youth in this regard.

Notice of Motion No: 09/2023

Councillor Aisling Moran proposed the following Notice of Motion:-

"That this Council please explain why the Graiguecullen-Portarlington Municipal District, with 33% of the population of Laois only received \notin 76,000 which is 2.3% of the funds allocated to the County of Laois out of a \notin 3.3m budget. I would also like a list of all monies allocated to Portlaoise in Low Carbon funding, a breakdown of all projects in the Portlaoise area that has a low carbon focus. I require project name, commencement date and projected budget, final budget post & exante appraisals, monies received and paid out, a map showing the location, the position and overall project area. This can be in an annual form. I require a complete breakdown of all projected & anticipated Low Carbon projects for the town of Portlaoise and for absolute completeness and clarity, I require the same done for each of the 3 MD's. I'm asking for this in the interest of absolute transparency" This Notice of Motion was seconded by Councillor Padraig Fleming. The Members were advised that the process of seeking 2023 NTA Active Travel funding commenced in October 2022. Laois County Council has secured €3.3m in Active travel funding which is a very welcome investment in Active Travel measures across County Laois.

In the two years prior to 2023, many longed-for footpath schemes throughout County Laois have been funded by the NTA through the Active Travel fund. For 2023, the NTA outlined that, in keeping with the Government's Climate Action Plan, the focus of the 2023 fund, was to be on '*key projects in the main urban areas*.' Laois County Council made two funding submissions to the NTA towards the end of 2022. The funding allocation provided was ultimately decided by NTA.

Regarding the second part of the Motion, Portlaoise – Low Carbon Town funding derives from the Urban Regeneration and Development Fund. Under URDF Round 1, Laois County Council was allocated €2.026m (a 75% grant) for the following Portlaoise-based Low Carbon Town projects;

- Triogue Bluway (€487,500)
- Cycle Routes (€337,500)
- Solar Compactor Bins (€54,450)
- Public Lighting Retrofit to LED (€996,923)
- E-Charging Points (€131,250)
- Summerhill Park and Stride (€18,750)

Portlaoise is the only qualifying town in County Laois (based on population) for Urban Regeneration and Development Funding.

Notice of Motion No: 10/2023 - Councillor Willie Aird

"That Laois County Council liaise with insurance companies regarding the timeframe for securing mortgage protection"

Notice of Motion No: 11/2023 – Councillor Willie Aird

"That Laois County Council confirm what roads and laneways can be included for improvement under the additional €12.5 million announced recently"

Due to the absence of Councillor Willie Aird at the time of the discussion for the Notice of Motions, it was requested by Councillor Aird that the two Notice of Motions be deferred to the March Meeting for consideration:-

Notice of Motion No: 12/2023

Councillor Thomasina Connell proposed the following Notice of Motion:-

"That Laois County Council write to the Minister of Environment, Climate Change & Communications, Mr. Eamon Ryan, T.D., to seek an increase in the current grant provided for the replacement or upgrade of all septic tanks.

This Notice of Motion was seconded by Councillor Catherine Fitzgerald. It was agreed that correspondence would issue to the Minister of Environment, Climate Change & Communications in this regard. The Members noted that the maximum grant available

 $(\in 5000)$ now falls some way short of the current average costs for domestic waste water treatment system remediation/upgrade works. The Members also requested that consideration be given to extending the grant scheme to include Sports Clubs and other Community-based organisations.

Notice of Motion No: 13/2023

Councillor Thomasina Connell proposed the following Notice of Motion:-

"That this Council implement Choice Based Letting with regard to the operation of the allocation of our social housing units."

This Notice of Motion was seconded by Councillor Caroline Dwane Stanley. The Members were advised that Choice Based Letting is a different approach to allocations, whereby applicants can make bids for social housing properties advertised by the local authority, and the applicant with the highest priority under the Scheme of Letting Priorities is allocated the property. From both a policy and operational perspective, there are considerations to be made regarding the introduction of a Choice Based Lettings policy and system, and its suitability as an all-encompassing system of allocation, or just for particular properties.

As part of the Housing, Planning and Regeneration SPC Work Programme for 2023, it intended to review the Laois County Council Scheme of Letting Priorities and to recommend an updated scheme for adoption by full Council later this year. As part of this review, a Choice Based Letting policy and system will be discussed and an issues paper will be presented to the SPC in due course in this regard.
