"That this Council support the call by the Dyslexia Association of Ireland to the State Examinations Commission to allow extra time to students with dyslexia who are sitting exams in the Junior and Leaving Certificates next month"

Notice of Motion No: 26/2023

Councillor Caroline Dwane Stanley proposed the following Notice of Motion:-

"That this Council ensure that the proposed new Civil Defence building is refurbished and that the works commence as soon as it comes into Council ownership"

This Notice of Motion was seconded by Councillor Marie Tuohy. The Members were advised that Laois County Council has agreed terms by which the Council will purchase a property in Kea Lew, to be refurbished and used as the Laois Civil Defence Headquarters. Surveys are currently being conducted with a view to arriving at the most appropriate and efficient layout of the premises, to meet the ongoing and future needs of Laois Civil Defence.

Notice of Motion No: 27/2023

Councillor Barry Walsh proposed the following Notice of Motion:-

"That Laois County Council write to the Minister for Housing, Local Government and Heritage concerning the Residential Zoned Land Tax (RZLT) with a view to a clause being applied to the relevant Act that temporary exemption from taxation of lands within defined zones be applied where owners are actively trying to sell or develop the zoned areas. Encouraging engagement rather than penalising it would yield a more positive outcome. In addition, if lands are clearly actively used for agricultural purposes an exemption should be applied"

This Notice of Motion was seconded by Councillor P.J. Kelly. The Members were advised that a letter would issue to the Department in this regard.

Notice of Motion No: 28/2023

Councillor John Joe Fennelly proposed the following Notice of Motion:-

"That Laois County Council write to the Department of Housing, Local Government and Heritage requesting that the requirement for those voters seeking a postal vote due to illness or disability to have their application form certified by a medical practitioner be replaced with an alternative means of approval which will not incur a fee"

This Notice of Motion was seconded by Councillor Willie Aird. It was agreed that a letter would issue to the Department in this regard. It was further agreed that the correspondence also be forwarded to the Oireacthas Members for Laois.

Notice of Motion No: 29/2023

Councillor Thomasina Connell & Councillor Conor Bergin proposed the following Notice of Motion:-

"That Laois County Council introduce a reusable nappy initiative to encourage the use of cloth nappies, in line with other local authorities"

This Notice of Motion was seconded by Councillor Barry Walsh. The Members were advised that the Cloth Nappy Incentive Scheme is operated and administered by VOICE Ireland. To date, the Scheme has operated as a pilot, funded by the Environmental Protection Agency together with a number of local authorities, including Fingal County Council, Dublin City Council, Dún Laoghaire-Rathdown County Council, Limerick City and County Council and Kerry County Council. The Scheme aims to support the use of reusable nappies among families who could not otherwise have considered trying them owing to the upfront costs in buying the nappies. Currently, costs involved in participating in the Scheme vary from €3500 per annum, for 20 families supported, to €9000 per annum, for 75 families supported. To be eligible for the scheme a family must be in permanent residence in a participating local authority administrative area. At this point in time, Laois County Council is not a participating Local Authority.

Notice of Motion No: 30/2023

Councillor P. J. Kelly proposed the following Notice of Motion:-

"That Laois County Council contact the Department of Education and Minister Norma Foley to make funds available to help supplement the high costs rural primary schools face in trying to provide transport to offsite activities such as swimming lessons, Cuman na mBunscoile matches, educational field trips etc."

This Notice of Motion was seconded by Councillor Marie Tuohy. It was agreed that a letter issue to the Department of Education in this regard.

Notice of Motion No: 31/2023

Councillor Thomasina Connell proposed the following Notice of Motion:-

"That Laois County Council calls on the Minister of State at the Department of Enterprise, Trade and Employment, Mr. Neale Richmond T.D., to urgently engage with our large supermarket retailers specifically with regard to the rising cost of Infant Formula Milk"

This Notice of Motion was seconded by Councillor P.J. Kelly. The Members were advised that a letter will issue to the Minister of State at the Department of Enterprise, Trade & Employment in this regard.
