Local Government Payroll and Superannuation Shared Services Centre

- There are currently 85 employees based in the MyPay shared services centre.
- Waves 1, 2, 3, 4 and 5 were completed on schedule with Longford, Roscommon, Westmeath, Leitrim, Laois, Offaly, Galway, Carlow, Monaghan, Cavan, Kildare, Meath, Kilkenny, Louth, South Dublin, Tipperary, Kerry, Wicklow, Mayo, Donegal, Sligo, Fingal, Dun Laoghaire/Rathdown, Clare County Councils, Limerick, Wexford and Waterford City & County Councils and Galway and Cork City Councils now live in MyPay.
- The LGMA and the East & Midlands Regional Assembly are also being paid from MyPay.
- The implementation of Cork County Council is now commencing and is expected to be complete in 2022.

Local Authority Home Loan Scheme (LAHL)

The Local Authority Home Loan (LAHL) Scheme is available nationwide and <u>replaces</u> the Rebuilding Ireland Home Loan scheme, from 4th January 2022.

Similar to the Rebuilding Ireland Home Loan, applications will be for purchase of new or second-hand residential properties and for self-builds. It also includes purchase of homes through State schemes such as the Tenant Purchase Scheme and Affordable Housing Schemes, with the exception of the First Home Scheme, which will not be operated by local authorities.

One of the main differences is that a 'Fresh Start' principle also applies to the Local Authority Home Loans scheme, i.e., applicants divorced/separated and have no financial interest in the family home are eligible to apply. People who have undergone personal insolvency/bankruptcy proceedings will also be eligible to apply for the LAHL Scheme.

HOUSING DELIVERY ACTION PLAN

PROTECTED STRUCTURE – MILLBROOK HOUSE

Millbrook House .. A Protected Structure

Laois County Council took ownership of Millbrook House, Abbeyleix, a protected structure, in 2021 following the confirmation of a Compulsory Purchase Order by An Bord Pleanala in May 2020.

The Council, via an agent, held a bid competition in 2021 on foot of which the most advantageous bidder was slected. The crieria for the award of the bid included price offer, timeline for completion of restoration works on the building and a statement of resources available to the bidder to complete the works in a diligent and expedient manner.

The panels below show the current condition of the endangered structure and a representation of what it may look like following refurbishment. Members will consider the disposal under Section 183 of the Local Government Act at its January 2022 monthly meeting.





HERITAGE

1. MRTTT Just Transition Project Conservation and Pollination

Communications: Film company Crannog Media has been appointed to record the project. Site meeting to be held this month.

Works: Work on the conservation plans is ongoing and they are due for publication in January. Grass cutting was carried out in Offaly, and ivy trimming will be carried out at Clopook and two Offaly sites before end Feb.

Specifications will be prepared for masonry conservation as soon as Conservation Plans are approved and we hope to go to tender for three sites this year.

2. Laois Heritage Plan Projects

Heritage Council funded projects for 2021 were completed successfully and all funds recouped. An application for 2022 funding is available from the Heritage Council (an increase of ϵ 6,000 on 2021).

3. National Biodiversity Action Plan

Wetland Survey Phase I desk survey is complete by Wetland Surveys Ireland and draft report has been submitted. Work on Phase II Field Survey will commence shortly. Total 2022 budget €27,000, grant aid €22,950.

The "In your Nature" Podcast in partnership with BirdWatch Ireland will be supported again in 2022. Total 2022 budget €5,000, grant aid.

4. Conservation of Churches and Graveyards in 2022

There are two churches on the list for conservation in 2022: Ballylinan and Clonkeen. The Heritage Officer plans to commission a design teams to carry out condition reports and specifications for these sites this year, with a view to applying to the Community Monuments Fund for funding.

A site management plan to benefit pollinators of the **Ridge Graveyard** is being prepared by an Ecologist. Woodfield landscaping will be carrying out landscaping work including removal of vegetation. This work will be done in January. A plan for future management (and a budget) will need to be agreed with the MD.

5. Community Monuments Fund

Community Monuments Fund for conservation of **archaeological** sites is open for applications, public closing date **17th February 2022** to Laois County Council.

6. Creative Ireland

6.1. Heritage and Landscape Training "Know your Locality"

Online training course in local heritage (with Creative Ireland funding) will be held again in early 2022, details to be finalised.

6.2. Laois Festival of flight

Plan to submit funding request to Creative Ireland for part funding of the Laois Festival of Flight.

7. Community Action Projects

Heritage Council Community Heritage Grants have been advertised with closing date set at 16th February. Full details at <u>https://www.heritagecouncil.ie/funding/community-heritage-grant-scheme-2022</u>.

8. Town and Village Renewal and Regeneration Projects

8.1. Timahoe TVRS

Lotts Architecture are working on specifications and hope to get final approval and go to tender for works by Feb. Works due to be complete by June 2022.

8.2. Stradbally TVRS

Design team for Stradbally Bridge element of the TVRS has been appointed. Meetings have been held with the community on other elements of the project and discussions with Community Section are ongoing.

9. Commemorations

Decade of Centenaries

The Heritage Officer continues to work with the County Librarian on the Decade of Commemorations, including plans for commemoration of the centenary of the Air Corps and Col Fitzmaurice in 2022.

10. Conservation Grants

Applications for the **Built Heritage Investment Scheme** and **Historic Structures Fund** for 2022 have opened already and details are on the Laois.ie website, closing date **31st January** 2022.

BROADBAND

1. National Broadband Ireland (NBI)

Section 254 Licences have been applied for in the Eastern Municipal Area to provide pole network for rollout. NBI are currently working on the Programme of works for rollout in the county. NBI are engaging with LCC in relation to above and in relation to hedge cutting.

2. WIFI 4 EU.

WiFi4EU is a project developed by the European Union that intends to bring free WiFi to local communities.

The aim of WiFi4EU initiative is to bring high-quality WiFi access to places where it is not yet available but would provide value for the community and visitors to the County.

The rollout of the provision of WIFI infrastructure in public places has commenced (equipment, installation and maintenance and support) in the following locations : Portlaoise, Portarlington, Abbeyleix, Mountmellick as follows :

- Fit out is currently under way in Portarlington and Portlaoise in various building along the Main Street and the Link Road;
- Consultation is under way with property owners in Abbeyleix .
- Survey and Consultation to commence on Mountmellick.

This project is being delivered by "Network and Infrastructure Support Ltd." On behalf of Laois County Council. The Broadband Officer is available for any queries in relation to this project.

3. Broadband Connection Points (BCP's)

As part of the roll out of the National Broadband Plan, Laois County Council launched **Broadband Connection Points (BCPs)** in 4 areas in rural Laois.

- 1. Vicarstown Community Centre
- 2. Emo "Old School" Community Centre
- 3. Oisin House Rossmore, Killeshin
- 4. Donaghmore workhouse and Agricultural Museum

An additional two have been added with Shanganamore Community Centre Barrowhouse live in January 2022, and Ballyroan Community Centre going live by end of Q2 2022.

Under the TVRS in 2021, these Broadband Connection Points (or BCPs) were supported by the Dept of Rural Development with additional furniture, safety equipment etc to ensure the locations were compliant with Public Health Guidelines and available for the general public to use.

These are public locations which have been selected to receive high-speed connectivity in the first year of the National Broadband Plan and are available to work or study within. These are part of the Connected Communities initiative.

Portlaoise Innovation Centre (The Cube)

- The Cube has recruited a number of key partners that allow for the delivery of world class training, education and knowledge dissemination. These include Trinity College, Chris Mee Group, EIT Climate KIC, Global Strategic Sustainable Leadership PVT, Irish Institute of Training and Development and The Irish Times Training Group
- A core finding in our initial outreach was that businesses needed more than education on Low Carbon; they, also, needed the tools and capability to act on this knowledge. The centre has on-boarded best in class consultants to assist midlands business. These include SEAI, Carbon Action, The International Energy Research Centre, Tyndall- UCC, Trinity Tangent, Walton Institute WIT, Community Power, Irish Bio Economy Foundation, and 3CEA among others.
- The Cube has developed considerable capability in the advisory/development of innovation in the area of sustainability for both SMEs and Start-up organisations. To date, this includes early-stage start-up and Ideation through DBIC and EI partner accelerators and workshops. The Cube offers a "one stop shop" solution for integrated energy advice, capacity and auditing through its partnership with H2020 Speedier. The Cube has secured the Irish Licence for Innoloft which will allow midlands-based business access to an international eco system of customers and business development.
- Business funding: Provision of support in the confidential fundraising of projects from a network of investors and Debt solution providers. This capability extends from early-stage seed investment to larger capital requirements. Corporate funding partners include Baker Tilly, DBIC Ventures, BVP, HBAN and Bank of Ireland.
- The Cube can provide a turnkey Solar As a Service Energy System that can pay for itself. This solution can be tailored to a Pay As You Save Solar package to meet your individual needs.

Midlands Just Transition Fund.

Network of Co Working Facilities (MRTT81)

Members are advised that following funding approval by the Department of Rural and Community Development Mr Michael Newham, has been appointed to the role of Business Development Manager by Laois County Council on behalf of the four midland counties. Mr Newham's role is to promote and support the development and collaboration of the network of co working hubs , approx. 26, that have to date been established in the midlands area and to lead the development of remote working in the midlands region.

Digital Roadmap ... Destination Midlands (MRTT80)

Members are advised that Mr. Emmet Kavanagh has been appointed to the role of Communications Manager by Laois County Council on behalf of the four midland counties. Mr. Kavanagh's role is to promote and market the midlands region to a wide audience as a destination of choice in which to live, work and study.

RATE WAIVER: Quarter 1 of 2022

On the 14th December 2021, the Department of Housing, Local Government and Heritage confirmed a further rates waiver for the first quarter of 2022. This waiver applies to businesses in the hospitality, leisure, entertainment and tourism related sectors. It is estimated that the Waiver amount will be in the region of \leq 420,000. The waivers will be applied to accounts over the next few weeks.

National Transport Authority (NTA) Funded Projects

NTA funding allocation has been received for County Laois in the overall sum of €3million. Some of the Schemes are carried forward from 2021 and funded from previous NTA allocations. Additional funds, over and above 2021 allocations, include funds for dedicated resources now allocated towards oversight and delivery of NTA funded projects.

River Drainage Maintenance

Various, county-wide surveys are now ongoing to inform and underpin river drainage maintenance works later in 2022.

Environment & Environmental Protection

1. Kyletelesha Landfill, Transfer Station and Civic Amenity Site, Portlaoise:

Normal services continue at the Kyletelesha Landfill Facility. A Waste Licence Alteration application has been submitted to the EPA for the continued acceptance of C&D waste materials. Landfill monitoring and aftercare maintenance on-going.

2. <u>Portarlington Civic Amenity Site:</u>

This facility is operated and managed under contract with Bord Na Mona Recycling.

3. Historic Unregulated Waste Disposal Sites:

The Environmental Site Assessments for the 3 unregulated waste disposal sites (Aghanure, Killabban & Rathdowney Road, Durrow) are completed. The final grant claim forms are with the Department and payment of the claim will be made in January 2022. Further applications for funding from the Department are being prepared for other registered historic unregulated waste disposal sites.

4. Bring Banks:

A total of 1,877.09 tonnes of collected recyclable material was collected in 2021.

5. <u>Waste Enforcement & Litter Management</u>:

(a) Waste Enforcement

Laois County Council's Waste Management (Storage, Presentation & Segregation of Household & Commercial Waste) Bye Laws 2018 came into force on 1st November 2018. These Bye-Laws place obligations on waste producers in households and commercial premises regarding storage, presentation, segregation of waste, contamination prevention and demonstration of proof that their waste is disposed of by an approved waste operator or brought by the waste producer to an authorised waste facility. Door to door household waste inspections commenced in November 2018 and continued in 2019. The arrival of Covid 19 and lockdown restrictions periods, along with changes in staffing led to a slow down in inspections and enforcement. Two fixed penalty notices were issued in 2020. See table of enforcement / inspections to date.

Brown Bin Compliance

Under the EU Food Waste Regulations 2015, waste operators must provide and collect a food waste bin for all customers in agglomerations of over 500 people. The Regulations also places a duty on householders to segregate their food waste for collection. The Environment Section is in continuous communication with the authorised household waste collectors to promote and improve the roll out and operation of the brown bin service and Environment staff carry out household waste inspections around the county each year, issue advice letters and promote brown bins through various media channels.

a) **Protect the Water Quality Status in all Water Bodies:**

On site investigations of complaints in relation to water pollution are being carried out by Environmental staff in compliance with Health and Safety and Covid-19 control measures.

b) <u>Air & Noise:</u>



In conjunction with the EPA, an NO₂ (Nitrogen Dioxide) monitoring survey is being carried out in the towns of Abbeyleix, Durrow and Cullahill to quantify prevailing air quality. Diffusion tubes were erected at 20 locations across the region on the 6th July and will be monitored for six months. The EPA will issue a final report in late February/early March 2022.

Burning of Agricultural Waste

Circular WP02.21 from the DECC notified Local Authorities of an extension of the exemption provided for under the Waste Management (Prohibition of Waste Disposal By Burning) (Amendments) Regulations 2020 (S.I. No 738 of 2020) as amended, to all farmers, as a last resort, to dispose of waste generated by agricultural practices. Circular WP02.21 extended this exemption until 1st January 2022.

Please note that the Waste Enforcement Regional Lead Authorities (WERLA)WERLAs have been informed by The Department of the Environment, Climate and Communication (DECC) that this extension to the exemption does not extend beyond 1st January 2022 and will not be re-introduced. The DECC have informed us that The Department of Agriculture, Food and the Marine (DAFM) are evaluating alternative options for the farming sector and discussions are ongoing in this regard between DAFM and the Air Quality Unit in the DECC. The Dept. and WERLAS in turn will advise local authorities of any outcomes from those discussions. We will keep Members briefed on any further updates once to hand.

Emergency Planning, Fire Services & Flood Relief

In 2021 Laois County Fire & Rescue Service attended 616 emergency incidents consisting of 266 fires, 240 special service incidents & 110 false alarms.

Fire Services Capital Programme

Planning & design is continuing for the Mountmellick Fire Station upgrade, a, €150,000 project, which consists of a fire service drill tower & new concrete yard to the rear of the fire station. It has not been possible to obtain the services of an engineering consultant locally & therefore this appointment was advertised on E-Tenders. The tender process is now closed. 2 responses were received & following an assessment of the 2 responses, a Design Team has been appointed as consultants & PSDP for the upgrade work. Detailed design work is expected to commence in February 2022.

• In 2021 Elected Members were advised of an allocation of €140,000 for the acquisition of a new Water Tanker to support Fire Services operations in County Laois. The tanker chassis has been delivered to HPMP Fire, who are now in the process of building the body. Delays due to supply issues have resulted in the build being delayed and delivery has now been put back until Q1 2022.

Risk Based Management - Nearest Available Resource Project

• In accordance with the recently issued Circular Fire 01/2021, Laois County Council has established the Senior Project Group which has endorsed this project. The Working Technical Group has completed its work. New townland data sets have been completed & uploaded it to the STORM mobilising system in ERCC & has been tested operationally & the project is now live.

WATER SERVICES AND RURAL WATER

Public Water and Wastewater Capital

The following capital works have been approved by Irish Water:-

Durrow – Further progress was made in Durrow with the bringing into service of a borewell at Fermoyle WTP. Provision of a storage/blend tank and booster pump set also being discussed with Irish Water.

Portlaoise Water Supply Improvement Scheme - borewell PW09 at Coolbanagher has been developed and is currently on standby to be used as required. Irish Water now progressing with developing well PW07 and well PW08.

Disinfection/PH control programme – Civil works progressing in Derryguile, Kyle, Five Wells and Lough WTP. MEICA works progressed at Knocks, Derryguile, Lough and Ballyroan WTP. Site works are also in progress at Five Wells WTP with upgrade works progressing at Derrymoyle and Kilminchy WTP early in 2022.

Containerised unit program – UV containerised unit along with break tank installed on site at Aughfeerish WTP with the commissioning/testing/process proving completed. Disinfection upgrade works also completed.

Castletown WwTP-Inlet Works Storm and Sludge Programme: a new storm tank is to be installed on site by the end of 2022.

Networks and Water Conservation.

Water Network Improvement and upgrade works completed in Portlaoise, Portarlington and Mountmellick. First fix, find and fix and lead replacement works continue throughout the county. Significant progress in Portarlington in the area of leakage management. Ongoing projects in Portlaoise, Portarlington, Stradbally, Rathdowney, Durrow and Abbeyleix, including mains rehab and back yard services, funded by Irish Water funded via a Stimulus Package during 2021, have been completed.

Funding approved for replacement of 900m of watermain in the Swan network with works to start in February 2022.

Continue working with IW to take the 22 no. outstanding legacy estates in charge by IW - already taken in charge by LCC.

In 2021 €465,703.67 was processed in respect of subsidy payments to Group Water Schemes.

Well Grants –41 applications were received in 2021 with €174,189.93 paid.

Laboratory - In accordance with the EPA approved 2021 programmes, as an essential service Lab staff continued to conduct testing and sampling throughout 2021 in accordance with Covid-19 safe systems of work plans/risk assessments. The sample throughput increased from 3,529 in 2020 to 4,076 in 2021. During 2020-2021 there was a capital investment of € 157,000 in instrumentation. Work to maintain the existing customer base and seek and secure new business from neighbouring Local Authorities, LAWPRO and LCC's Environment Section in accordance with market opportunities is ongoing.

Corporate, Community, Climate Action, Arts, Culture, Libraries & Tourism

CORPORATE AFFAIRS

The 2022/2023 Register of Electors which comes into force on the 15th February will be published on the 1st February and will be distributed in the usual manner.

Plans are also underway by the Department of Housing, Local Government and Heritage for the modernisation of the Electoral Register. The modernisation includes the introduction of a rolling register and a centralised database from which the electoral register will continue to be managed by individual local authorities for their own area. The Electoral Reform Bill is at an advanced stage of drafting and is proposed to be published in 2022.

COMMUNITY

Laois Public Participation Network

At the end of 2021, 634 registered groups were registered with Laois PPN. Laois PPN welcomed 54 new member groups in 2021. Laois PPN held 3 Municipal District Plenaries and a second County Plenary online in December. All plenaries were well attended.

The PPN Annual Report for 2020 was circulated by DRCD in December. This report highlights the work and achievements of PPNs nationally. The integral role of Laois PPN to the Covid 19 response in Laois with the creation of the interactive map – which was utilised by the Communy Call Helpline – was highlighted in the report. Also highlighted in relation to Laois PPN was the hosting of our first ever Social Inclusion week.

Laois Community and Voluntary Awards

The 2021 Community and Voluntary awards received a staggering 52 applications across 8 award categories. This year will see the launch of a new COVID-19 Community Response Awards in association of Laois Volunteer Centre. As a result of on-going COVID-19 restrictions the awards were somewhat delayed and are expected to be broadcast on Facebook by the end of January 2022.

Laois Comhairle na nÓg

2 members of Laois Comhairle na nÓg took part in TedX in Dun Laoghaire on the 19th of November 2021. The National Executive of Comhairle na nÓg have worked with government to get a new travel card for 19 – 23 year olds to avail of 50% off public transport. Funding was made available for a Strategic Plan 2022-2024 which has been prepared

Age Friendly

The Age Friendly programme engaged a company called Wool in School to deliver an intergenerational project called Knit Stitch. Knit Stitch was rolled out to Laois nursing homes in December and will continue into January. Knit Stitch is a beautifully designed knitting kit using Irish wool to encourage the passing down of skills while strengthening generational connections. This initiative brings young and older people together. This intergenerational project is an inclusive project designed to give older people the

opportunity to be creative and get involved with grandchildren / schools . The knitting kit is provided for both the nursing home resident and the child. 40 knitting kits were distributed through 8 nursing homes in Laois and feedback has been very positive to date.

Community Activities Fund

This funding scheme was announced by the Department on 11th November 2021, with an allocation to Laois LCDC of $\epsilon_{273},048$. Application process closed on the 7th January with 118 applications received, seeking funding in excess of $\epsilon_{564,075}$. The CEP subcommittee will convene on the 7th February to appraise applications which will go forward to the February LCDC meeting for full approval.

Social Enterprise Capital Grant Scheme

Laois LCDC funded a further 4 projects amounting to €23,794 under the newly established Dormant Accounts Social Enterprise Capital Grant Scheme.

Disability Participation and Awareness Fund

Laois County Council were successful in their application for funding under the Disability Participation and Awareness Fund. €75,000 was granted under this fund for a suite of projects/initiatives including accessibility works at Portlaoise Leisure Centre, a sightless cinema initiative, social inclusion event delivered through Laois PPN and staff training.

Town and Village Revewal Scheme

All Town and Village Renewal Accelerated Measures project are now complete. In addition, TVRS projects at Durrow, Camross, Castletown and Ballinakill are now complete. We await announcement of the 2021 approved projects under this scheme.

Rural Regeneration Development Fund

Laois County Council were successful in their application under Category 2 of the Rural Regeneration Development Fund. $\epsilon_{212,000}$ has been granted for development of the renovation of Borris in Ossory Courthouse project to reach the stage of being shovel ready. This project involves the renovation and re-use of the historic courthouse building as a remote working and community facility.

Town Centre First Initiative

Laois County Council were successful in their application for funding under the Town Centre First Initiative Scheme. ϵ 100,000 has been awarded to Laois County Council to develop a masterplan for Rathdowney. The aim of the fund is to tackle dereliction and revitalise town centres.

CLIMATE ACTION

Sustainable Energy Communities

Portlaoise 2040 SEC and Durrow SEC have applied for Energy Master Plan to SEAI. Portarlington Business Association have received approval and are progressing to tender stage.

Climate Literacy Course

An 8 module Climate Literacy Course for Transition Year pupils has been rolled out in five Secondary Schools across the County. This action based learning course includes a teacher

training element to enable teachers to incorporate sustainability modules into mainstream subjects.

Midland Energy Agency

Roscommon County Council have joined the Midland Energy Agency.(MEA) The MEA now aligns with the Climate Action Regional Office Midlands Regional Group.

SPORT & LEISURE UPDATE

Leisure Centres

Works at Portlaoise Leisure Centre have progressed considerably (cost incurred to date by Laois County Council is €330,000) and the facility will open to the public by 28th February 2022. Tenders are being prepared for accessibility improvements at Portlaoise LC as a result of disability funding recently awarded to Laois County Council. The board of Portarlington Leisure Centre have agreed to rename the company to Laois Leisure CLG and an application for a change of name has been submitted to CRO's office. The board having advertised for directors from the greater Portlaoise area, have selected 3 new directors who join the board in January 2022. Training of the board will commence in February in addition to the development of Strategic/Business Plans and company policy documents

Playgrounds Developments

Ballinakill playground installation works are completed subject to post installation inspection. The site will remain closed for access until March 2022 to allow the site to settle and dry.

Annual maintenance works are continuing in all playgrounds.

Healthy Ireland – Creating Playful Spaces

The tender for a Landscape Architect has been awarded in Dec 2021, to work with 3 social housing areas to develop plans for their green spaces – Oak Glen-Stradbally, Bruach/Cois na hAbhann- Portlaoise and Old Forge Crescent - Mountrath. The consultation phase with residents has commenced with the assistance of Housing and Laois Partnership staff. The designs will be completed in March and assistance will be provided to the residents to access funding to realise their plans over a 1-3-year period.

ORIS 2020

The installation of play trail, amenity area and accessible fishing stands along the canal bank in Vicarstown by SVT Activity and Wellness Hub, funded under ORIS 2020 was completed in early January 2022 subject to final inspection. These amenities are a wonderful addition to the Barrow Blueway.

ARTS & CULTURE

Laois Arthouse & Gallery

On Dec 4th 2021, the Laois Arthouse launched its 10th anniversary celebrations with an exhibition 'In Trust. In Gratitude. In Hope - with 60 artists responding to a specially commissioned poem 'The Window Seat' by poet Pat Boran. A specially commissioned catalogue was also published and is now available for sale.

Arts Awards and Opportunities

Advertisements have been placed for 2022 Arts Act Grants, the Tyrone Guthrie Centre Bursary, Artists in Schools Scheme and expression of interest for Laois Culture Night 2022. Closing date 24th February 2022.

Local Live Performance Scheme Phase 2 completed in December 21st last and included a diverse range of live events in multiple outdoor and indoor settings across the County, enlivening community events, markets, and offering intimate concerts in our Arts Centres. Performing artists were encouraged to develop and perform work that was again recorded, giving the performers an important promotional tool to utilise when restrictions were eased once again. In addition to these events Music Generation Laois produced a fantastic programme of events throughout the county, including a major outdoor event to premier new music by Martin Tourish and the Music Generation Laois, Trad Orchestra.

Local Live Performance Phase 3

Laois County Council will participate in the third Phase of this scheme, with a further €143,000 available to support employment and wellbeing in the commercial arts and culture sectors to include musical society and pantomime projects, through the provision of live performances for the period up to June 2022. Advertisements and call outs have been circulated.

Creative Ireland Laois

Winners of the inaugural Cruinniú na nÓg 'Laois Series: Sense of Place' Art Competition were announced with the launch of the winning artworks as a series of A5 postcards at Dunamaise Arts Centre on Dec 15th 2021. The competition had five age categories up to 18 years, with one winner selected from each category.

On Jan 5th 2022 'Made in Laois' grant scheme recipient and poet Laura Murphy launched an online video poem 'In Laois I Fly Free' inspired by the history, mythology and beauty of Laois, filmed at the Rock of Dunamase, Slieve Bloom Mountains, Oughaval Woods and Portlaoise.
