- Vacancy Surveys

SERVICED SITES

Laois County Council is actively considering the development of serviced sites over the coming years at a number of locations in the county. In advance of finalising its plans, Laois County Council has opened a survey to establish the level of interest in serviced sites among prospective home buyers in the county and, in general, their preferred locations.

In the first instance, eligibility will be determined by criteria as set out under the Croí Conaithe (Towns) Fund – Ready to Build Scheme (Serviced Sites for New Homes) Scheme. Under the scheme, local authorities are supported to make serviced sites in towns and villages available to potential individual purchasers. These sites will be available at a discount on the market value of the site for the building of a property for occupation as the principal private residence of the purchaser. The level of discount to the individual will depend on the level of servicing cost incurred by the local authority before the sale of the site with discounts up to a maximum of ϵ 30,000. The amount of such discount will be reflected in the sale price of the site to the purchaser. The survey can be located on the links below:

NOTE A: Laois County Council has been approved Department Retrofitting funding for 47 units at a total cost of €1,299,987. Surveys of these properties (listed below) commenced in Q3 2022 and tenders advertised in Q1 2023.

- 1) Thornberry, Abbeyleix 16 units.
- 2) Church Avenue, Stradbally 9 units.
- 3) Slieve Bloom Park, Clonaslee 8 units.
- 4) St. John's Square, Portlaoise 7 units.
- 5) Old School Road, Ballylynan 7 units.

LCC has recently issued a tender for Energy Consultancy services for 2023 for a further 53 houses.

There will be a match funding requirement from the Council in the above regard, which will be determined when tender prices are returned.

NOTE B: The Housing Section are currently preparing their submission for the continued programme of retrofitting homes in 2023. We have been advised that funding will be made available for up to 65% of last year's programme and we have been provisionally approved funding with an average of €36,000/unit.

The following 53 units in the following estates are being considered in 2023:

- 1) St Brigids Place, Portlaoise 26 units.
- 2) Fr O'Connor Crescent, Mountrath 11 units.
- 3) Erkindale Drive, Durrow 6 units.
- 4) Rossmore View, Graiguecullen 10 units.

(NOTE: The above estates were prioritised based on property age and MD area.)

There will be a match funding requirement to complete all the retrofitting works which will depend on the tender prices returned. Once this proposal has been approved by the Dept, we will commence surveys of properties to inform the tender for works.

HUMANITARIAN RESPONSE TO REFUGEES FLEEING CONFLICT

Laois County Council continues to lead and coordinate the "Laois Ukrainian Community Response Forum". The Forum, consisting of 23 member groups/agencies, convened its 13th meeting on Wednesday 15th February 2023. All response efforts are supported, as required, by An Garda Síochána, Dept of Social Protection, the HSE, Civil Defence, the Laois Partnership Company, LOETB, TUSLA and various local voluntary groups, and community organisations.

Most recent data indicates there are 873 displaced Ukrainian citizens in County Laois. Approximately 310 of these are in accommodation centres such as hotels, guesthouses and hostels around the county, with the remainder in privately sourced or pledged accommodation.

Laois County Council continues to assist the International Protection Accommodation Service (IPAS - under the auspices of Department of Children, Equality, Disability, Integration and Youth, DCEDIY) with the temporary accommodation of Ukrainian arrivals to our county, as well as providing details nationally in relation to vacant buildings and sites suitable for medium to long term accommodation solutions.

A public engagement meeting was hosted by DCEDIY at Rathdowney Library on 9th February, in relation to the site in the town which has been deemed suitable for a 42 modular homes development. While some individual concerns were expressed there was an overall positive reaction to the project.

The Council continues to allocate privately pledged accommodation to Ukrainian families, both in shared settings with a host family, and in matching vacant properties offered under the 'Offer A Home' campaign which launched nationally last November. Almost 30 families have been provided with accommodation through these mechanisms to date.

In relation to the new Community Recognition Fund which was announced on 24th January 2023, the Community Department hosted a public information session for interested community groups at Dunamaise Theatre on 9th February last. The deadline for submission of Expressions of Interest to the Community Department is 24th February 2023.

PLANNING, DEVELOPMENT & HERITAGE

LOCAL AREA PLANS

Graiguecullen / Carlow Joint Urban Area Plan

The Draft Plan and associated SEA is currently being prepared. It is scheduled to go on public display in April 2023. The Draft Local Transport Plan is currently being prepared as well. The intention is that is that it two will go on public display in April 2023. A workshop for the Transport Plan was held on 25th January 2023. It was attended by AECOM consultants, elected members and officials from both local authorities. Various options were presented at the workshop.

Portlaoise LAP

Following pre-draft public consultation in November 2022-December 2023 a Chief Executives report on the issues raised is being prepared by the Forward Planning Team and will be circulated to the members of the Portlaoise MD in March.

Rathdowney Town Centre First Plan

A Town Team whose function is to deliver on the actions of the Town Centre First Plan has also been established. It comprises members of the local business and community sectors as well as elected members and council officials.

The first meeting of the Town Team is scheduled for 23rd February 2023. A draft version of the Town Centre First Plan will be made available by the end of February 2023 with the final version scheduled for completion by April 2023.

Aughnaharna Masterplan

A Steering Group has been established of stakeholders including Landowners and Council officials to prepare a Masterplan for lands at Aughnaharna from the southern circular road to Rathleague. The masterplan will look at transport links for the lands taking account of current land uses and proposed land uses.

Residential Zoned Land Tax

Laois County Council prepared a draft map of the land considered to be in scope for the RZLT as of October 1, 2022. The Planning Authority has sought further information in respect of three parcels of land based on submissions received during the public consultation stage. It has also written to Irish Water for clarification in respect of two submissions in which the landowners are alleging that Irish Water services are deficient, thereby preventing development proceeding.

An evaluation of the submissions, including a determination as to whether or not the subject lands shall be retained in scope for the purposes of the RZLT, is required to be made by the Planning Authority by not later than 1st April 2023.

A supplemental map will be published on 1 May 2023 identifying any additional land considered to be in scope as a result of a change of zoning, servicing or where the local authority becomes aware of the fact that land, which did not appear on the draft map, may meet the criteria for being in scope, such as where this has been identified during submissions

DEVELOPMENT MANAGEMENT PERFORMANCE

EPlanning has been live since 11th November 2022 and has resulted in a shift by agents in the way they submit applications to the Planning Authority. Community Action Projects

The Heritage Council is now accepting applications from community groups and not for profit non-governmental organisations around the country for its <u>Community Heritage Grant Scheme 2023</u>.

A total of €1.5m is available for this year's scheme. Applications are sought for projects aimed at improving access and inclusion to heritage sites, and that apply

good heritage practice to the management of places, collections, or objects (including buildings), with the maximum grant amount increased to €25,000 this year.

Funding is also available for groups who want to improve access to heritage for people with disabilities, as well as for projects which explore the heritage of minorities, including newly arrived immigrants, and the Traveller community.

The scheme also supports training events for traditional building skills, biodiversity, and archaeology, as well as the purchase of specialised equipment.

Conservation Grants

BROADBAND - DIGITAL PROJECTS

Broadband / Fibre Rollout.

(a) National Broadband Ireland (NBI)

Section 254 Licences have been applied for in all Municipal Area to provide pole network for rollout. NBI are currently working on the Programme of works for rollout in the county. NBI are engaging with LCC in relation to above and in relation to Civils subducting, blockages, OH caballing, tree trimming and chamber building.

NBI are rolling out fibre in all MD areas of the county at present.

(b) Siro - Fibre Rollout.

Engaging with Siro in relation to Fibre rollout in the town of Portarlington. This work is due to commence in March.

WIFI 4 EU.

WiFi4EU is a project developed by the European Union that intends to bring free WiFi to local communities.

The aim of WiFi4EU initiative is to bring high-quality WiFi access to places where it is not yet available but would provide value for the community and visitors to the County.

The rollout of the provision of WIFI infrastructure in public places has been completed (equipment, installation and maintenance and support) in the following location:

Portlaoise, Portarlington, Stradbally, Abbeyleix, Ballinakill, Ballyroan, Mountmellick, Mountrath, Camross and Borris in Ossory as follows:

- Portlaoise town is completed in the Top Square, Main Street, Fitzmorris Place, Lyster Square and the Plaza at Co. Hall.
- Portarlington town is completed on Main Street, part of the Peoples Park including the playing courts, the Swimming Pool Car Park, the Link Road area, the library both externally and internally.
- Stradbally is completed in Market Square, the Arthouse both internally and in the Courtyard.
- Abbeyleix is completed in the Market Square, part of the Main Street, the entrance to The Bog Walk, Fr. Byrne Park including the GAA grounds, Tennis Courts, Soccer Pitch and the Outdoor Gym area, Internal meeting room in the Complex and at the Parish Hall.
- Ballinakill is complete on the Main Square.
- Ballyroan is completed in the Old School.
- Mountmellick is completed in the Carpark of the MDA Complex, The Square, The CYMS Courtyard.
- Mountrath is completed in the Main Square.
- Camross is completed in Community Centre and Poets Cottage both internally and externally.
- Borris in Ossory is completed in the Community Centre both internally and externally.

This project was delivered by "Network and Infrastructure Support Ltd at a cost of €115,084.43." On behalf of Laois County Council, NIS were successfully granted €60,000 from the EU on this project.

LCC funded the remainder € 55,084.43 which was recouped from DRCD.

Signage will be located in all of the above areas over the next few weeks.

Portlaoise WIFI4EU project was launched in June '22, and it is proposed to launch all other locations in Q1 of this year as well as ongoing advertisement.

Broadband Connection Points (BCP's)

As part of the roll out of the National Broadband Plan, Laois County Council launched **Broadband Connection Points (BCPs)** in 6 areas in rural Laois.

- 1. Vicarstown Community Centre
- 2. Emo "Old School" Community Centre
- 3. Oisin House Rossmore, Killeshin
- 4. Donaghmore workhouse and Agricultural Museum
- 5. Shanganamore Community Centre Barrowhouse
- 6. Ballyroan Community Centre

New projects and available funding are being examined for the coming year. The Launch of all BCP's was deferred in 2022 and Minister Heather Humphreys is to reschedule her visit.

Vex Robotics.

Vex Robotics Programme has been secured for Laois schools.

We have rolled out in 2 schools to date. Scoil Eoin Phóil II Naofa Ballyroan and Shanganamore, Barrowhouse. Both schools have rolled it out to their 6th class student.

A workshop event has taken place in both school showing children how to build and operate Robots, with both schools putting in as much of their own time now to develop the project.

The students will build their own Robot and develop the game using the Scratch programme.

All the equipment for the board game and the Robot has been supplied by funding secured from DRCD.

It will be rolled out to 2 further schools in March and hopefully to more in the future.

Future Projects.

(a) Computer Science in Secondary schools.

Computer Science training for Secondary School teachers has commenced with 2 modules been offered in this school year to May 23 with 4 remaining modules to be rolled out in the school year Sept '23 to May '24. This will allow schools to offer Computer Science to Leaving Cert students in the future.

3 Laois schools have signed up to the 1st rollout. It is hoped to get more on board for future rollouts.

This is an initiative been piloted by Laois Co.Co., Offaly Co.Co., LOETB and ATU Donegal.

(b) STEM in Primary and Secondary Schools.

Midland ICT skills has been set up within the Midland region of County Councils through the BBO's – Laois , Offaly , Longford and Westmeath in association with Ericsson Athlone. (It is hoped to get other stakeholders involved in the future).

The proposal is to engage with schools primary and secondary schools to introduce and rollout STEM projects.

Ericsson have built training programmes to suit both primary and secondary schools to train teachers and students in topics such as Scratch, Microbit and Building Websites which will be rollout to 6 schools here in Laois initially before the end of this school year. It will be further rolled out in September '23 to more schools.

Consultations ongoing at present re the following:

- CEF 2 Traffic Corridors and Smart Communities Project.
- Engaging with PPN re programmes / courses that could be facilitated in our BCP's.
- Providing WIFI4EU in Rathdowney.
- IoT and Smart Projects.

Digital Strategy Review

Digital Strategy is under review with a programme of proposals to be outlined for 2023.

All the above pillars 1 – 5 are included in the LDS.

The BSU is working with the Marketing Sub-committee of the Portlaoise Town Team on a new project called "Bringing Portlaoise Online" which involves engaging with a social media company to market Portlaoise as a place to visit. Funding for this project is being provided by Laois Partnership and Laois County Council.

The BSU is working with Laois Taste on a series of initiatives for 2023. A new coordinator has been appointed to the group and this position is being funded by Laois Partnership and Laois County Council. An application for funding has been submitted to the Department of Agriculture to support the work of the new co-ordinator and Laois Taste's participation at various events this year.

Portlaoise Innovation Centre DAC (The Cube)

The new Manager is expected to be in place on the 27th March 2023. The official opening of the building will take place on Thursday 30th March at 5.00pm.

In 2022, Certificate of Authorisation Applications were submitted to the EPA for Aghnure, Killabban and Rathdowney Road, Durrow Landfills. Previous Certificate of Authorisation applications were submitted for Trumera, Wynne Park and Oughaval Landfills. No decisions have yet been made on these applications by the EPA.

5. GAP Regulations - Farm Inspections

The purpose of the farm inspections is to improve the water quality in the "atrisk" river catchments identified as catchments under pressure from agricultural activities.

- 2022 Approximately 50 Farms have been visited to date and farms ranked as high, medium low risk, as appropriate. Where necessary, advice letters have issued.
- 2023 Farm surveys to continue targeting more than 100 farms.

In 2023 (to date) Laois County Fire & Rescue Service attended 25 emergency incidents consisting of 6 fires, 17 special service incidents & 2 false alarms.

New Fire Station in Stradbally

Following approval of Part 8 proposals in February 2022, for a new Fire Station in Stradbally, Laois County Council has recently received 'approval in principle for the construction of a new Fire Station at Stradbally.' Laois County Council has now prepared a design brief for the project with a view to the appointment of a design team to oversee the detailed design, tendering and delivery of the new Fire Station. This brief was sent to the NDFEM in December & approval to appoint the design team is now awaited.

Mountmellick Fire Station upgrade

Approval to go to tender for the upgrade has been sought from the NDFEM.

WATER SERVICES AND RURAL WATER

Uisce Éireann

The Department for Housing, Local Government and Heritage, published the Framework for the Future Delivery of Water Services in June 2022 and it sets out the next phase in the transformation of the water sector in Ireland. Irish Water become Uisce Éireann from January 2023 and will assume full responsibility for the delivery of all public water services in Ireland on a phased basis during the coming year.

Portlaoise Water Supply Improvement Scheme – Following submissions from Laois County Council, Irish Water is progressing the introduction of Borewells PW07 and PW08 at Coolbanagher. IW/NOD currently agreeing design with the ESB. This intervention will provide for increased supply to the network, enhanced resilience for periods of drought and enable a planned maintenance programme for all Borewells to be introduced, funding is available from Irish Water under Capital Maintenance.

Disinfection/PH control programme – Civil works progressing in Meelick, Derryguile, Kyle, Five Wells, Derrymoyle and Lough WTPs. MEICA works progressed at the Strand, Knocks, Derryguile, Lough, Kyle, Five Wells, Clonin Hill, Derrymoyle, Ballyroan and Meelick WTP. Process proving now complete at the Knocks, Kyle and Ballyroan WTPs.

ESB supply upgrade currently being progressed for Five Wells. Power switchover at Lough WTP now complete. Design for Kilminchy WTP and Fermoyle WTP currently being progressed by CWL/IW.

Irish Water Small Towns & Villages Growth Programme

Under this Programme Irish Water have allocated €2.249m for the improvement and increase in treatment capacity at three waste water treatment plants in Laois. These are Ballyroan, Ballinakill and Borris In Ossory. Ballyroan is the most advance of these with Irish Water currently considering the options and pricing report for this site. Ballinakill and Borris In Ossory are at design stage.

Lead Mitigation Strategy – Derryguile WTP has been identified as a priority plant under the IW Lead Mitigation Strategy for addition of Orthophosphate Treatment.

Inlet Works Storm and Sludge Programme – Castletown WwTP - New Storm Tank installation is complete. Training for LCC operational staff now complete. Snagging list has been issued by IW to EPS.

Ballyroan WwTP Upgrade – A laser scan survey of the plant and an asbestos survey are being progressed/carried out. Catchment questionnaire completed by LCC for IW. Works now expected to progress in 2023.

Filter Upgrade Programme – Kilminchy WTP put forward for upgrades, confirmation of scope required post filter assessment report.

Networks and Water Conservation - First fix, find and fix and lead replacement work continued throughout the county in 2022 and will continue into 2023. Significant progress was made in leakage management in Portarlington following back yard service works in St. Michael's Park.

Replacement of watermain on the Swan network is now complete.

Mains rehabilitation works were also carried out in Abbeyleix and Stradbally in 2022, which will provide a safer, more secure water supply by minimising the frequency of bursts and improving the resilience of the network.

National WWPS programme – Bob's Bar Pump Station has been issued by Irish Water to Ward & Burke Construction / Tobin Consulting Engineers for detailed design. Survey works recently completed on site by Tobin's to finalise design.

Taking in Charge

Continue working with IW to take the outstanding legacy estates in charge by IW - already taken in charge by LCC. 10 no. estates have been progressed and referred to the Planning Section and work is ongoing on the remaining 7 no. estates.

Irish Water confirmed that The Rock GWS was taken in charge by them on 7th of December 2022 and work is progressing on transitioning of Moyadd GWS to Irish Water and this scheme will be taken in charge in 2023.

Multi Annual Rural Water Programme.

Projects under the current programme, 2019 - 2021, are being completed and claims paid and recouped. The Department has advised that details of the next Rural Water Programme will be issued in due course.

Water conservation and network upgrade works were completed on a no. of schemes in 2022. Grants totaling €107,130 were paid to Ballacolla GWS, the Heath GWS and Barrowhouse GWSS in respect of these upgrade works.

Application and Feasibility Studies for Vicarstown and Cullohill were submitted to the Department on the 15th of September for funding under Measure, A8 (Waste Water Collection and Treatment Needs for Villages and Settlements without access to Public Waste Water Services). These applications are being reviewed and adjudicated upon by the Department.

Well Grants – There were 65 applications received for grant aid assistance to improve private water supplies to domestic households in 2022 and the sum of €139,944 was paid out to 39 applicants in respect of well grants. The remaining grant applications will be processed in 2023.

Domestic Lead Remediation Grant Scheme



The Domestic Lead Remediation Grant Scheme has been in existence since 2016 and the Department of Housing, Local Government and Heritage have revised the eligibility criteria with effect from 1 December 2022. The grant is no longer means tested and is available for both public and private water supplies. This grant provides 100% financial assistance (max of €5,000) to eligible applicants to replace lead piping and fittings in a house, that is occupied as the applicant's normal place of residence. Applications can be made through the local authority.

CORPORATE, COMMUNITY, CLIMATE ACTION, ARTS, CULTURE, LIBRARIES & TOURISM

CORPORATE

A Civic Reception in honour of Mr. Teddy Fennelly in recognition of being named Irelands 2022 Heritage Hero by the Heritage Council will be held on Thursday 23rd February 2023.

COMMUNITY

Laois PPN

Laois PPN will host the Midlands Regional PPN (MRPPN) meeting on the 23rd March. The MRPPN meeting will see delegates representing Offaly, Kildare, Westmeath, Longford, and Meath welcomed to Laois. The event will take place in Castle Durrow. The MRPPN meeting is an important opportunity to share knowledge and ideas that benefit all members of the MRPPN.

Laois Comhairle na nÓg

Laois Comhairle na nOg continue to meet on a biweekly basis. The Comhairle are working through their Topic this year of Discrimination and are currently devising a plan to impact young people.

World of Work

This programme has commenced with 2nd year students in Portlaoise College. In February, an introduction to the functions of Laois County Council was delivered, including an information session about climate change.

Community Recognition Fund

A Community Recognition Fund was recently announced by the Department of Rural and Community Development. The fund aims to support the development of

community infrastructure and facilities in recognition of the contribution being made by communities across the country in welcoming and hosting significant numbers of arrivals from Ukraine and other countries. It is specifically targeted at projects that are located in communities, towns and villages that are hosting the Beneficiaries of Temporary Protection and/or International Protection Applicants ('new arrivals').

Laois received an allocation of €1,014,607

Projects to be funded must be:

- Capital in nature. Operational or running costs will not be funded.
- > Deliver tangible benefits for the communities in which they are located. The type of projects eligible for funding are:
 - development, enhancement or refurbishment of community or cultural facilities including play areas, walkways, parks, community/sensory gardens including communication boards, allotments, and recreational areas;
 - development, enhancement or refurbishment of local club and sports facilities including facilities such as community swimming pools, changing rooms, toilets, digital aids such as score / information boards etc.
 - enhancement to school/parish facilities which are open to use by all of the community after school hours

A well attended information session was held in the Dunamaise Arts Centre on the 9th

February for interested community groups. The closing date for submission of

Expressions of Interest is Friday 24th February 2023.

Age Friendly Programme

The new Age friendly Strategy 2023-2027 is being reviewed and will be open for consultation in the coming weeks. It will then be brought to the Age Friendly alliance for final approval. A formal launch will then be held and a new Older Persons Council executive formed.

Planning is ongoing for the Age Friendly & Healthy Laois Expo, which is scheduled for the 13th April, from 4-8pm in Portlaoise College. This will be an information event for many different demographic groups, with 40 exhibitors confirmed so far.

Operation Transformation

The Final Ad Break Challenge was filmed in Timahoe on 10th February 2023 and was the culmination of seven weeks of filming, which commenced on 27th December 2022 in Stradbally. The Operation Transformation host Mr Karl Henry, confirmed that the attendances in Stradbally, Vicarstown, Portlaoise, Kilcavan, Portarlington, Ratheniska and Timahoe were the highest on record. The large turnout representing local Clubs and Groups for each Ad Break Challenge showcased the fantastic community spirit in Laois.

ARTS & CULTURE

St.Colman's NS Exhibition at Laois Arthouse Stradbally

A wonderful exhibition of artworks titled 'We Are Artists' was presented by Junior and Senior infant students in St Colman's NS from Wednesday 8th February to Friday 10th February at Laois Arthouse, Stradbally. Through the Arts-in-Education BLAST Residency Programme, the pupils got the opportunity to work with local professional artist Orla McDonagh. The pupils created beautiful creations inspired by their woodland walk at Cosby Estate.

The official opening of the exhibition took place on Thursday 9th February with Cathaoirleach of Laois County Council Cllr. Thomasina Connell opening the exhibition.



Arts Awards and Opportunities

Following advertisement and promotion, applications have been received for 2023 Arts Act Grants, the Tyrone Guthrie Centre Bursary, Artists in Schools Scheme, Laois Culture Night 2023. Closing date for receipt of applications was Friday 17th February 2023. Adjudication process to be carried out in the coming weeks.

Creative Ireland Laois Events

'Activations' is part of Laois's Creativity in Older Age Programme supported by Creative Ireland in partnership with Laois County Council Arts Office. An 'Activations' workshop on Digital Skills Development and networking Session for Laois Artists aged 55+ will take place on Thursday 23rd February at Dunamaise Arts Centre.

Business of the Local Community Development Committee

The Local Community Development Committee (LCDC) comprises of 17 representatives from both the public and private sectors and has primary responsibility for coordinating, planning and overseeing Local and Community Development in the County, and disburses significant funding in pursuit of these development objectives.

The LCDC oversees the implementation of:

- Community objectives in the Local Economic & Community Plan(LECP) 2016 - 2021
- Social Inclusion and Community Activation Programme (SICAP) 2018-2023
- Implementation of the Laois Local Development Strategy operated under the LEADER Programme 2014 - 2020 in partnership between the County Council (financial partner) and local development company, Laois Partnership (implementing partner).

- Implementation of the Department of Rural & Community
 Development (DRCD) Community
 Facilities/Enhancement/Supports Programme since 2017
- Healthy Ireland/ Healthy Laois Plan

Local Economic and Community Plan (LECP). This was compiled agreement with a number of public sector stakeholders, under both community and economic development headings. It was adopted by Laois County Council in March 2016, and sets out the strategic framework for economic and community development resource allocation, and informs other planning processes over the course of the 5 year plan.

The new LECP 2023- 2028 is currently being development with 10 draft High Level Goal established which will go out for public consultation in March 2023. The high level goal consultation document has been developed in conjunction with a Socio Economic Statement and detailed mapping.



The SICAP Programme provides funding to tackle poverty and social exclusion at local level through local engagement and partnerships between disadvantaged individuals, community organisations and public sector agencies. Laois Partnership Company are the LCDC's implementing partner for the programme, and the annual spend for 2023 is in the amount of ϵ 849,393. This amount includes an allocation of ϵ 133,687 that focuses on Ukrainian supports under both Goal 1 and Goal 2 of the programme.



LEADER Programme 2014 - 2020

The LEADER Programme 2014 – 2020 enabled rural communities and partners to actively engage and direct the local development of their area. Laois County Council are the financial partner for governance of the programme.

The LCDC acts as the Local Action Group (LAG) for the County and holds the contract for the LEADER programme in Laois. Almost €8m of LEADER funding has been invested in innovative community and private enterprise projects throughout rural Laois over the duration of the programme. The LCDC has responsibility for the delivery of the Programme and works with the Implementing Partner (IP) which has been Laois Partnership Company. Animation is undertaken on a continuous basis by the IP through attendance at community meetings, business briefings and contributions to other events such as Teagasc Options Programmes and the LEO Start Your Own Business Training Programmes. This animation process energises interested parties to make applications for funding and those projects which successfully come through this process are brought to LAG, for funding approval. 134 separate projects have been approved to date by the LCDC in its capacity as the LAG under the programme.

Transitional LEADER Programme

The Transitional LEADER Programme came into effect on 1st April 2021 to bridge the gap between the 2014-2020 LEADER Programme and the start of the next EU programme in 2023. A key focal point of the Transitional LEADER Programme was on building capacity within communities which have not received LEADER funding to date.

With a project budget allocation of €1,095,976, 47 projects have been approved by the LCDC in its capacity as the LAG to date under this Transitional Programme.

EURI Fund

The European Union Recovery Instrument (EURI) is a fund established by the European Union to support recovery in the aftermath of the Covid-19 pandemic. With a project allocation of €485,767 a total of 13 projects have been approved to date under this funding stream

Examples of LEADER Funded Projects

Cullohill Community Plan

The Laois Local Development Strategy identified Cullohill as one of six areas to be targeted with public funding programmes and an area for development.

Cullohill Community Council responded to a LEADER funding call and applied to develop a five-year Community Plan for the area. This would establish a shared vision for the future of the village and assess development potential aligned with wider local and national policy objectives.

Developing a community plan for Cullohill involved a number of stages including research, profiling, consultation and monitoring. Consultants were appointed to coordinate and manage each step and write the final community plan report. Initial work involved a focus around strategic themes, objectives and actions such as developing infrastructure, enterprise, tourism and community facilities. Where actions required funding, potential sources were identified in the plan. Notably, many of the actions identified, rather than requiring significant financial support, primarily rely on community resources such as time, organisation and coordination skills.

The process of preparing this plan also required analysis and reflection on the strengths, issues and opportunities in Cullohill's future development at the community level. The community engaged very strongly with the planning process and a number of strong outcomes emerged:

- Fundraising drive delivered to accumulate a community fund.
- A community managed and coordinated 'education hub' was established providing extra weekend tuition to small groups and hosted in the community centre.
- LEADER funding secured to deliver ca €300K refit of the local multi-use community centre
- LEADER funding secured to develop the Folly Music Festival in collaboration with organisers of the Electric Picnic. This festival is the first gender balanced festival in Ireland, staging equal numbers of male and female performers.



Ballykilcavan Brewing Company

Another LEADER funded success story is that of Ballykilcavan Brewing Company, based at Ballykilcavan farm near Stradbally, Co. Laois, the home of the Walsh family since 1639. David and Lisa Walsh Kemmis have set up a new craft brewery in a 230 year old courtyard on the farm.

LEADER Funding in the form of a grant of just under €50K was sought to help purchase brewing equipment an essential element of the project. The overall cost of the project totalled €350K. The objective of the project was to create an on-farm craft brewery

that sources 100% of the grain used from the farm where the beers are brewed. The brewery based in an existing courtyard is the centre piece of a wider tourist project that is being developed around it. The brewery released a range of craft ales designed to showcase the qualities of Irish Malting barley. A number of guided walks have also been held on the farm which have allowed the farm to be enjoyed by the local community.

Two full time jobs have been created by the company; a head brewer and a salesperson, in addition to the CEO and co-founder David Walsh-Kemmis working fulltime, as well as season jobs.

Community Enhancement Programme (CEP) 2017-todate

This additional scheme funded by DRCD through the LCDC presents a favourable alternative for promoters of small scale projects who may be discouraged by the more rigorous and bureaucratic process which applies to the LEADER funding programme.

Since 2017 Laois LCDC has approved funding in excess of €640K in respect of approx. 344 applicant groups, supporting a myriad of local small-scale projects and initiatives countywide. This funding opportunity for 2022 under the Community Support fund has been advertised with Laois receiving an allocation of €291,487.

A sample of some of the grants paid out are:

Rathdowney Men's Shed received €1,501.00 towards the cost of the refurbishment of their kitchen area.

Castlecuffe National School received €1,000 for a playtower with swingset and buddy bench. This is proving a very beneficial activity and imaginative play area for children in the school. It facilitates the development of gross motor skills and the buddy bench ensures that no child will feel lonely in the playground.

Healthy Ireland – The Healthy Ireland fund was created by the Department of Health to establish and support the implementation of Healthy Ireland programmes and project which would improve the health and wellbeing of Ireland over the coming generation.

This funding is distributed through Laois LCDC to our Action Partners who implement a range of programmes, targeted at different groups throughout County Laois. All actions undertaken under the Healthy Ireland programme are guided by the Healthy Laois Plan 2018-2020. In excess of €400k has been approved by the Department of Health for Laois based initiatives since 2017. Programmes have been designed to help address and respond to local community health and well-being needs throughout the county and are targeted at all age and socio economic groups. Laois County Council's Community Section provides financial oversight and management in the delivery of the Healthy Ireland fund on behalf of Laois LCDC.

Upcoming LEADER programme 2023-2027

The Department of Rural and Community Development invited applications late last year for organisations interested in becoming the "Local Action Group" for the next round of LEADER funding.

Laois LCDC applied to continue to be the Local Action Group for Laois.

Separately, Laois Partnership submitted their own application to be the Local Action Group. On the 26th January this year the Department announced that both groups has passed the first stage of the selection process, which now requires the development of a Local Development Strategy (LDS) for the County by each applicant. The national guidelines for the development of the LDS have recently been issued.

LIBRARY SERVICES
